Woman's Heroism Saves Passengers

SHATVILLE, Wash., Aug. 6 (UPI)—Five passengers and a pilot of an Alaska-Washington airway plane on an excursion trip from Victoria to Seattle were saved late Monday through the heroism of Miss Anna Louise Williams, a nearby United States coast guard boat operator, whose boat caught fire and was forced down.

While flying over Point No Point, the engine began smoking and Williams brought his plane down to ascertain the trouble. When he hit the floorboards, a flock of smoke and flame shot into the plane.

He informed the passengers the plane was on fire and ordered them onto the pontoons.

Miss Williams, Williams, who was getting a swim ashore, on the way she sighted a fisherman in a skiff and made for the boat. The fisherman pulled her aboard and she took the oars and rowed to the plane.

The smoke and flames of the passengers had attracted other fishermen and a United States revenue cutter, the U.S. cutter "Kittiwake," soon everyone but Williams, who had stayed with the ship. Miss Williams persuaded Williams to get aboard the rowboat.


