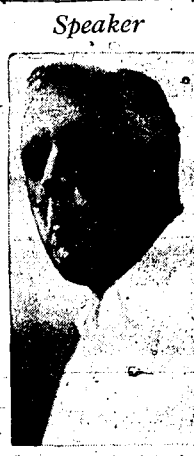

3 NEW RECORDS WILL BE SET IN YEAR'S BUDGET

Largest Collection Since War; Biggest National Debt Recorded

WASHINGTON, June 28 (AP)—Treasury statistics indicated today that the federal government's 1937 fiscal year will close Wednesday with income and outgo higher than last April's revised budget estimates and with a deficit slightly more than anticipated.

It also became apparent that at least three new records will be established in government fiscal operations under the New Deal. They were:

1. The lowest deficit since the Roosevelt administration went into office.

2. The highest national debt in history.

3. The largest revenue collection for any fiscal year since the World War.

The deficit appeared the most uncertain "quantity" in the fiscal situation. Its size depends on a treasury decision to raise approximately \$300,000,000 of the outstanding public debt.

If the treasury decides to postpone this operation until next year, the deficit will be in the neighborhood of \$2,850,000,000.

If the retirement is carried out, the deficit would amount to approximately \$3,100,000,000. In his revised budget, President Roosevelt estimated the deficit would amount to \$2,557,000,000 without taking into account \$402,000,000 budgeted earlier for debt retirement.

The national debt stood at \$36,892,849,647 on June 24.

Some slight reduction was anticipated in the debt within the next few days and it was believed that the nation's indebtedness at the year end will approximate \$30,300,000,000.

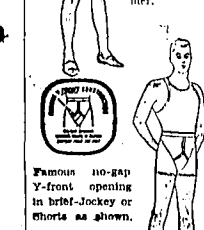

2 KILLED IN AIR CRASH AT NAMPA

Plane Shipped to Boise For Disposal Following Fatal Saturday Accident

NAMPA, Idaho, June 28 (AP)—Remains of the airplane in which Joe Mutchler, 35, pilot, and Kenneth Dunn, 17, passenger, lost their lives Saturday was being shipped to Boise today, probably for disposal at the municipal airport there.

Testimony indicated that the Aerona monoplane had stalled when it climbed to an altitude of approximately 170 feet, came into a spin, and crashed.

A coroner's jury, sitting at Nampa Sunday, refused to fix blame for the crash, reporting merely that the two had lost their lives in an "airplane crash."

Friends of Mutchler said he had not a student's license, and had no transport license as previously reported. A student's license does not permit carrying passengers.

Mutchler's body was shipped to Butchlers, Mont., today, where interment will be. His bride of one year, Alice, will accompany the body.

Dunn's funeral was held today at two p. m. in Nampa, where a quarter of a mile east of the Nampa airport runway.

NEW YORK CITY, June 28 (AP)—The Idaho Scout contingent (The Jamboree Troop)—We were an hour late going inland Tuesday because a train ahead of us had a wreck, causing a delay of about an hour.

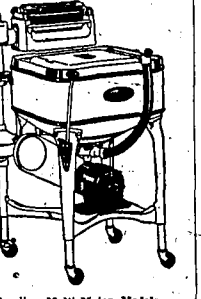

Value of Democratic Split

The deserving Democrats who gather with President Roosevelt on Jefferson Island, in Chesapeake bay, at the end of this month seem fated to do a lot of very pleasant eating; but whether they will sew up the growing rift in the Democratic party, or, indeed, whether it is actually to the best interests of the party and the country that they should do so—is quite another question.

This serial get-together is commonly spoken of as a love feast, despite the fact that precious little love is involved. Since the last election the party has been splitting wide open. This three-installment feast is supposed to get it back together again.

Now every President runs into a certain amount of party dissension in his second term. This is inevitable from the nature of politics. He is on his way out, even though the date when he steps down is a long way off. The party leaders in congress have their own futures to look after. Naturally, they begin to pull away from the presidential leading strings.

But what Mr. Roosevelt and his party leaders are up against is something quite different. It is no mere second-term restlessness, that is dividing the party; it is a deep and fundamental difference of opinion over principles of the most vital importance.

Mr. Roosevelt is trying to lead his party in a direction which, whatever you may care to say about historic traditions, Thomas Jefferson, Andrew Jackson and so on, is at least quite different from the direction it has been following in the last few decades.

A good many responsible party leaders do not believe that it ought to go in that direction, and have parted company with him—most notably, on the matter of revision of the Supreme court.

Should a breach like that be healed, in the best interests of all concerned? Might we not have a more healthy and responsive political setup in this country if the breach widened, instead of narrowing? Ought not a political party, in other words, to stand for a clearly-defined set of principles to which all members of the party can give unqualified adherence?

A realignment of political parties has been long overdue. For many years the difference between the two parties, as parties, has been less noticeable than the difference between the two wings within the parties. The sooner the realignment takes place, and is formally accepted by a widespread shifting of party labels, the better off we shall be.

And so, while it is to be hoped that the Democrats feast well and enjoy themselves, it is quite possible that both the feasters and the country they serve will be in better shape if the expected reconciliation does not take place.

Be Wise—And Live

Independence Day is not far off, and the problem of a safe and sane Fourth is once more up for consideration. But nowadays it is the adult, rather than the child, who needs protection and restraint; for the holiday automobile traffic is getting to be a worse menace than the cannon cracker ever was.

The newspapers of July 5 will most certainly publish a long list of Fourth of July casualties. A distressing number of them will be due to fireworks, in spite of years of safety campaigning; but a large number will be due to automobiles—and will be due, also, to carelessness on the part of people who are old enough to know better.

The roads will be crowded on July 4. If you are going out in your car, take a little extra precaution—and keep your name out of the next day's newspapers.

Good Place to Relax

There must be advantages to life in a backward and isolated community. You might miss some of the conveniences of this modern world, but you would also miss a lot of grief.

Consider, for instance, the Guatemalan village of Agua Escondida, recently visited by Dr. Robert Redfield, dean of the division of social sciences of the University of Chicago. Dr. Redfield says that the villagers of Agua Escondida know nothing of the world's news; they have never even heard of the D.D.T. quintuplets, Col. Charles A. Lindbergh, or the romance and marriage of Wallis Warfield and the Duke of Windsor.

It must follow, logically, that they know nothing of modern strikes, an unbalanced budget, the Supreme court revision plan or the civil war in Spain.

How peaceful and uncomplicated life in Agua Escondida must be!

Simply because of his overweight, exertion will cause shortness of breath and the heart will feel as if it will have to pump the extra weight. It is definitely established that a person with heart disease does not do well if he gains too much weight and that a person with a disturbance of the heart, the arteries of any of the other vital organs of the body has another hazard in the overweight.

Overweight is a distinct hazard to a person with a tendency to diabetes and a menace to the life of any one with high blood pressure or high blood pressure.

Some Scotch investigators have emphasized particularly the fact that four out of five cases of heart disease are associated with disturbance of circulation of the blood, and that this disturbance is due to the disturbance of the ability of the person to get about.

The association of overweight with heart disease is so definite that there has come to be a "rough" among the medical profession which asserts that the typical case of heart disease is a woman who is fat, fat and fat.

Germany Plans for Direct Action in Any Future Spanish Crisis

NAZIS ADMIT TO WISH FOR REBEL VICTORY IN WAR

Search for Colonies Will Be Continued, World Congress At Berlin Told

By FREDERICK C. OEBISNER
BERLIN, June 28 (UP)—Nazi Germany opened a world congress of businessmen today with assertions that it will take direct action in any future Spanish war crisis, that it wants a national victory in Spain, and that it will continue searching for colonial territories until it gets them.

The occasion was the fifth congress of the International chamber of commerce, said to be the greatest gathering of world business leaders ever assembled—1,500 delegates from 40 nations in addition to hundreds of specially invited guests.

To Continue Search
Gen. Hermann Goering, air minister, economic dictator and right hand man of Fuehrer Adolf Hitler, in his speech of welcome at the opening of the congress, said bluntly:

"You may be sure Germany will continue to bring up the colonial problem until its urgent and legislative desires as regards colonies are fulfilled."

Goering made a bid, too, for a system of trade treaties that would transcend political considerations and defeat such moves as the League of Nations effort to penalize Italy for its war on Ethiopia.

To Take Own Hand
But the real keynote, insofar as it concerned German world policy, was sounded by Hitler in a speech at a Nazi party convention at Weisberg yesterday.

Denouncing alike an alleged Spanish loyalist attack on the German cruiser Leipzig and British-French refusal to join in a naval demonstration in protest, Hitler said:

"From now on we shall prefer in such cases to take into our own hands the safeguarding of the nation's freedom, independence, honor and security, and to protect ourselves."

"Thank God we today are strong enough to protect ourselves."

"From this incident we have drawn conclusions which will be effective for all the future. Speeches in parliaments or talk of statesmen in the future will not befuddle us."

CALDWELL, O., June 28 (UP)—A mystery growing out of the navy dirigible Shenandoah disaster near Ava, O., on Sept. 3, 1925, was solved here when Mrs. Faye Larrierson plucked from the stake of a mustard weed in her garden the missing Annapolis naval academy class ring of Commander Zachary Lansdowne, one of the 14 who died in the crash.
Agents of the department of justice had attempted to find the highly prized ring of Commander Lansdowne. The government had spent much money in the search for it, offering lucrative rewards for its return.

Charge Robbed
Secret service men had charged that Commander Lansdowne's body had been robbed. Commander Jacob Klein, assigned to investigate the dirigible crash, directed his assistants to run down every clue concerning the ring.
The ring was found within two yards of a monument in memory of those who died in America's first major airship tragedy.
