**Alben Barkley Named as Majority Leader in Senate**

**KENTUCKY SOLON BEATS HARRISON BY SINGLE VOTE**

**New Bourbon Head One of Enthusiastic Backers of President's Program**

WASHINGTON, July 21 (UP)—Senate Democrats by a vote of 38 to 37 today chose Sen. Alben W. Barkley of Kentucky, to be their new majority leader, charged with disposing of President Roosevelt's battered judiciary program and attempting to restore party harmony.

Barkley, who defeated Sen. Pat Harrison of Mississippi, had generally been regarded as the candidate of the administration and one of the most enthusiastic supporters of the court bill. The White House, however, emphasized its neutrality.

Win Back Ground  
As a result of the election, supporters of the judiciary program appeared to have won back some of the ground lost in a series of blows during the last few days.

Selection of Barkley left the future of the measure and the question of adjournment of the Senate as demanded by opponents of the court bill, uncertain.

The one vote margin by which Barkley was selected emphasized the closeness of the division of senate Democrats. The vote of each of the 78 Democratic senators was recorded, including that of Sen. John H. Bankhead of Alabama who voted by proxy from his home in Jasper, Ala.

Election Made Unanimous  
The outcome of the leadership election was disclosed after a 45-minute session which ended as a burst of handclapping in the caucus room.

Harrison moved to make the election unanimous. The motion was adopted.

Barkley, smiling broadly, said: "My party is representative of the administration as well as of the senate in working out to the best of my ability the problems that face the congress and the country."

**COURT MEASURE SUPPORT FAILS**

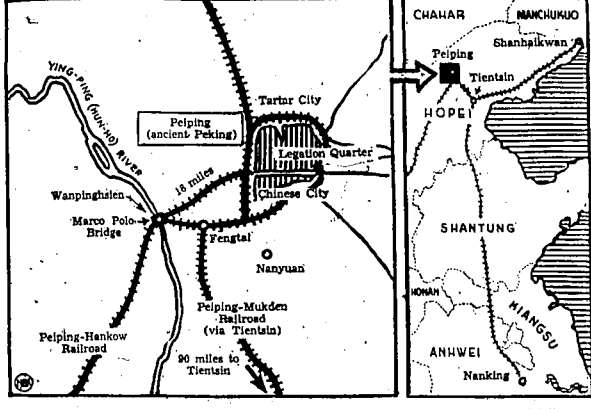

**Il Duce Plans to Send Rebels Aid, Paper Says**

**Nazis, Italy Join in Pact, French Claim**

PARIS, July 21 (UP)—French newspapers reported today that Premier Benito Mussolini of Italy had sponsored a plan to send 15 divisions of soldiers—perhaps 75,000 men—to aid the Spanish nationalists in the Civil War.

Under the plan, it was reported, Mussolini proposed to furnish Adolf Hitler of Germany with 15 divisions of British non-intervention proposals to London.

Hitler, in response, was asserted to have informed Mussolini that he did not wish to engage himself definitely as regards Spanish policy until he knew the result of the discussion of British non-intervention proposals to London.

Needed 125,000 Men  
The newspaper Centre, organ of the radical Socialist party which is the dominant element in the French popular front government, asserted that after the fall of Bilbao Gen. Francisco Franco, nationalist dictator, informed Mussolini that he needed 125,000 men to win the civil war.

**British Leaders Stay in England**

**Ohamborlin Asks Cabinet Members to Be on Hand in Case of Trouble**

**LONDON, July 21 (UP)—**Prime Minister Neville Chamberlain has asked all cabinet ministers to remain in Great Britain throughout the vacation season because of the danger of the international situation, it was understood today.

Chamberlain, it was understood, wants every cabinet member to be where he can reach London within a few hours for a possible emergency meeting. Parliament adjourns July 30 until the end of October.

It was understood that Foreign Secretary Anthony Eden would remain in the south of England where he could remain in closest touch with the foreign office. Chamberlain's request came as it appeared that the Spanish non-intervention committee was dangerously near collapse.

**CHINESE WARNED BY LOW FLYING NIPPON PLANES**

**Japanese War Craft Drift Over Peiping at Bare 500-Foot Altitude**

**SOLDIERS SEIZE WHARF**

**Firing in Wunpingshien Area Ends as Punitive Bombing Is Completed**

TIENTSIN, July 21 (UP)—Japanese war planes flew a bare 500 feet above Peiping today in warning that China must accept Japan's demands or face the consequences.

A second fleet of planes, flew southward along the Peiping-Hankow railroad and the highways, to report movements of any Chinese troops that the national government might send to aid the embattled 29th army whose clash with Japanese soldiers caused the present grave situation.

At Tangku, 25 miles down the river from Tientsin, Japanese soldiers seized the entire Chinese wharf area to accommodate four army transports due there today with the first of 35,000 soldiers being sent from the homeland ready for a war.

Ask Demand Approval  
Japanese army leaders at their headquarters here and at Peiping today demanded that Chinese authorities must accede to each of their demands or face a renewal of the "punitive" bombardment of which Wunpingshien and other areas westward of Peiping were subjected yesterday.

Firing in the Wunpingshien and other areas ended this morning. Despite the explosive nature of the situation, there were distinct signs that serious fighting was ended at present level.

For one, Chinese and Japanese authorities agreed in statements regarding negotiations and the United States was enabled to confirm reports that the 37th Chinese division, which is regarded by the Japanese as the most reliable to give them help, has begun moving from the Papanan neighborhood just before noon today.

Long Controversy  
A Chinese official at Peiping told the United Press that an agreement for withdrawal was reached into the city of Peiping, after the Chinese-Chuan-Yuan, chairman of the Hopei (Continued on Page 5, Column 3)

**CHIEF TESTIFIES AT NLRB HEARING**

**Maassillon, O. Police Head Says Republic Officers Offered Arms**

**WASHINGTON, July 21 (UP)—**Elmer W. Maassillon, chief of police at Maassillon, Ohio, testified before the national labor relations board today that an official of the Republic Steel Corp. offered him \$10,000 in return for help in any situation that might arise during the steel strike.

Maassillon, who was the first witness called as the board opened its inquiry into charges that Republic violated the Wagner labor act, said the arm and ammunition and arms offered for police use were owned by the corporation.

Charges against Republic were filed with the board by the committee for industrial organization.

STORE CLERKS RAP LONG HOURS OF NEIGHBORHOOD SHOPS

SMALL GROCERY PLACES TERMED "DEMORALIZING"

Meeting to Form Union Here Finds Establishments Are Hurting Conditions Neighborhood groceries, staying open late hours of the night, on Sundays and holidays, are doing much to demoralize labor working conditions in Twin Falls, a representative group of local clerks had decided today.

The opinion was expressed at a special "get acquainted" meeting held last night in the temporary union hall. It was the first meeting held prior to formation of a clerks' union here on Tuesday, Aug. 3.

Hurting themselves "Outlets here, staying open Sundays, holidays and also nights, are demoralizing the local grocery business and not only hurting down town stores but also hurting owners of neighborhood stores in that they and their clerks cannot enjoy a healthful life," said the state organizer for the American Federation of Labor said today.

This was the exact consensus of opinion among clerks from local stores who met at the hall last night. Freedom said, "The group, which included one store owner, also discussed the possibility of some action to be taken by the city council of Twin Falls to regulate the closing time of stores and also the days on which they can remain open by ordinance along the lines of that which creates business zones and prohibits stores from remaining open in certain sections.

Discussed Wagner bill "Clerks as well as store owners present, discussed terms of the Wagner relations bill which makes it unlawful for employers to intimidate or discharge any workers because he wants to become, or is affiliated with, a union.

Regular clerks meetings have been held for the first and third Tuesday of each month. It is possible that at the Aug. 3 meeting a contract will be elected as organization, pointing toward a charter, will get underway.

Organization of a clerks union has been discussed in terms of higher wages, shorter working hours and a closed shop. Freedom said today.

It is estimated approximately 200 persons in this city will be eligible to join.

# WORLD MOURNS DEATH OF FAMED INVENTOR MARCONI

## NATIONS' HEADS SEND MESSAGES OF CONDOLENCE

### Thousands File Past Bier of Italy's Most Famous Man in Academy at Rome

By FRANCIS BEA  
ROME, July 21 (AP)—Thousands of Italians, rich and poor, filed silently today past the bier of Guglielmo Marconi, who died in the night of the most amazing experiment of his amazing inventive career.

His body lay in state in the Galleria hall of the Royal academy of which he was president. His white-linen hands clasped a rosary against the medals of many lands emblazoned on his breast.

From statements, presidents, kings and scientists came thousands of messages of condolence.

At dusk today private funeral services were to be held in the little church of Santa Maria Deglie Angeli where Marconi often prayed. Premier Mussolini ordered a national funeral at Marconi's native Bologna where the body will be buried in the family vault at Pontecchio.

Body Lies in State  
His body will lie in state until 6 p. m. At that hour religious services in memory of Italy's most famous son will be held throughout Rome.

Premier Benito Mussolini and members of the cabinet are expected to march behind the gun carriage bearing Marconi's coffin from the academy to the church.

The body will be sent to Bologna tomorrow. The national funeral will be Friday.

The thousands who viewed the body included carabinieri in brilliant uniforms, academy officials in evening dress, peasants and city folk. Two nuns knelt in prayer beside the bier.

Many Decorations  
On Marconi's knee rested his academician's hat and by his side lay his gold chain and dagger. Six huge candles lit his serene features and gave luster to his grey hair.

So many were his decorations that many of them were pinned on red velvet cushions placed at the foot of the catafalque and strewn about the bier.

Newspapers all agreed that his loss was a great blow to Italy—and the world. The Catholic newspaper, *Avvenire* d'Italia declared that all the world's countless radio stations should be silent for one moment during the funeral services this afternoon.

One of Marconi's collaborators, the Marquis Luigi Bolaffi, revealed that experiments which death interrupted would have snatched new secrets from nature to improve television.

## Prospectors Find Gold Bars Reportedly Worth \$3,000,000

"Its purpose," said Chief Ballard, "is to offer up prayers to the Great Spirit on the rays of the sun. The morning ceremony takes place at sunrise every day of the dance. At that time all the dancers form two rows facing the rising sun and extend their arms, not worshipping the sun, but praying to the Great Spirit through the sun. Following the prayer, medicine men of the tribe lead the sick and ailing to the center pole where their sins are cured."

Absolute Quiet  
Indians that do not participate on the part of visitors while the dance is in progress. Cameras are barred. Very few pictures of the ceremony are in existence.

At the end of the dance, dawn, July 24, Indians take part in a feast of barbecued beef.

Week At The Capitol

BOISE, Idaho, July 21 (UP)—With Republican M. B. Yeaman at the wheel, the Idaho liquor control commission this week poked its nose into illicit grog shops in northern Idaho and gave the boys 48 hours to close up or face abatement proceedings.

In southern Idaho, the commission took a sharper bite, and ordered a proprietor of a rooming house near Emmett to alter in Ada county district court and show cause why his place should not be abated for selling liquor by the drink in violation of state law. It is expected that the place will be padlocked.

This particular liquor drive is the most violent ever undertaken by a liquor commission, not merely from the point of places closed, but from point of determination. Bolstered by evidence gathered by secret operatives, giving complete legal verification of charges, the county prosecutor, in an overlock, the commission announced it was bound to make Idaho as dry as state laws permit—the no-license age.

Election of Yeaman as liquor commission chairman was not expected, yet, when analyzed, it was seen to be a clever move. He being the only G.O.P. man of the group, his election was a lot of responsibility off the shoulders of the Democratic pack-mile, Yeaman, in turn, probably feels he has accepted somewhat of a challenge to do better than his predecessor, if he can.

Yeaman is a former newspaper publisher from Idaho Falls, and is entirely unacquainted with the minor political circle which has dominated and protected liquor law violation. He knows how to act, and probably will be more to shut up drinkeries than any other member of the commission.

At last, immediately following his election, he banged right into the hotbed of illicit drinking—northern Idaho. He told the gentlemen just what to do, and how long they had to do it. Biggest ribs which can be paid for in Idaho is that his suggestions were taken as face value and carried out.

On the other hand, from a member of the department of law enforcement came the commission that prohibition was not what was needed, but a more tempered with, legal administration. Control, it seems to this gentleman, does not necessarily mean padlocking every establishment in the state, but abatement of nuisances. There is no logic in his suggestion that the liquor commission, for the time being, seems to be illogically accomplishing what it had failed to do previously.

The commission is sending a man through Oregon to study that state's method of control. Oregon operates under the commission system, selling liquor at state operated stores, and has package wine stores where no liquor license is needed. The state does not tolerate cocktail lounges or bars, but does permit one to purchase a bottle of wine with one's meal and drink it at table in hotel or restaurant. Of course, the state is plagued with "protected" bars, especially in the City of Roses (Portland) but not to the extent Idaho has been hounded.

Troops at Fort Lewis will include those from Montana, Wyoming, Idaho, Oregon and Washington which compose the third division of the regular army, 41st division of the national guard, and several air squadrons. Those attending from Idaho national guard are the 11th engineers, from the southern part of the state, and the 14th field artillery stationed in western and northern Idaho, so the division headquarters troop of the 41st division which is at Blackfoot, Ida.

Hummel Heads Engineers Col. E. T. Powell, of Coeur d'Alene is commanding officer of the artillery and Col. F. C. Hummel, Boise, is commander of the engineers. Maj. Gen. White of the 8th division, Ore. is in command of the 41st division.

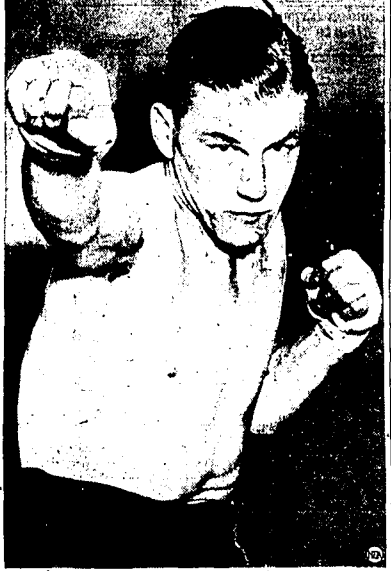

## State Board Outlines Strict Rules In Granting of Pardons

BOISE, Idaho, July 21 (UP)—Prisoners receiving conditional pardons will have to walk a narrower and straighter road as the result of new regulations laid down today by the state pardon board.

The board, convening today after a recess of 10 days, put sharper teeth in its rules after one prisoner, pardoned July 12, broke his promise and got into trouble.

The new rule, which will apply to all conditional pardons, is as follows:

"The pardon is granted on condition that the prisoner refrain from the use of intoxicating liquor and that he observe all laws of the state of Idaho and that he obtain employment and lead the life of an upright, law abiding citizen and that upon his failure to keep each and every term and condition of this pardon, he forfeits all his rights and shall be returned to the state penitentiary to serve his original sentence."

LIPPMAN LASHES GUILD IN LETTER

Famed Columnist Threatens to Quit Group if Political Views are Enforced

NEW YORK, July 21 (U.P.) - Walter Lippmann, New York Herald-Tribune political commentator, has made public a letter to the American Newspaper Guild in which he said he did "not recognize the right of any majority to determine the political views of the members of the guild."

Lippmann said he was prompted to make the letter public by a statement of Heywood Brown, Guild president, to the effect that the commissioner would "have an opportunity to vote in the referendum on controversial guild issues."

Lippmann also called attention to Brown's assertion that "the membership of the guild is supreme. His letter, dated yesterday, follows: 'I am returning this bill requesting the payment of dues for July 1937, and I beg to state that as long as the American Newspaper Guild stands committed to the political opinions adopted at the St. Louis convention, or to any other political opinions, I shall not pay any membership dues.'

"I am taking this action in advance of the referendum because, whatever the outcome, I would not recognize the right of any majority to determine the political views of the members of the guild."

"It is for you to determine whether this action disqualifies me. If it does, you may regard this as my letter of resignation."
