## CROOK MAKES HIS ESCAPE FROM JAIL

## J. W. Sanders Held for Forgery Knocks Out Jailer.

## Sack Weighted with Coal Used to Put Officer Graham Out of Commission. Sanders at Large.

Officer Graham while locking up his trapdoors for the night on Monday evening of this week was knocked down and rendered unconscious by J. W. Sanders, who had been on the charge of forgery, awaiting trial in the district court. The prisoner, after obtaining possession of Mr. Graham's revolver and although pursued made good his escape into the Rock Creek canyon.

Graham had already locked two of the prisoners into the cell and was preparing to put Sanders into the cell for the night when inadvertently he allowed Sanders to get hold of his revolver. It was just what the crook had been looking for some time, and he hit Graham a terrible blow just back of his right ear, with a sock loaded with a lump of coal, telling him and making him a bit dazed for a minute. Graham says he was still holding on to Sanders when his senses returned but was too weak from the blow to hold him and the prisoner got away carrying with him Graham's revolver, which he took from the jailor's coat pocket.

Deputy Sheriff Dyer heard the jail call for help and ran to ward the jail and to see a man run away from the jail toward the Snake hole. Dyer followed on his trail and managed to keep him in sight until the man ran down across the tracks and plunged into the mouth of Rock Creek canyon. The surrounding towns have been notified and mounted men have been sent out to catch the man if he seeks any of the towns off the railroad.

Sanders was wanted here for passing forged checks and was arrested at Rexberg and held for the Sheriff. On Deputy Dyer reaching that city he learned that Sanders had made his escape from the marshal, and was later apprehended at Bingham City, Utah, and brought to Twin Falls.

## LAND STILL ANOTHER RECRUIT

### Attraction of Twin Falls Makes George Baird a Booster.

George A. Baird of Chicago, president of the Honorable Mining and Milling company, was in Salt Lake for a few hours Thursday morning, enroute to his Eastern headquarters. After spending several pleasant weeks in Southern California, Enroute from the coast, Baird stopped over in Twin Falls, with whose progress to prosperity he has had a great deal to do. Regarding Twin Falls, he said:

"At Twin Falls you are going to see soon the greatest farming community in the west, the greatest diversified section in the world. The new agricultural district is growing remarkably, and all hope has been feasted by the appearance of the prairie there. Before 1902 we will have six thousand inhabitants in the city of Twin Falls, and within fifteen years the city will be the largest in Idaho."

"The community is growing rapidly, and the very best people of the land are coming there to settle. Last week a train load of visitors who numbered 200 came in and purchased lands and determined to locate there. While I was at Twin Falls four lots back of one of the large hotels sold for \$20,000 cash and a year or two ago you could have purchased them for \$1000 each. A year ago I thought some land I had there was selling pretty high at \$25 an acre, and I sold one tract. You could not buy it today for \$25 per acre, while land far beyond it that usually would be considered worthless is worth today something over \$300 an acre."

"The people are happy, progressive and progressive. Money is plentiful. There are three banks there now, and one of them during the past two weeks had its deposits increased by a round \$100,000. The city is building a \$60,000 school building; for the school facilities were hardly calculated at first to handle such demands as now are being made upon them. The children ride to school in large wagons, and they are taken home by the same means."

## POWER RIGHTS BELONG TO PEOPLE

### So Says Roosevelt in Special Message to Congress.

### Vigorous Executive Vetoed Bill Granting Special Privileges—Natural Wealth the Heritage of People.

upon a consistent and uniform plan by which each party should be made to help every other party. The income derived from this source would materially aid in the complete improvement of our navigable waters, for which there is now such existing need. The chief objection of the army experts that the bills now pending at this session of congress permit the construction of dams in navigable rivers capable of developing over 1,000,000 horse-power. These rivers run every hour in the day and in the night. To develop this amount of power would under average conditions require 25,000,000 tons of medium quality coal every year. This natural wealth is the heritage of the people. I see no reason for giving it away, though there is every reason for not imposing conditions so burdensome as to prevent the utilization of the power."

In a special message Monday vetoing a dam bill President Roosevelt warned congress that there are pending in this session bills which propose to give away without price strong rights capable of developing 1,300,000 horse-power, whose production would cost annually 25,000,000 tons of coal, urging in vigorous terms the establishment of a policy such as the Mississippi River navigation authority, the demands which would segment the granting of dam privileges and require the grants to pay for them, and definitely forbidding a future policy on this part with regard to prompt utilization of construction privileges by refusing his signature to a bill that gives an additional three years to the Idaho River Improvement company, which is to build a dam in the Idaho River, "if we do not believe," says the president, "that our natural resources should be granted and held in an undeveloped condition for speculation or other reasons. So far as I am aware there is no assurance that the grants in these cases in any better condition promptly and properly to utilize this opportunity than they were at the time of the original act granting the privilege ten years ago."

Discussing broadly the federal policy, the president says:

"Every permit to construct a dam on any navigable stream should specifically control the right of the government to fix a term for its duration and to impose such charge or charges as may be deemed necessary to protect the present and future interests of the United States connected with the act of June 2, 1906.

"The provisions for a charge of vital importance. The navigability of every waterway and of all connected or connectable inland water ways as a whole should be improved for the purpose of interstate and foreign commerce."

## ORIGIN OF EASTER.

The establishment of the Christian festival of Easter, typical of the resurrection of Christ, was a matter of much controversy in the Church for centuries; but it was finally determined by the Great Council of Ephesus. Thus far as we know, the first Sunday after the full moon, which happens upon or just after the 21st of March - the beginning of the ecclesiastical year, if the full moon happens upon a Sunday, Easter Day is the Sunday after.

The earliest date upon which Easter may occur is March 22. If the full moon should fall on March 21, Easter is the following Sunday, i.e., April 1 and Easter fell on April 1, but this did not occur during the present century.

The latest date upon which the festival may fall is April 23. In 1856 it fell on this date. It will do so again in 1915.

There is a belief common among country people that when Easter falls on an early date the sowing season will be corresponding early.

In ancient times, as winter was rapidly giving place to spring, and the earth was beginning to put on its garment of green, the people of Northern Europe observed a festival in honor of Easter, or Easter, a goddess by whose name they supposed the change from dark, grey winter to cheerful, sunny spring was brought about.

The festival held in commemoration of the Resurrection fell about the same time of the year as the festival of Ostara, or Easter, a goddess whose name they supposed the change from dark, grey winter to cheerful, sunny spring was brought about.

In the east the festival was known as the Paschal Festival, and the French called it Paques, both, of course, having reference to the Paschus. Probably from the various customs of eating "poule," "pastrie," or "paschal cake," as they are variously called in various districts. This is perhaps the most common custom nowadays associated with Easter in Scotland. Some few other customs still exist, but, as a rule, they are rapidly dying out, and are only to be found in out-of-the-way districts or particular locations where, from one reason or other, the people cling more tenaciously to old traditions.

In some districts "Easter Sunday" is duly recognized by the working classes, many of whom partake of hot one, but two or three eggs at breakfast that morning. Sometimes, indeed, this feast has been known to take the form of an eating contest. A reporter of this paper, an amateur sportsman, reported that morning was kept up by our Society, beginning the night before. The eating of boiled eggs, on Good Friday is not to be fully understood. It is, probably, a Puritan custom. On Good Friday, the morning after which is called with power, heat, and chaff, to be heated, chearing the well-known rhyme:

"One "Pase Sunday" a few weeks gathered at his home, and promised to provide him with a "free foot" if he would undertake to eat the last egg in a dozen duck eggs. To this proposal he agreed.
