### LEASES BUHL CREAMERY

Steering Company of This City Takes Over Buhl Concern.

A transaction of importance to the dairymen of the Buhl country was consummated on Saturday afternoon of last week when the Sterling Creamery Co. of Twin Falls, secured by lease for a period of one year, the plant, business and good will of the Buhl Creamery Milk Condensing Cheese Manufacturing company of this city. The consideration was highly satisfactory and most remunerative to the local concern, guaranteeing as it does a substantial market, paying a liberal con-

tribution for the business and being in effect for a period of only one year. At the meeting of the stockholders of the local creamery company held last Saturday afternoon for the purpose of considering the matter of leasing the business, representatives of two outside creameries were on hand with offers for lease. One, the Jensen company, through their agent, Mr. Niemi, offered the local company a royalty of one cent a pound for all butterfat purchased in the city, and were fully ready to sign up a year's lease or agreement to that effect, but when it came to taking over Mr. Niemi, the buttermaker, as local manager for three and a half months to fill the terms of the contract, he declined the Buhl creamery, they balked and

would go no further.

Mr. Young, representing the Sterling company of Twin Falls, agreed to all the specifications in the agreement considered with the Jensen people, and in addition agreed to take over Mr. Maple for local manager to fulfill the local company's contract. In short, the agreement as signed up between the Sterling company and the Buhl creamery, is that the former is to pay into the treasury of the latter one cent for each pound of butter fat purchased in this district; the local company is given the privilege of supervising all testing; the price of butterfat to be not less than three cents below the wholesale price of butterfat in Salt Lake, Boise, Pocatello and Twin Falls, and they agreed to take Mr. Maple for a period of one year, being his present contract with the Buhl company.—Buhl Herald.

### TROPY CUPS OFFERED.

St. Paul Land Show Will Give Special Prizes.

Growers of choice grains, grasses, fruits and other soil products in the American northwest will be rewarded for their trouble in furnishing samples to their states, sections or Commercial club exhibits at the St. Paul Land Show according to an announcement made by the Land Show management stating that fifty handsome sterling silver trophy cups, valued at \$4,000, have been offered by the St. Paul Association of Commerce and some enterprising business firms.

To secure one of these cups the Northwestern Land Show does not require the exhibitor to go to the trouble and expense which is usually necessary to win a prize. All the growers have to do is to furnish the sample to those in charge of the state exhibit of the Commercial club which has charge of the display of a particular section at the show to be held in St. Paul December 12 to 23.

These are some of the trophy cups offered at the St. Paul show by the Association of Commerce:

Cup for the best state exhibit, open to Minnesota, North and South Dakota, Montana, Idaho, Washington, Oregon, and Alaska.

Cup for the best sectional exhibit from American Northwest.

Cups for best half bushel Minnesota wheat's for best bushel of potatoes grown in Minnesota; for best ten ears of corn grown in Minnesota and the best bushel of oats grown in Minnesota.

For North Dakota cups are offered for the best bushel of wheat and best half bushel of flax.

In South Dakota the cups are for the best ten ears of corn.

Chas. W. Clark of Montana, has offered ten cups for various Montana products and the St. Paul Association of Commerce will give a cup for the best half bushel of oats grown in the Gallatin valley.

Cups are offered for the best bushel of apples grown in Washington, Idaho and for the best sample of alfalfa grown in either of these states.

In Idaho a cup is offered for the best ten ears of corn.

The Great Northern Railroad offers a cup to the person who furnishes the best samples for a state exhibit in each of the seven states, while the O'Donnell Shoe company of St. Paul offers a cup for the best bushel of winter wheat grown in the American Northwest.

Through Jno C. Kelly, Manager, of the Sioux City Tribune offers a handsome silver trophy cup for the best showing made from an acre of alfalfa in South Dakota.

"We saw, on checking over delinquent tax certificates issued at the date of 1908, that in June of this year 50 pieces of property were not redeemed from that delinquent tax sale, this property including valuable farms and city property. Among the owners of this property were a number of clients and friends of the writer. He knew that the failure to pay these taxes must in most instances be the result of oversight and forgetfulness.

"Passing the farm of one of these, worth probably \$12,000, he remembered the outstanding tax certificate, and stopped and told the owner, who promptly redeemed his land. The writer personally told others of their dangerous situation, and they, too, extricated themselves. It so happened that one of these tax title speculators owned several of these tax certificates so redeemed, and on inquiry learned who had told the owners of their situation, and complained to a friend of the writer that the writer was robbing him of his business.

"One owner was living in Eau Claire, Wis., and we did not learn his address until the evening of the last day upon which he could redeem, when we telegraphed him. He was at a summer resort, some distance away, but the telegram was forwarded, and he at once wired to a Twin Falls bank and redeemed his land. This is only one instance. We are glad to say that practically every piece of valuable property in the list was redeemed.

"If this notice were given by the county auditor, the occupants of the tax title speculation would be gone, except that he would get interest at 18 per cent per annum until redemption. We were glad to do so again, even if we do tread on the toes of the tax title speculator.

"This notice is given you that the law should be so amended that this trap could not so easily be sprung on the unsuspecting and innocent taxpayer. There surely should be notice to him—actual notice, when it can reasonably be given—and he be given a chance to redeem."—Statesman.

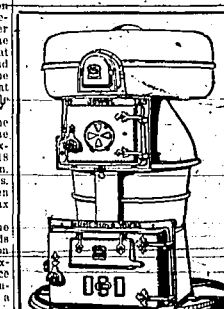

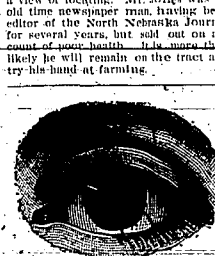

CORN A PROFITABLE CROP.

Farmers Find It One of the Best Paying Crops.

Idaho may never be a corn state, strictly speaking, yet corn will soon become one of its leading crops.

Farmers who are now growing corn find it to be the best paying crop for them.

Necessity compels us to look for some method of farming other than the bare fallow system.

That some system of crop rotation must ultimately take the place of the bare fallow system, the prevailing method of farming in Idaho at this time, the corn crop with an return does not appeal to a thinking man as being strictly a business proposition.

It is about the same as a corn crop. Interest on the money invested in the land and the rental proceeds. Corn must be grown on the fallow land to make farming as profitable as it should be.

There is no question as to whether corn can be made more profitable than Idaho butter. Butter is shipped into Idaho every month of the year from the middle west. Why not produce this butter within our own state?

Ten years ago ninety per cent of the farmers of Idaho bought their most expensive and best machinery for family use. Many of them will say, even at this time that there is no money in farming.

Any one will agree that to feed a crop that requires two years to produce is too expensive for dairy cows.

The dairyman who is making a profit on his business depends upon corn as much as the principal part of his cost of the feed.

It is well to be able to produce very economically when fed on corn silage. Everything is made better, and milk is produced from the feed of corn silage.

When Idaho's farmers need will make a better stand and do better. In fact, any of the Idaho crops will yield better following corn than the bare fallow.

Of the farmers of Iowa and Illinois, it is not possible to see the very best methods of cultivation taught to them by the great school of experience, and keep continually striving for some better method. The corn crop might be called a future with them. With all their experience and up-to-date methods, these farmers have very not uncommon with them, yet they do not despair and say that there is not a corn crop.

It will be a problem in many sections of Idaho to get corn to mature. In many sections it will be impossible. It is only a matter of time when corn will be one of the leading crops of this state, and Idaho one of the greatest dairy states in the union.

GIVEN LIFE SENTENCES.

Jury Returns Verdict of Guilty Against Slayers of M. J. Crowley.

Halley, Nov. 6.—Charles H. Allen and J. E. Crowder were found guilty by a jury in the Fourth judicial district court, now in session here, of the murder of M. J. Crowley, at Ft. Allen, resort, September 21, just six weeks ago. Sentence of life imprisonment in the state penitentiary at Boise was pronounced by Judge B. A. Walters shortly after the verdict had been returned. Two others, who are held as accomplices in the case are Charley Crawford and Lorenzo Swift, who turned state's evidence at the trial.

The defense tried to prove an alibi for the two men, but the state's witnesses established the fact that they were on the ground when the killing occurred. They brought out that Allen came into the resort and took a shot at Dot F. Allen, who is not a player in the game, who was in the room when the shooting was going on, and was dropped by a bullet from the gun of the slayer. Dot Allen was injured, while Crowley died instantly.

According to some of the members of the jury, that body at first seemed to be in favor of the death sentence for Allen, but afterwards agreed on the life term in the state penitentiary for both.

The trial of Charley Crawford and Lorenzo Swift, who are charged with being accomplices in the murder, will be held later in this term of the court, Statesman.

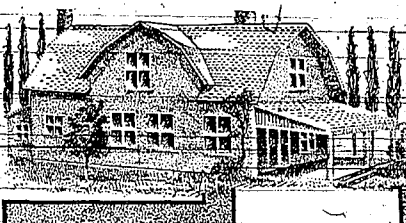

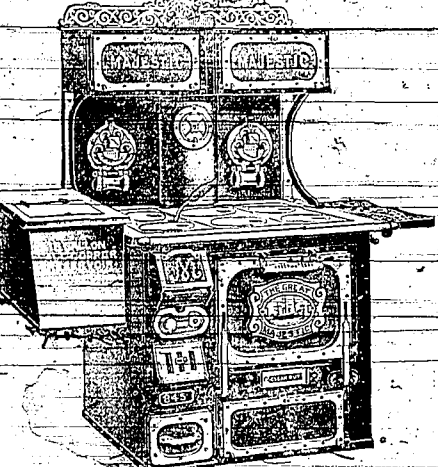
