As soon as the loan is authorized the state land commissioner will appraise the land and report to the registrar.

When the applicant has been notified that his application has been passed upon favorably he should have an abstract of titles prepared. The state accepts first mortgages only.

Final certificates or other evidences of ownership, except warranty deed on United States patent, do not constitute such title as will be required by the state.

The state makes loans for from one to five years, with interest at 2 per cent, payable semi-annually. Interest payments are payable January 1, and July 1, of each year.

The state loans up to one-third of the appraised valuation of the land, exclusive of improvements.

Blank notes and mortgage deed will be furnished by the registrar free, upon application.—Parma Herald.

Will Meet Governor West at Baker City Accompanying Him to Boise.

Governor Hawley is to ride horseback from Baker City to Boise in company with Gov. West, of Oregon, according to a statement in the Oregonian. Those who know "our Jim" best say he will not tackle any such stunt. He might make a sort of triumphal entry on horseback into Boise,
