## GOLDEN AGE IN MEXICO

"Pancho" Villa, having surrendered to the de facto government in Mexico, has been "submitted," as he prefers to call it, announcing that he is going to settle down in Durango as a farmer. It is a sign of the times.

It need not be assumed that Villa has experienced any real change of heart. Very likely he would still just as lief shoot a man as look at him, and if the man happened to be an American, would rather do it. But the business of it is not what it used to be. Even Mexico, after all these years of turmoil, shows signs of progress toward the white man's civilization. Obregon and De La Huerta seem to have succeeded pretty well in restoring order throughout Mexico, with the exception of Lower California, which is of little importance, for away and hard to reach.

Villa in the begotten role is an appealing character. The swashbuckler who has lived heretofore by stealing other men's food will go to work producing food for himself. The man who wanted his neighbor's wealth will not only obey the law but will start producing wealth. What he will raise is not revealed, but probably he will follow the historic example of Kansas, and raise corn instead of the infernal commodity he used to raise. With such things happening, is not the Golden Age returning?

## POLISH COMMANDERS REPORT ARMY STILL ADVANCING

WARSAW, Sept. 2.—Continued fighting in the region of Zamość, 15 miles southeast of Lublin, is reported in a Polish official communication issued today.

The northern wing of the Polish army is reported to be advancing without resistance. It has captured Gradec, says the statement, taking more than 1000 prisoners.

A group of red detachments appearing out of Chotk was repulsed with heavy loss.

General Budyenny's forces in the region of Zamość continues to meet firm resistance, continues the communication.

The statement declares that General Budyenny's activities have been paralyzed to a great extent, "thanks to effective activity on the part of the Polish pursuit group operating in the rear which succeeded in cutting off a considerable quantity of the enemy's supply train."

In Galicia, the situation remains unchanged.

## WITNESSES DID NOT GO ON STAND

By the Associated Press.  
CHICAGO, Sept. 7.—Democratic witnesses today were unable to present to the senate investigating committee the data on

which Governor James M. Cox based his charges of a \$15,000,000 republican campaign fund, because of the adjournment of the committee until Tuesday.

### Summons Issued.

At the request of Senators Reed and Pomeroy, the democratic members Senator Kenyon tonight issued a list of subpoenas for witnesses, chief of whom is Edmund H. Moore, of Ohio, Governor Cox's personal representative. Mr. Moore was here today to

present all the data in Governor Cox's hands, regarding campaign expenditures but he was not called during the brief session.

Several of the subpoenas issued were withheld from publication at request of Senators Reed and Pomeroy, the latter of whom returned to Chicago today from Columbus where he conferred with Governor Cox and Mr. Moore.

Among those made public were six republican leaders including Harry

M. Blair, of Marion, Ohio assistant to Fred W. Upshur, republican national treasurer.

The other nine chairmen of the republican ward and precinct committees in Ohio, Illinois, Missouri, Indiana and Kentucky. They are charged with appropriating the republican budget within their territories.

The six republicans were called at the request of Senator Reed who announced he wanted to find out how machinery was functioning in republican states.

Decision of the committee to accept today to permit witnesses to keep silent until subpoenaed was expected to today and had told newspaper men he expected to present charges in support of Governor Cox's charges that millions were flowing into the republican campaign chest.

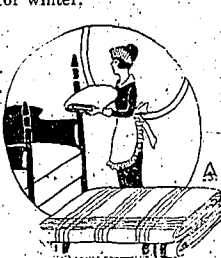

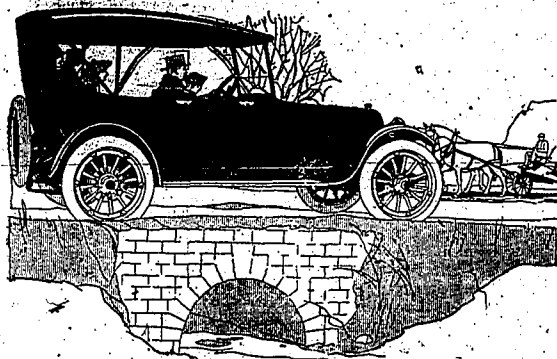

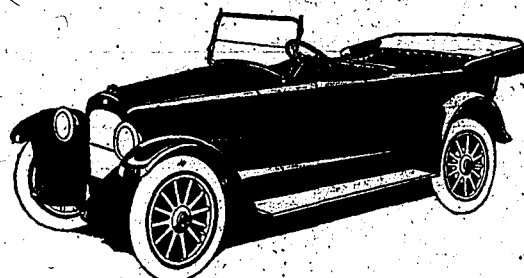

## Grain

CHICAGO, Sept. 7.—Active demand from houses with seaboard connections led to soaring wheat prices today. The close was nervous 1-4 to 1-2¢ net higher, with December \$2.45 3/4 to \$2.49 and March \$2.17. Corn gained 1/8¢ to 1-3/4¢ and oats 1-1/4 to 1-1/2¢. In provisions the outcome varied from \$1.25 decline to 25¢ advance.

Aside from indications of continued good export demand for wheat, the scantiness of receipts here counted as a decided bullish influence and so did the fact that rural offerings were extremely light at all western points. Only eight cars of wheat arrived today in Chicago, an abnormally small number. Unfavorable crop reports from Iowa and Illinois did much to make the corn market harken. Oats reflected the action of corn. Pork underwent a severe drop as a result of distress selling by holders.

## REPUBLICAN CANDIDATE TALKS ABOUT THEATRES

MAILTON, O., Sept. 2.—Commenting today on the proposed derogation of various commercial treaties, under a provision of the shipping act, Sen. Arthur Harding declared his belief that "some judgment" in favor of American bottoms must be made. If the present requirements on the trade are to be enforced.

"I am not prepared to discuss the effect of the shipping bill on existing commercial treaties," said the republican nominee. "The bill was enacted while I was involved in the pre-convention campaign. I voted for the measure. I never realized the policy of favoring American bottoms and it is my own judgment that the only way we can fairly promote an American merchant marine is to have the continuance of the specific requirements of our shipping, which competition do not require, and adjustment excepted to that situation in favoring contracts for the transportation of mail and other public business."

It was the republican's estimate bill represents the existence of many

as I think it does, and we impose unusual engagements on our merchant marine. We cannot make exceptions on our merchant marine without some adjustment to meet the situation. The senator referred to the subsidies granted by other nations to their shipping interests and said he had been told that competition in foreign commerce would be impossible for American shipping, conscious of which they were given substantial assistance.

The operators based their refusal to grant increased tonnage wage rates on the fact that the central committee five fold gave no such increase and that the advance in wages to day labor, or was asked in order to correct an inequality.
