



# GEN. HUMBERT STRIKES NORTH IN OISE VALLEY

Advances at Right Angles to Main Battle Line—Lay of Land Earns for Country Title of "Little Switzerland"

## FRENCH REVEALS POINTS OF STRATEGIC VALUE

Line Now of Sawtooth Nature Owing to Peculiarities of Terrain—German Morale at Low Ebb, Prisoners Say

By LOWELL MELLETT (United Press Staff Correspondent) WITH THE FRENCH ARMIES IN THE FIELD, August 14.—General Humbert following the successful advance of his right wing in the Oise valley, is now striking northward in that region, almost at right angles to the main battle front. This action is now fully under way, the French infiltrating the ravines, which give this section the name of "Little Switzerland."

The French already possess Plaisir and L'Ecouvillon, the keys to this region. The advance is careful because of the great quantities of mustard gas with which the Germans flooded the depressions and their abandoned trenches, but it is steady. The French line is now of a sawtooth nature, owing to the peculiarities of the terrain.

Admit Defeat Prisoners taken by a French division near Belval, Belgium, and a half directly south of Launoy, are responsible for the knowledge of German commands and orders. These prisoners, consisting of 177 men and seven officers, claim five different companies added to the increasing thickness of the shakiness of the German army's morale. It is no longer uncommon for German officers to admit double of German success, which was almost unheeded before the recent fighting began. Morale Gone The morale of the Germans is almost gone. That of Muisson, a Frenchman was taking back a German prisoner. Enemy shells began falling all around. The Poles took refuge in a shell hole. # U-BOAT SINKS TRANSPORT WITH HEAVY LOSS LIFE

440 Persons Missing in Sinking of French Transport Djennah in Mediterranean—Boat Was Under Convoy

PARIS, August 13.—Four hundred and forty persons are missing from the French transport Djennah, which was torpedoed and sunk in the Mediterranean the night of July 14, while under convoy, according to announcement. The Djennah was carrying passengers and troops.

On July 10, the French steamer Australin was torpedoed. She caught fire and exploded. Several men of her crew were killed and three passengers are missing. Nine hundred and forty-eight passengers were saved.

Another steamer in the same convoy was torpedoed but remained afloat. Several bombs were dropped on a U-boat as it was submerging.

# SUBSTANTIAL AID PROMISED ITALY

Enough Americans Will Be Sent to Assure Victory for Italian Arms

ROME, August 14.—Cooperation of the Italian and American navies in future operations in the Adriatic and Mediterranean is the chief concern of the mission to Italy of Franklin D. Roosevelt, assistant of the United States navy. Roosevelt said today in an interview with the United Press.

"With the intention of increasing our assistance to Italy," he said, "We are now endeavoring to solve the problem of using Italian ports to their full capacity. Henceforth, good ships to Italy must be discharged at Italian, instead of French ports."

Solve Traffic Problems It is imperative that we do this in order to relieve congested traffic conditions in the French roads. To put the plan into effect, the Mediterranean must be made safe from submarines.

"The American and Italian fleets can easily accomplish this task. We should also close the Adriatic and prevent the exit of enemy craft as well as paralyze the exploits of the Austrian fleet."

Roosevelt declared the United States is prepared to send to the Italian front enough troops to insure victory for Italy's arms. From the north sea to the Adriatic, the initiative both on land and sea has forever passed to the allies, he declared.

# BATTLE RAGING BETWEEN BOLSHEVIKI AND GZECHS

Soviet Army Numbering 150,000 Is Fighting for Key Positions on New Russian Front

AMSTERDAM, August 14.—A battle is raging between Czech-Slovak and Bolsheviki forces along the middle Volga, especially around Simbirsk according to dispatches received from Germany today.

Simbirsk, 400 miles east of Moscow is one of the key positions on the new "Russian front."

The soviet army is said to number 150,000. The soviet fleet in Volga has seized all Czech-Slovak vessels, breaking the latter's communication with headquarters at Simbirsk.

# PEACE OFFENSIVE MAY CONCEDE TO WILSON'S TERMS

Diplomatic Advances Indicate That Germany Will Yield Right of Self-Determination in Alsace-Lorraine

## TO END WAR WITHOUT MILITARY DECISION

Expected that Huns Will Make Open Proposition to Allies —German Offers Would Be Regarded with Suspicion

WASHINGTON, August 14.—That Germany and Austria will offer to submit to President Wilson's policy of self-determination in Alsace-Lorraine and the Austro-Italian Tyrolan provinces, in a new peace offensive of the central powers is expected in diplomatic circles here today. Reports arriving from various sources of political manipulations in Alsace and Lorraine that would indicate that the Germans in desperate attempts to end the war without a military decision might agree to a pacific in the "last provinces."

It is believed Germany will make an open proposition, but will attach such conditions to it as would put the matter entirely under her control and assure a favorable verdict for Berlin.

WASHINGTON, August 14.—August 24 will be the next registration day for American boys who have reached 21, since June 5 last.

To prepare for any delay in the passage of the 18-45 man-power bill Provost Marshal General Crowder has issued orders to state headquarters calling for a registration August 24.

It is planned to hold the first registration of men between 18 and 21, and between 31 and 45, early in September, if the man power bill passes by that time as expected.

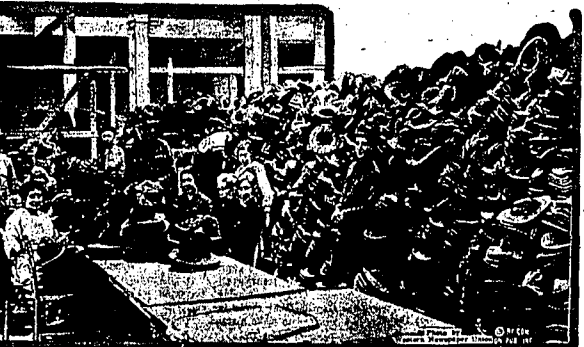

## BREAK BETWEEN SPAIN AND HUNGARY HELD PROBABLE

Alfied and Neutral Diplomatic Circles Doubt Her Becoming Actual Combatant—Situation Is Grave in Spain

WASHINGTON, August 14.—A diplomatic break between Spain and Germany is held to be probable in allied and neutral diplomatic circles here, but Spain as an actual combatant is considered unlikely. Official dispatches from London, Paris and Rome report a grave crisis at Madrid and throughout Spain.

### Unrest Spreads

The food shortage reported to have attained the proportions of a famine in the centers of population is declared to have precipitated the growing dissatisfaction of the Spanish people. Spain has completely exhausted her stock of many staple foods. The Spaniards see that the French and Italians, though actually at war, are better off in many respects.

An official Rome cable suggests that the Spanish cabinet is likely to decide upon immediate "energetic action" against Germany. It is declared that the attitude of the Spanish government and people in regard to Germany's submarine campaign has become increasingly bitter.

### Seek Relief First

Diplomats are inclined to believe that Spain's first step in a program of "energetic action" would be to put all the ships of the kingdom, now detained in port on account of the submarine menace on the high seas to bring food to the stricken populace. A demand upon Germany to spare the ships probably would be made simultaneously.

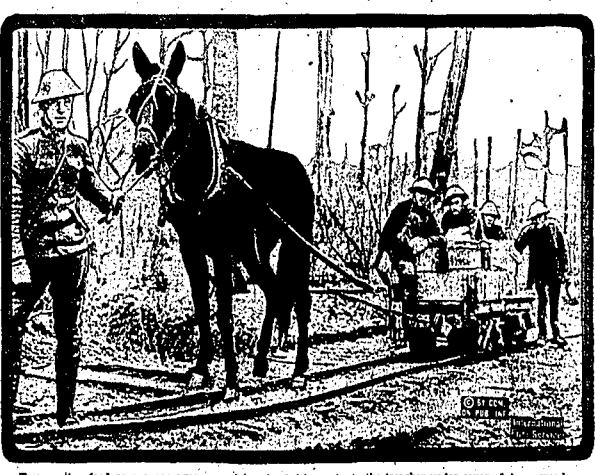

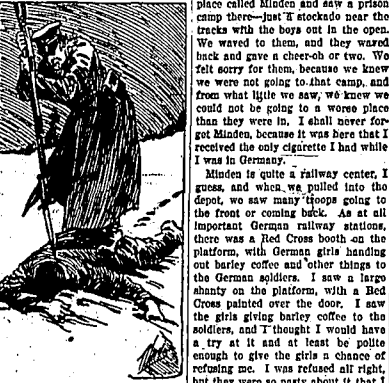

"Zuruck!" as I had enjoyed this latest addition very much, and we were glad they had the dogs.

There were some things the Hun did that you just could not explain. For instance, one of the Russians walked out of the kitchen, as we were passing, and we heard a Bang! and the Russian knelt over and went west. Now, he had not done anything and the other Russians said he had behaved himself, worked hard and had never had any trouble. They just killed him, and that is all there was to it. But not one of us could figure out why.

After we had been at Neuville for three weeks, they drilled us out of the camp to a railway station, and stood us in the open for four hours waiting for the train. We were exhausted and began falling, one by one, and each time one of us fell, the sentries would yell, "Nicht krank!" and give us the rifle butt. We had our choice of standing up and dying or falling down and being killed, and it was a fine choice to have to make.

The cars finally pulled in, and as usual, the windows were smashed, the doors open, and the compartments jam-packed with snow. When we saw this, we knew we were going to get worse treatment, even, than we had been getting, and many of us wanted to die. When we reached Wittleben, the men to tell the Germans to shoot them too, and it seems as though it was always a man who wanted to live who did get it and went west.

However, all of us nearly got killed when we reached Wittleben. When the train stopped there, we saw a big wagonload of sliced bread on the station platform and we all starved at it. We stood it as long as we could, and then we made a dash for it. When we got nearer, we saw that there were four sentries guarding it and four women issuing it out to the German soldiers. They would not give us any, of course.

So we stood around and watched the Hun eat it, while they and the women laughed at us, and pretended that they were starving and would groan and rub their stomachs and say, "Nicht so reich!" and then they would grab a big hunk of bread and eat it. What we did not say to them was very little indeed. We were certainly wild if any men ever were.

He did not want to smoke again for some time afterward, and like as not, he did not want to eat either. They were therefore very valuable. It is very hard to get matches in the camps, and when any prisoner does get hold of one, it is made to last a long time. Here is how we make a match last. Some one gives up the sleeve of his coat, and the match is carefully lit, and the coat sleeve burned to a crisp. Then we take a button from our coats—the buttons are brass with two holes in them—pass a shoestring through the holes, knot the ends, and with the button in the center of the string, buzz it around as you have seen boys do, with the string over both hands, moving the hands together and apart until the button revolves very fast.

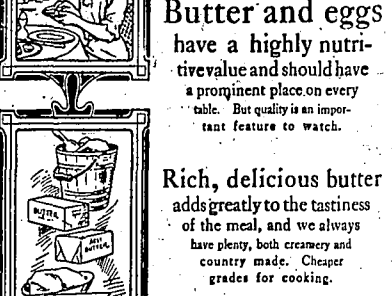

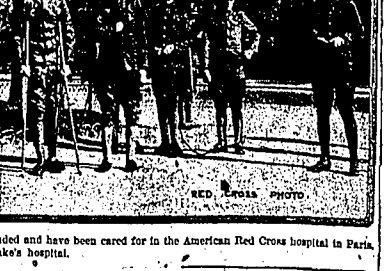
