



# RESISTANCE TO TEXTILE WAGES CUTS INDICATED

**Workers Organization Executive Says Reports from Mill Cents Point to a Fight Against Pay Roll Reduction**

NEW YORK, (AP)—Reports from mill centers give every indication that wage reductions announced for December 20 by large textile manufacturing plants will be resisted, John Golden, president of the United Textile Workers of America, declared here today.

## LAWRENCE MILLS ANNOUNCE FORTHCOMING WAGE CUTS

LAWRENCE, Mass., (AP)—First announcement of actual reduction of textile operatives' wages by large mill corporations was made today by the Pacific mills and the Arlington mills of this city. Their 16,000 workers were notified that a readjustment had been made, effective December 20. In accordance with custom the amount was not stated, but it was understood to approximate 2 1/2 per cent as suggested by a manufacturers' conference last week.

No word of its attitude on the question of wage reductions came from the American Woolen company whose four local mills employ most of the other operatives in the city.

The Pacific and Arlington mills make principally cotton cloths. The notice posted by the Pacific mills management said that "due to lack of orders and a lack of stock in the textile industry" the readjustment was necessary.

## New Bedford Mills Affected

NEW BEDFORD, Mass., (AP)—Wage reductions affecting approximately 40,000 operatives, were announced today by all cotton mills affiliated with the New Bedford Cotton Manufacturers association. The reduction, amounting to 2 1/2 per cent will become effective next Monday.

## Blanchery Gives Notice

LONSDALE, R. I., (AP)—Employees of the Lonsdale Blanchery at Lincoln, Blanchery were notified that a wage reduction would become effective December 20. The amount was not stated. About 1,600 employes are affected.

## DEPORTEES IMPLICATED IN RUSSIAN BOMB PLOT

Members of Party Sent from America on Soviet Ark Charged with Attempts to Blow Up Officials

WASHINGTON, (AP)—Members of the party deported nearly a year ago on the Soviet "ark," Buford, with Emma Goldman and Alexander Berkman, have attempted to blow up officials of the Russian soviet government, according to information received by the department of justice. The advice said that Mark Gidowatz and Arthur Katjes were in jail at Moscow for attempting to plant bombs in a building occupied by the general executive committee of the soviet government.

Schnabel, formerly head of the Union of Russian Workmen, the reports said, had been killed by the Japanese in Siberia while engaged in railroad work. Peter Branky was reported to have entered the ranks of the communist party and to be associated with the international propaganda bureau at Petrograd. Hyman Perkins was said to be employed at Odessa, both the Schatz brothers in Kiev and Paul Kovaloff working on a tug boat near Petrograd.

**Contest Between Murray and Howat for Miners' Union Office Holds Attention**

PITTSBURGH, (AP)—Interest among miners of this section in the district and national election of officers of the United Mine Workers of America, which was held today centered in the election of the vice president. The contest between John L. Lewis of Indianapolis, and Robert H. Harlin of Seattle for the chief executive position was forgotten momentarily in the race of Phillip Murray, of Pittsburgh, Pa., and Alexander Howat, of Pittsburgh, Kan., for the vice presidency. Murray for several months, has been conducting negotiations with the anthracite coal operators to secure for the hard coal worker a wage increase equal to that recently granted the bituminous miners. Howat, since the great coal strike was called in 1919, and which the union was enjoined from putting in effect, has been at variance several times not only with union officials but with the federal authorities.

# CONSTANTINE WILL NOT ABDICATE GREEK THRONE

**Former King Recalled to Rule Over Hellenes Personally Declares Purpose to Return**

LUICERNE, Switzerland, (AP)—Constantine of Greece yesterday personally declared he would not abdicate the throne. Professor Georgios Strait, his confidential adviser, last week denied reports that Constantine might abdicate in favor of Crown Prince George, but today's utterances by Constantine was his first direct statement on the subject.

"I will not abdicate and never had any such intention," said Constantine in his farewell interview with the correspondents preliminary to his departure for Venice tomorrow, en route to Athens.

# COUNTS GOLDEN RULE CURE FOR INDUSTRIAL ILLS

**Former Minister and Present Executive of Manufacturing Concern Recites History of Unique Undertaking**

CINCINNATI, O., (AP)—The Golden Rule of the divine law governing human relationships, accepted by all religions and proclaimed by all prophets and teachers of every creed, and is the only workable, industrial and economic law in the universe today, according to Arthur Nash, former minister and present of the Golden Rule (Clothing Manufacturing company of this city, who has injected the Golden Rule into the conduct of his business. Recently the 500 employees of the company, actuated by the spirit of the Golden Rule, agreed to surrender their jobs for a month, either January or February, so that unemployed workmen in the clothing industry could be given employment. In June, 1919, the company was incorporated with a capital stock of \$60,000 and Mr. Nash as the prime mover and principal investor was elected president.

## Reject Profit Sharing.

In July, 1919, the company moved into more commodious quarters on the strength of a loan of \$50,000 from a bank. Mr. Nash called the employees together and told them of the loan which he said was negotiated on the basis of his confidence in them. With the Golden Rule proclaimed as the governing law of the business, Mr. Nash submitted a profit-sharing plan to the employees. Their confidence in Nash was such that the employees refused to accept the plan but said they preferred to have their pay each week and were willing to leave it to management to figure out what they could pay in weekly wage. Wages were thereupon increased from time to time. At the end of 1919 the company found that the plan was increasing and the enormous expense of moving and equipping the new plant it had made a net profit of \$42,000 on an investment of \$60,000.

The actual condition at that time was that the company was paying higher wages, selling its products for less money and earning a larger profit than any of its associates in business. Mr. Nash says that these figures were submitted to the employees and that he felt chagrined because it was his belief that an unjustifiable profit was made off the labor of others. At

the meeting Mr. Nash said that wages would be increased from 10 to 20 per cent. Later the profit sharing basis of arriving at a just wage, as the only solution of the problem, was adopted.

By the plan presented to them the profits were to be divided among the help on the basis of salaries earned, twice a year.

## Equalize Dividend.

The employes who earned more than \$60 a week, petitioned the company to distribute the workers' share of the profits on the basis of time worked instead of on the basis of wages drawn. The petition stated that this would give those earning the smaller wage an equal dividend with those making larger sums. This meant that the cutters and the off present earning from \$75 to \$90 a week petitioned that the poorest paid hold receive the same dividend that they did.

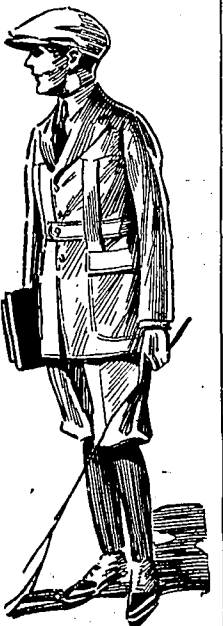

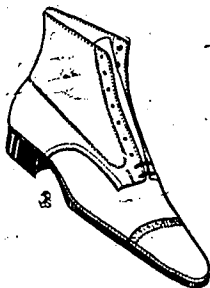

A PROBLEM TO SOLVE

Populism arose in the west about 50 years ago because of the low price of farm products, the prevalence of mortgages and a belief, whether well-founded or otherwise, that the farmer was not getting a square deal. The mortgage is far less common now than then but the other conditions at present are about the same and the protest against the situation that now is heard reminds much of populist days.

It is not astonishing that a farmer who raises wheat at a cost of \$2 a bushel should feel that he has a grievance when he finds that he can sell his crop only at a price that means a heavy loss. He would have no such well-founded cause for complaint did he find that what he has to buy had declined in price in the same proportion, but right there is where his wrong lies.

The question of what can be done to render the situation less tense is the big problem before congress. Revival of the war finance corporation, extension of credits to Germany in order to afford a market for our surplus products and placing a tariff on Canadian wheat have been suggested.

The credit situation is the largest factor in the problem, though there is no intention of making an effort to have the government offer financial aid since that is realized as impossible. The farmers do not object to the deflation, realizing that they must eventually get down from the high prices, but they do not like to see their property devalued and in this they seem to have a good case.

DEVOTION WINS SYMPATHY FOR KING'S SPOUSE

Nothing but Good to be Heard in Greece about Wife of Late Ruler Previously Center for Storm of Protest

ATHENS, (AP)—The devotion shown by Mrs. Alexandra Manos, wife of the late King of Greece, to him during his fatal illness resulting from the bite of a monkey, has created so profound an impression upon the Greeks that they have heretofore and spared no effort to separate her from the king, have today nothing but good to say about her.

Her devotion during which the king fought for her life against blood poison, his wife obtained not a moment's rest when exhaustion compelled her to take a little sleep. The ordeal she underwent it had been so long and because of her own state of health, since she is to become a mother.

Government Finds Law. Heretofore King Alexander's marriage had not been considered in some governmental quarters to be valid because it had been contracted secretly and without the fulfillment of certain formalities. Since the death of the king, the government has been so moved by the story that it has discovered a law by virtue of which Mrs. Manos is recognized as having been the king's legal wife.

This was regarded heretofore as excluding the possibility of a marriage in connection with her inheritance of the late king's personal estate. It is also understood that the government was anxious to have the highest confirmation for the payment of a pension to Mrs. Manos.

All this has made her an interesting figure in the tragedy enacted at the palace where the king and his wife led the happiest of lives until the terrible mishap cut short the life of the monarch. Their romance has been one of the most fascinating stories of royal life in Europe for years.

True to Plighted Troth. Aspasia Manos belonged to the Greek Thracian aristocracy but was not of royal blood. She was a beautiful girl and the young prince fell in love with her. When King Constantine abdicated and Alexander was called to the throne, he laid down as a condition of acceptance that he should be allowed to marry the girl to whom he had plighted his troth.

AUSTRALIA ALLOWS FOR DEPRECIATED CURRENCY

Opens Markets on Payment of Duties at Bank Rate of Exchange. NEW YORK, (AP)—The Australian government has taken steps to enable countries whose currency has depreciated to trade with Australia, according to advices received by Mark Sheldon, commissioner for that dominion.

Australia has been collecting customs duties at the mint par rate of exchange based on the value of its values in the currency of the country where the goods originate. This, the commissioner says, has made it virtually impossible for certain countries whose currency has depreciated to trade with Australia, because the duties would be too high.

FORDNEY URGES REFUND OF GOVERNMENT'S DEBTS

Ways and Means Committee Chairman Would Reduce Tax Bills

WASHINGTON, (AP)—Refunding of some seven and one-half billions of government obligations falling due in the next two years and a half and the reductions of taxes to the sum needed for the ordinary running expenses of the government was advanced in the house Monday by Chairman Fordney, of the ways and means committee.

Representative Fordney said he did not believe it was possible to collect from the people sufficient funds to meet operating expenses and retire the maturing obligations, including victory notes and war savings stamps. He pointed out that the expenses of the government for the next year would approximate \$4,000,000,000 and added: "It is impossible to pay off those obligations and at the same time furnish sufficient revenues to carry on the running expenses of the government."

UPHOLDS QUASHING OF BISBEE INDICTMENTS. Supreme Court Sustains Federal Court Decree in Arizona Deportation Cases

WASHINGTON, (AP)—The supreme court Monday sustained federal court decrees quashing indictments brought against 25 defendants who were charged with participating in the deportation of 221 alleged undesirable from Bisbee, Arizona, into New Mexico in July, 1917.

INDIANS GET WAGNER. CLEVELAND, O., (AP)—Announcement that the Cleveland baseball club acquired Arthur Wagner, an outfielder from the Joplin club of the Western league before the world's series, was made today.

URGES ROADS BUILDING. Secretary of Agriculture Offers Plan to Meet Unemployment Problem

WASHINGTON, (AP)—Prompt action to continue federal aid in highway construction as a means of meeting the increasing unemployment problem, was recommended by Secretary Meredith, of the department of agriculture, speaking at the annual gathering of the Association of State Highway Officials. Present provisions for such aid expire next June, the secretary said and he urged that congress provide a new five-year program with appropriations of \$100,000,000 a year to carry forward the work.

PRICES FALL REACHES SWEDEN. STOCKHOLM, (AP)—The tendency of prices to fall has now reached Sweden and according to the Svensk Handelsblad, during the month of October it amounted to 4 1/2 per cent.

# EMPLOYERS OF IDAHO GATHER AND ORGANIZE

### Associated Industries of Idaho Brought into Being at Meeting of Delegates

At a meeting of delegates from Boise, Idaho Falls and Twin Falls held at Gooding, Monday, officers were elected and a constitution adopted following the organization of the Associated Industries of Idaho.

Delegates from Twin Falls who were present report an interesting session. An entire day was consumed in the work of organization and a good spirit was apparent among the various delegates from the very beginning.

**Extension Association.**  
The Associated Industries of Idaho is an extension under and a part of the work of the Southern Idaho Employers' association, and as at present consists of a Boise division, an Idaho Falls division and a Twin Falls division.

**Preamble to Constitution.**  
Following is the preamble to the constitution as adopted:  
"We, the undersigned, hereby associate ourselves together under the name of the Idaho Associated Industries of the state of Idaho and the harmonizing and standardization of the policies and measures undertaken to effectuate those aims."

"One of the principles upon which this organization is based is the use of the American plan of employment by all members of the Associated Industries, and membership in this association is hereby understood as an endorsement of the American plan (or open shop) method of employment."

"A second principle of the Associated Industries is that the right of every man, and this association hereby recognizes and will maintain such right, either on the part of the employer or the employee, will, however, just as diligently and firmly resist coercion and intimidation in any place or in any of its phases."

"A third principle of the Associated Industries is its assistance on and the maintenance of an honest wage to the employees of any member of the association, and membership in the association is hereby understood as an endorsement of the above principle."

# ALL WATER USERS STOCKHOLDERS IN MUNICIPAL FILTRATION PLANT

### Alderman C. B. Channel Explains Why the Twin Falls People Should Get Behind Water Meter Saving Scheme as a Practical Means of Making Waterworks Institution a Paying Proposition

Every water-user in this community is a stockholder of the Twin Falls waterworks. As such stockholder it is to the advantage of users to give every assistance in efforts to make the water delivery plant a service as well as financial success.

To this effect Alderman C. B. Channel addressed the municipal administration last night. He stated that in his opinion the average user of water looks upon the city council as a trust formed for the purpose of operating the city waterworks without considering the will, wisdom or pleasure of the people.

**Meters Cause Complaint.**  
Alderman Channel's statement, was made in connection with a discussion over the installation of water meters throughout the city. This discussion brought out the fact that numerous complaints have been lodged against the installation of these measuring devices, both as to the plan of charging the cost of the devices to the consumer, and also as a means of regulating and charging for the amount of water used.

**Broad as Long.**  
"I have told all those who complained to me about charging the property owners and users for the meters that the whole proposition is as broad as it is long; that the people must pay for the measuring devices one way or another, and that is the long and short of it. If they prefer to pay by taxation that is up to them, but the meters must be paid for and only the people themselves are involved," said Alderman C. B. Channel. The same sentiment was voiced by all the council colleagues, including Mayor W. H. Eldridge.

One of the complaints lodged against installation and operation of meters came from the users in outlying districts, who declared they would protest against the meter system as applying to themselves unless the entire town is metered by the time the irrigating season begins. These protesters take the position that the plan of metering the outlying districts is discriminatory, and that under the measuring system users are benefiting during the non-irrigating months. Mayor Eldridge, in view of this fact, was constrained to state that there is much crying before anybody is hurt.

**For User's Benefit.**  
It was at this juncture that Alderman Channel stated that if the people would look upon the plan as a stockholder benefit proposition instead of just seeing what they believe to be an injustice done the users the whole proposition will be settled without further controversy.

All the aldermen expressed the sentiment that the meter plan will ultimately work out to the advantage of the city generally, and will have the effect of teaching the people economy in the use of water instead of permitting continuance of an extraordinarily wasteful habit with respect to the use of water in irrigating times.

It was further asserted that through the meter system only can the excess tax on the filtration plant at the peak of the irrigating season be eliminated.

John J. Filmering, waterworks superintendent, stated that the city is now supplying meters at less than cost, the single devices being charged to the city at \$20.25 by the manufacturers. Users get the meters at \$20, or \$18 if paid in full. He said there are now 200 meters installed, and expected to have 700 more laid down here in January. These, the superintendent, would all be installed in time for the opening of the regular irrigating season, so that all persons who use water will be placed on the same rate basis.
