SUMMER MONTHS HAVE HAZARDS

Safety Institute Sends Out Warning to Children Released from School Duties

NEW YORK, (AP)—Judging from reliable statistics of previous years, approximately 6,000 children will be killed and 100,000 more injured in accidents during the summer vacation period throughout the United States unless parents and other guardians give greater attention this summer to the safety of their charges. This warning comes from the Safety Institute of America, with headquarters in this city.

Before July 1, the Institute points out, something like 20,000 children will be thrown on their own devices for amusement, be the closing of public and private schools. The accident hazards confronting children throughout the year as a whole will then be multiplied many times by longer hours of play; by the summer increase in automobile traffic; and by the lapses of schoolroom discipline.

The principal causes of accidental death among children, the Institute avers, are fire, the automobile, drowning, and the auto-mobile. The child of about seven years of age is in the greatest danger of becoming the victim of a fatal accident that depends on the child's care, at which mothers begin to permit children to take care of themselves.

"Vacation Do's and Don'ts"

In an effort to stem the usual summer tide of violent deaths among young people the Institute has issued a list of Vacation Do's and Don'ts with the recommendation that teachers, parents and all other persons who have the opportunity to reach large groups of children, bring them on to the children.

The list follows:

- "Swim all you can this summer, but never on a full stomach, or if overheated or extremely tired."
- "Learn to swim, but never pretend yourself to be a diver; you may really need help some day, and not get it."
- "Learn to make your own canoe, but never rock the boat to scare the other fellow; this has caused the death of thousands of boys and girls."
- "If you are out with the children who instead of being with you, have been electrocuted when their kite wires, also don't climb telegraph poles to recover entangled kites."
- "Hike out into the country, but if you go for more than one day carry a first aid kit with you; also learn to recognize poison, and then stay away from it; drink a lot of water, but that make sure that its source is clean."
- "Don't use the streets for play if there isn't vacant lot, a clean alley, or a playground nearby; if you must use streets for recreation, pick a street that has no street car tracks or heavy automobile traffic."

Don't Be a Jaywalker

"Don't be a jaywalker; in the city cross streets at regular crossings, never in the middle of the block; when walking across the street, look to the left, then to the right hand side of the road, so that you can see approaching vehicles."

Finally, remember that June is a particularly dangerous month in which to take chances; the other dangerous months are July, January, September, April, November, August, May, December, October, August and February."

COURT RULES AGAINST SCHEME FOR SETTLEMENT ON SALMON

Judge T. Bailey Lee Declares Attempt to Solve Problem Involves
Contract to "Sell What They Cannot Deliver and Buy What
Already Belongs to Them"—Enjoins Transfer of So-Called
Surplus Stock on Company's Books

Persons who have attempted to effect an all-out, void as against the settlers, and will work an unwarranted discrimination as between contract holders for water rights in such restricted area. They therefore pray that the contract entered into between the defendant, Ray, and these companies, their successors and assigns, whereby it has been attempted to convey him additional water rights be canceled; that he be enjoined from receiving any additional water thereunder; that the contract company be enjoined from transferring any or such purchased shares upon its books, and finally that the defendant company be directed to distribute the water available for the restricted area pro rata according to the agreement between the settlers therein who have paid or tendered the basic advance charge prescribed by the board of directors.

No Dispute Over Facts.
The defendant company sets up in its answer certain details and affirmative defenses which have been adopted in effect by the defendant, Ray, and the intervenor, Clinton. There is precisely no dispute over the facts. The stipulation filed shows that the landholder committee actually purchased some 20,000 shares of the defendant's stock, and has been causing the same to be transferred to settlers within the patented area; that this was done in violation of the defendant company's by-laws amended by resolution to the effect that all stock available for the restricted area should be applied to the restricted area. Three affirmative defenses are urged especially: First, that certain persons, presumably the bondholders' committee, had been perfecting a settlement with a large number of holders of water contracts and re-endorsing to effect similar settlement with all such holders; that in pursuance of this intent and purpose, the by-laws of the defendant company were amended at a stockholders' meeting providing that certain shares of stock owned for extended lands may be transferred on the company's books and made appurtenant to the lands included, and that water should be delivered in accordance with the number of shares appurtenant to tracts or parcels of land within the restricted area; that to acquire delivery of water according to the average would be in violation of the by-laws, and would unjustifiably deprive of their vested rights those contract holders who have accepted such shares and purchased three additional shares originally issued for lands therewith transferred, have been or will be transferred on the company's books, and that the defendant company will distribute the available water according to the number of shares outstanding and not according to the average as was originally intended.

They claim that such contracts were

predecessors could have bought these shares except as trustees for the entire body of entrants. Water rights are not subject of speculation to be bought and sold by persons who have no land upon which to utilize it. A more brokerage would ensue, and a traffic in water rights to be held and sold at pleasure is inconceivable.

The only way legally to acquire these water rights is by direct purchase either from the owner or on foreclosure of his defaulted contract by someone who has land to irrigate or is in the business of impounding and retaining water for irrigation.

Not only any body of stockholders by resolution or otherwise determining that water in the company reservoir should be distributed according to shares appurtenant to lands within the restricted area. This would arbitrarily preclude an outside contract holder who had not accepted additional shares getting any water at all, and such resolution would be void as to such included entrants, as may have purchased shares from the bondholders' committee. Judge District has well said: "How could an excluded settler be compelled against his will to relinquish his right?"

Involves General Trust.
As to the contention that the entrants who have purchased these shares from the bondholders' committee are not to be excluded from the water, predecessors may be deprived of their property without due process of law, no judgment is that they have dealt with parties who have contracted to sell what they cannot deliver, and furthermore have contracted to buy that which already in equity belongs to them. As before stated, in the hands of these original purchasers these water rights or shares become impressed with a trust in favor of all contract holders, and they were sold to the settlers still subject to that trust. Not until the contract of every remaining settler had been fulfilled, could that trust have been discharged. Had some strange water company bought up these shares and sold them to inside entrants, the transaction would have been perfectly sound, but equity cannot permit parties standing in the relation of these bondholders and their predecessors with the contracting entrants to defeat the obligation of the very contracts they later seek to enforce.

As to the further defense that the members of the bondholders' committee and the settlers who have purchased these additional shares should be made parties to this suit I think this contention has been disposed of by the decision of the supreme court in the Skidmore case.

Entitled to Contract Fulfillment.

Resignation of Dr. Alvin E. Evans to
Accept Offer from George Washington
University, Expected

UNIVERSITY OF IDAHO, MOSCOW.—Announcement that Dr. Alvin E. Evans, professor of law at the university, and received an offer of a professorship from George Washington University, Washington, D. C., and that his resignation was expected, effective September 1, is made by Dr. A. H. Upham, president of the university. Professor Evans is now at the University of Texas, at Austin, where he is delivering a course of summer school lectures on property. Professor Evans has made special study of the law of community property and has published articles in several law magazines which have attracted wide attention.

Professor Evans has been a member of the faculty of the University of Idaho since 1917. He holds doctorates in philosophy and in jurisprudence from the University of Michigan. "I regret exceedingly the loss of Professor Evans," said President Upham. "His scholarly interests and his numerous recent contributions to the literature of the law have attracted a great deal of favorable attention to the law school of the university. The several opportunities he has had of late to accept more remunerative positions have been a just recognition of his achievements."

"The loss of Professor Evans is only another indication that our salary scale at the University of Idaho is relatively low, so that it tends directly to avoid rather frequent changes in our teaching staff."

"Steps will be taken at once to secure a thoroughly competent man in Professor Evans' place."

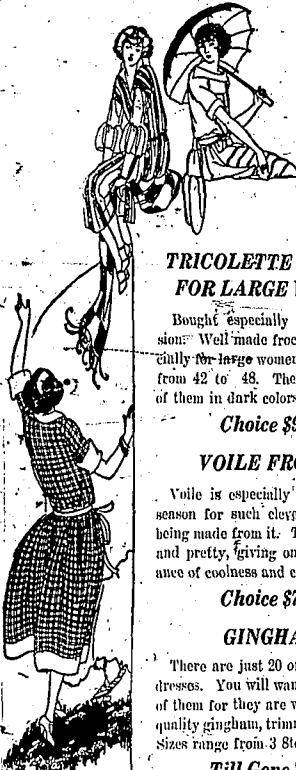

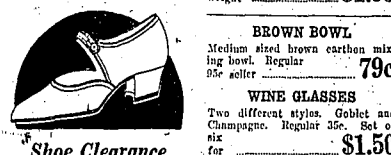

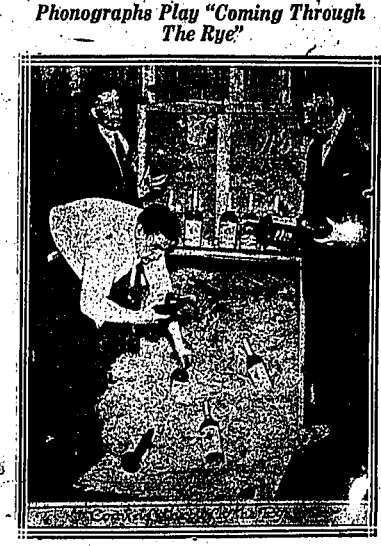
