ASSASSINS-SLAY IRISH LEGISLATOR

Fatal Shooting of Sean Hales and Wounding of General O'Malle seen as Fulfillment of Constant Threat

DUBLIN, Dec. 7. (AP)—Sean Hales, a deputy of the Irish parliament, was slain today as he was leaving the O'Connell hotel for parliament, accompanied by Brigadier-General Patrick O'Malle, who served in a deputy capacity of the house yesterday. General O'Malle was seriously wounded, being shot in the hand and leg.

General O'Malle underwent an operation and tonight was reported as doing as well as could be expected. An official statement from army headquarters at Fortio Bally barracks said that a condition of a truce existed in Dublin.

Fulfill Constant Threat The shooting of the deputy is in fulfillment of a constant threat. The names not only of the ministers who ordered the recent conscription, but of all members of the Dail Eireann who voted in favor of repressive measures, were published in a blacklist, and the men were warned that they would be held responsible.

Hales was a prominent supporter of the government and had been a strenuous fighter against the English. He was the chief agent in Dublin of the Irish volunteers together in southwest and west-coast and took part in many attacks against the British.

Another Fight Evaded It was in charge of Eblodan battalion from 1917 to 1920 and in April took office as brigadier general in the same area, and since then he had been a major general in the armed forces of the government.

President Cosgrave of the Irish cabinet, made the announcement in parliament of the assassination, and Richard Burke, minister of agriculture, tribute to the two men. His voice was tense with passion when he declared that "these victims had no priest, no funeral, no burial, no work, and no reporters were present."

Almed as Labor Members This was aimed at the labor and other independent members who have frequently urged the presence of representatives of the press at court-martial hearings and the withholding of the announcement of executions from relatives until all was over.

ULSTER DENIES DUBLIN'S RULE Sir James Craig Goes to London With Address to King for Severance

BELFAST, Dec. 7. (AP)—Premier Sir James Craig, accompanied by the Marquis of Londonderry, leader of the senate, and Colonel Spender, secretary to the Ulster cabinet, started for London tonight, bearing an address to the king, requesting Ulster out of the Irish free state.

The address was voted unanimously by both houses of the Ulster parliament tonight in a session which lasted for more than half an hour.

In his explanatory speech in the house of commons, Premier Craig declared it was useless to hold out any possibility that Ulster would accept the Dublin parliament and asked that the moment such a question arose, he would refuse to remain premier.

Against Accommodation The premier's whole attitude was against any accommodation with the south. He said the northern parliament would have nothing whatever to do with the boundary commission, provided for under an agreement which he described as a bargain entered into by the two parties behind the back of the northern government.

CONVICT BOISE MAN OF MURDER

Jury Find A. E. Caviness Guilty of Slaying Wife and Recommend Life Imprisonment

BOISE, Idaho, Dec. 7. (AP)—Forty-two minutes after they had taken the case, the jury in the wife murder case of A. E. Caviness, a convict, returned its verdict today.

Caviness' trial, which began November 22, was held at the Idaho state prison, following a brutal beating the night of August 31, when he was held in custody of a number of prisoners who entered sweeping demands of every incriminating bit of evidence relative to the charge of cruelty given by character witnesses during the taking of testimony.

UNITED STATES VETOES TURKS' PLAN TO DRIVE OUT GREEK POPULATION

Near Eastern Peace Conference Sees American Government Take Determined Stand in Line with Traditional Humanitarian Policy; Menace to Entire Negotiations is Seen in Possible Insistence on Deportation

VENIZELOS WILL NOT AGREE TO REMOVAL OF FELLOW-COUNTRYMEN

LAURENCE, Dec. 7. (AP)—True to its traditional humanitarian policy, the United States government took a strong position at the Near Eastern peace conference today in protesting against "expulsion of the Greek population from Constantinople." A vote was taken that the Turks would insist on their deporting all Greeks from their occupied cities, and the American delegation, when at the meeting today of the sub-committee on the exchange of populations, a Turkish representative announced that the Greek side of all the Greeks was a feature of their program concerning the adjustment of populations.

It was stated that the bandits who number approximately 30,000, now are battling with Generalissimo Chiang's troops. LIQUOR FIGHT FLARES UP IN HOUSE SESSION

Advocates of Prohibition and Opponents Stage Stormy Debate Over Dry Law Enforcement Appropriation

WASHINGTON, Dec. 7 (AP)—An old time liquor fight—short but stormy—flared up in the house today during debate on the \$10,000,000 treasury supply bill, which item \$2,000,000 for prohibition enforcement.

Starting when Representative Maule, republican, New York, a member of the committee which drafted the bill, declared that defiance of the Volstead law was no prevalent as to "licensing our institutions." It ended abruptly just after Representative Hill, republican, Maryland, a leader in the movement for light wines and beer legislation, had announced what he proposed to offer in the form of amendments when the prohibition section was reached tomorrow.

Bray Joins Barrage.
Meanwhile, friends of prohibition, overwhelmingly in control, took one shot after another at those who sought to attack the law and by parliamentary methods cut short Mr. Hill's attempt to connect the prohibition unit in a friendly way with the Ku Klux Klan. In urging congress to give to the states the right to say what alcoholic content would make who and beer interesting, Mr. Hill said he probably would result in a beverage made from pure ingredients and "the restoration of wholesome respect for the law."

Declaring the liquor traffic had thrived on misery until the people had had enough, Mr. Hill said he would like to see a law which would prohibit the sale of liquor in the bar room, Kentucky, shouted to the house that he was getting tired of constant attacks on men who were trying to see that the law was obeyed.

Explains Amendments.
Half a dozen members were on their feet at once trying to break in their questions when Mr. Hill, with six minutes to close the general debate, explained the nature of his amendments. "In the first place," he shouted above the hubbub, "I shall propose that the house strike out of the bill item of \$100,000 for the prohibition unit's publicity bureau; that the sum of \$100,000 to \$100,000 as heretofore, shall not be spent hereafter in open violation of the Volstead law for the purchase of bottled liquor to be used as evidence; that some of the government appropriation shall be used to defray the expenses of stump speakers sent over the country by the prohibition commission."

All the time Mr. Hill was being bombarded with questions as to whether he was trying to tighten the Volstead law. "I shall also propose to strike out of the appropriation all funds," he went on. "For that reason, special counsel to the prohibition unit, on the ground that its legal force does not know how to continue the law which exists today. Another amendment provides that no part of the fund shall be used by the commissioner for propaganda purposes, in an attempt to defeat members of congress, and finally, to transfer enforcement of prohibition from the treasury to the department of justice, where it belongs."

Rebuke to Hill.
Mr. Hill declared that anybody connected with the government "who approves the Ku Klux Klan, should not receive government funds for its enforcement." When forced to sit down by expiration of his time, Mr. Hill was attempting to read an extract from a pamphlet by the prohibition unit's publicity bureau, which said "the federal prohibition director of Arkansas had organized a campaign against moonshiners." This, he said, was issued last April, and printed. There was another flurry after the bill was taken up, item by item.

COLOMBIA GIVEN CHECK.
WASHINGTON, Dec. 7 (AP)—The United States yesterday gave the republic of Colombia a check for \$2,000,000, first payment under the \$25,000,000 treaty ratified in 1921 to cover certain damages incurred in the construction of the Panama canal. The payment was due September 30, but for some unexplained reason, Colombia was not ready to receive it until today. The balance of the remaining payments will be made yearly in five million dollar sums.

LIQUOR FIGHT FLARES UP IN HOUSE SESSION

Advocates of Prohibition and Opponents Stage Stormy Debate Over Dry Law Enforcement Appropriation

WASHINGTON, Dec. 7 (AP)—An old time liquor fight—short but stormy—flared up in the house today during debate on the \$115,000,000 treasury supply bill with its item of \$9,000,000 for prohibition enforcement.

Starting when Representative MaGee, republican, New York, a member of the committee which drafted the bill, declared that defiance of the Volstead law "was so prevalent as to threaten our institutions," it ended abruptly last after Representative Hill, republican, Maryland, a leader in the movement for light wines and beer legislation, had announced what he proposed to offer in the form of amendments when the prohibition section was reached tomorrow.

Dry Loose Barrage.

Meanwhile, friends of prohibition, overwhelmingly in control, have been shot after another at those who sought to attack the law and by parliamentary methods cut short Mr. Hill's attempt to amend the bill. He introduced in a friendly way with the Ku Klux Klan.

Urging congress to give to the states the right to say what alcoholic content would make wine and beer intoxicating, Mr. MaGee declared it would be the result in a beverage made from pure ingredients and the restoration of "wholesome respect for the law."

Declaring the liquor traffic had thrived on misery until the people had had it as if it were a serpent, had choked it, Representative Gilbert, democrat, Kentucky, shouted from the floor that he was getting tired of constant attacks on men who were trying to see that the law was obeyed.

The determined and vindictive, in the small minority that it stands out in open defiance of the Constitution," said Mr. Gilbert, adding that it was "backed by influential forces and that members of the house gave aid and comfort. Mr. Gilbert asserted that crimes which flourished in the barren days had decreased to the point where many jails in rural communities were empty.

Explains Amendments.

Half a dozen members were on their feet at once trying to break with questions when Mr. Hill, with six minutes to close the general debate, explained the nature of his amendments.

The first place, said Mr. Hill, above the hibbub. "I shall propose that the house strike out of the bill the \$150,000 for the prohibition unit's publicity bureau for the sum of from \$135,000 to \$150,000 as heretofore, shall not be spent hereafter in open violation of the Volstead law for the purchase of bootleg liquor to be used as evidence; that none of the government appropriation shall be used to subsidize the expenses of speakers sent over the country by the prohibition commissioner."

All the time Mr. Hill was being interrupted with questions as to whether he was trying to tighten the Volstead act.

"I shall also propose to strike out of the appropriation bill funds," he went on, "for legal advisers, special counsel to the prohibition unit, on the ground that the legal force does not know how to construe the law which exists today. Another amendment provides that no part of the fund proposed be used by the commissioner for propaganda purposes, in an attempt to defame members of congress, and finally, to transfer enforcement of prohibition from the treasury to the department of justice, where it belongs."

Speech at Klan.

Mr. Hill declared that anybody connected with the government "who approves the Ku Klux Klan should not receive government funds for law enforcement." When forced to sit down by expiration of his time, Mr. Hill said in a capsule to read a statement from a press bulletin by the prohibition unit's publicity bureau, which said "the federal prohibition director of Arkansas has reported that the Ku Klux Klan had organized a campaign against moonshiners." This, he said, was issued last April, and printed.

There was another flurry after the bill was taken up, then by Hon. The

word "alcohol" appearing in the list of the treasury's cleaning supplies, tied the house up again. Representative Blanton, democrat, Texas, contending that the word was not in the list, substituted, but failed. Then he tried to make it denatured alcohol, and Mr. Hill insisted it should read "thoroughly denatured." Both proposals were formally put to a vote on "throw out."

Getting about half way through the bill, the general theory of the amendment relating to the bureau of internal revenue, at the prohibition appropriation, when it quit work tonight.

"That kind of talk," he advised, "is induced by the patent leather hair, the short skirts and bobbed hair, but it is not godless at all."

"As a matter of fact, a religious indication points to a general uplift of standards, a general movement for the better that outweighs the sensational reports," he continued. "There never have been such fine relationships as there are in the colleges today. The young people in our colleges are the best in the history of the world, and the advancement of good sportsmanship—the desire to be a man, win or lose. There never was a time in the history of the world when standards were higher as regards inter-collegiate relationships or boys."

COLUMBIA GIVEN CHECK

WASHINGTON, Dec. 7 (AP)—The United States yesterday gave the republic of Columbia a check for \$5,000,000, the first payment on the \$25,000,000 treaty ratified in 1921 to cover certain damages incurred in the construction of the Panama canal. The payment was made on September 30, but some unexplained reason, Columbia was not ready to receive it until today. Under the treaty the remaining payments will be made yearly in five million dollar sums.

Ohio Woman, 83, Found Guilty of Forgery in Connection with Charge of Wholesale Frauds

POMEROY, Ohio, Dec. 7 (AP)—Mrs. Susan Kraus, 83 years old, who is alleged to have obtained more than \$300,000 from friends and neighbors on get-rich-quick schemes, last night was found guilty by a jury of uttering and publishing a forged document. She is liable to a sentence of from one to 20 years in the state reformatory.

Charged specifically with forging the name of her son, Michael Kraus, to a note for \$2000 given to Miss Lizzy Zytzler, Mrs. Kraus sought to show that she had permission from her son to sign his name. He said, however, that he did not remember having authorized her to use his signature.

Mrs. Kraus still faces five indictments charging forgery and one, embezzlement, and her husband and two sons also are under indictment in connection with the alleged acceptance of thousands of dollars on unsecured notes.





WASHINGTON, Dec. 7 (AP)—George Clemenceau paid his usual visit to the White House today, this time as the honor guest at a state luncheon presided by President Harding.

There was Vice President Coolidge, Chief Justice Taft, cabinet and other officers of the federal government, including Senator Henry Cabot Lodge of Massachusetts, chairman of the senate committee on foreign relations.

Clemenceau, president of the Versailles peace conference, and one of the authors of the "proposals" for agreement for the Allied States, Great Britain and France, and Lodge, leader of the senate majority party when the Versailles treaty was rejected.

Hollister Favored for Location of New Rural High School; Six Districts in South Part of County Unite

Formation of rural high school district No. 2 to compose the districts of Rogerson, Hollister, Berger, Amstar-Gardner, Haggard and Springvale, was announced Thursday after the county commissioners completed canvassing the vote on the question taken in the various districts November 22.

The first petition for the formation was filed by residents of the districts on August 20. Rogerson was the only district which showed any opposition to the formation of the district. The official vote of November 22, is as follows:

Rogerson, 10 in favor, none opposing; Hollister, 45 in favor, none opposing; Berger, 27 in favor, 20 opposing; Amstar-Gardner, 21 in favor, none opposing; Haggard, 19 in favor, none opposing; Springvale, 18 in favor, none opposing. The total vote was 155 for, the change and 20 opposing it.

The high school which, through the formation of this district will be made available to the students, will probably be established at Hollister, where a suitable building is available. Although the location has not been definitely announced, the appointment of the trustees of the district was held last Friday.

A large amount of legal technicalities must be met and an election will be called before the district is ready for permanent form, which will probably be next fall. The tax levy to support the school will be agreed upon by the trustees to be appointed and the levy will be taken only from the newly formed high school district. The project does not in any way affect the other schools of the county and they will be maintained as in the past.

GROWERS FAVOR LICENSE OF FARM PRODUCE FIRMS

State Meeting of Farmers Asks for More Potato Inspectors in Local Districts

Several hundred farmers, attending the annual conference of the Idaho Potato Growers' Association at Boise Tuesday went on record as favoring the placing of all produce dealers under license, and that inspection conference at each district. A point was made final and asked for the abolishment of the Bee-Omnibus license.

Apple growers asked for the privilege of including fruit affected by San Jose scale in the grade established by the state department of agriculture. Potato growers favored the continuance of the federal grade and asked that the state continue its inspection and maintain an inspector in each district. Some discussion followed on this subject and it was objected to as being too expensive.

Addresses on agricultural problems including fixing prices and car shortage and freight rates were given by C. C. Moore, governor-elect, former Senator K. L. Polk and E. M. Swendley, member of the state public utilities committee.

A large delegation from Twin Falls county attended. The conference was divided into four divisions, each of these appointing a committee to bring their farming needs before the state legislature. William Burton of Burley and H. J. Weaver of Filer were named on the committee to deal with pressing problems of the potato growers.

SEND HUGE SHIPMENT OF APPLES FROM PORTLAND

Consignment of Apples Rotted to England Would Cover Five City Blocks; New Dock Warehouse Under Way

It was said to be the largest shipment of apples to leave a Pacific coast port in one vessel will be taken on the Royal Mail steamer "Warrenton" from Portland to be landed in England the early part of January. The shipment comprises 125,000 boxes of the "Golden Wonder" variety, the "Golden Wonder" being produced in the northwest.

The shipment, it is said, would cover five city blocks and the boxes, packed and to be worked, would fill 20 miles. The new apple storage plant of the port of Portland will be ready about January 1 and will hold between 400,000 and 500,000 boxes. The new 60-foot pier to under construction and conveyors will lead the apples direct from the warehouse to the ships.

More than 40 persons entered the Bible class for laymen being conducted Wednesday evening by the Rev. W. W. Burkes, pastor of the First Christian church. The class was prepared by the Rev. ADD MORE CARS TO SHIP FRUIT

Pacific-Fruit Express to Have 5,000 More Available Early Next Year

The Pacific Fruit Express company, the carrying medium for the greater part of the fruit and vegetables of the northwest, has authorized the construction of 5,000 new refrigerated cars to be made available early in 1923, according to a communication from the company, received by Oregon Short Line railroad officials here.

The communication says: "The approximate cost of these cars will be \$15,000,000 and they are being built at the rate of 1,000 a month. This will give the Pacific Fruit Express company equipment of between 23,000 and 24,000 cars to be used exclusively for fruit and vegetable transport originating in the state of California, Oregon, Washington, Idaho, Colorado, Arizona, Texas and Louisiana."

"The refrigerator car equipment of this company is thereby increased by 12,000 cars, and the government control and at an approximate cost of \$37,000,000, in addition to which several million dollars have been expended for new and improved icing facilities throughout the country during this period."

"This action has been made necessary in order to meet demands occasioned by the growth of fruit and vegetable business in the sections served by this company as indicated above."

These children and their helpers will on Saturday canvass the city for dollar donations. The local quota has been set at \$1000. BUCK GOES TO OXFORD AS SCHOLARSHIP WINNER

Graduate of Twin Falls High School and Former Resident of Filer Benefits Under Rhodes Program

UNIVERSITY OF IDAHO, Moscow, Dec. 7.—Philip A. Buck, winner of the Rhodes scholarship for Idaho, a graduate of Twin Falls high school, is coming to the University of Idaho, majoring in economics and history in the college of letters and science. For several years he lived at Filer, but his parents moved to Monrovia, Cal.

Buck has been active in debating at Idaho, being a member of the Idaho team that debated against the University of Chicago at Boise last year. He also has been a leader in college dramatics and is credited with being the author of three original plays. While he has never been a member of a varsity athletic team he has been prominent in interfraternity athletics on the college campus during his student years at the University of Southern California.

Buck won the scholarship in competition with 250 other candidates. He will enter Oxford university, England, next October. Under terms of the will of Cecil Rhodes, he will have an income of approximately \$1,000 a year for three years, providing him with funds for summer travel on the continent, as well as for winter study.

The appointments of Rhodes scholars representing 32 states have just been announced.


