FAST RISING RIVERS TAKE HEAVY TOLL

Hundreds Flee for Safety from Rapid Advance of Flood in the Manitoba and Michigan Regions

ONTANAGON, Mich., April 20 (AP)—The Ontanagon river overflowed its banks today and the water was the highest in 40 years.

WINNIPEG, Man., April 20 (AP)—With many districts in central and southern Manitoba reporting a steady rise in the Assiniboine and Red rivers and tributaries today, the flood situation showed no improvement tonight.

Many families have been forced to leave their homes, others are isolated from nearby towns by changing a stage of water.

The most serious condition exists at Brandon, where hundreds of residents living in the section of the city now known as the flats, have been forced to vacate their homes, while others, virtually surrounded by the fast rising waters, are making preparations to get to safety.

STORY OF RAID IS TOLD

First Week of Trial of Ruthenberg, Charged with Criminal Syndicalism, Sees Progress with State's Case

ST. JOSEPH, Mich., April 20 (AP)—The first week of the trial of Charles Ruthenberg of Cleveland, charged with criminal syndicalism, ended tonight with the state's story of the raid on the communist convention at Bridgman last August virtually completed and the way paved for the prosecution's star witness, Francis Morrow, to take the stand.

Morrow, or "K-97," as he is known in the department of justice files, is a government agent who attended the convention as a delegate.

Indicted Klansman Causes Arrest of Hooded Trespasser

Captain Skipwith of Morehouse Parish Klan Charges Wrongful Use of Regalia

MONROE, La., April 20 (AP)—Winnic Carroll, a resident of the Bonita section of Morehouse parish, was arrested today on an affidavit sworn to by Captain J. K. Skipwith, exalted cyclops of the Morehouse parish Ku Klux Klan, charging trespassing on the premises of the Hustrup Paper and Paper company at Bastrop.

The company complained to District Attorney David I. Garrett yesterday that a hooded man with a gun on his shoulder had been prowling about the company's plant for several nights, intimidating workmen.

The Morehouse Klan officials disclaimed any knowledge of the affair.

Captain Skipwith said he asked for the arrest of Carroll because he was masquerading in the regalia of the Klan.

FLYERS SUCCOR MAROONED MEN

President of Wool Growers Points Out Importance of Industry as Factor in General Welfare

SALT LAKE, April 20 (AP)—Prosperity of a permanent nature and world-wide is predicted by F. J. Hagenbarth, president of the National Wool Growers association, in a statement here today on his return from California.

"Wool is selling for from 40 to 50 cents a pound," said Mr. Hagenbarth, "depending on the quality."

"I believe there are about 4,000,000 sheep in this intermountain country and these will bring at prevailing prices nearly \$15,000,000 for wool and about \$20,000,000 for lambs.

HARDING PLANS TO MAKE FIGHT FOR PROPOSAL

Counts on Explanation of Plan for American Membership in International Court to Rout Opposition

WASHINGTON, April 20, (AP)—Convinced that lack of information is responsible for much of the opposition to the administration plan for American membership in the permanent court of international justice, President Harding is understood to have decided to explain the proposal carefully and in detail at the first favorable opportunity.

The explanation contemplated by the chief executive, is expected to take the form of a letter or an address, more probably the latter. It is considered unlikely that the presidential announcement will be delayed until the proposed western speaking trip to start the middle of June.

Wood Reports Opposition

Some of the president's advisers are of the opinion that it should be made in the near future and this opinion became more decided after Representative Will R. Wood of Indiana, chairman of the republican congressional committee, during a call at the White House today asserted that the world court proposition had aroused more opposition among republicans in the middle west than the league of nations.

The president has accepted several invitations to make addresses, some of them only tentatively, within the next few weeks. A dozen or more additional invitations have been tendered.

The opportunities to obtain any detailed information the president might desire in connection with the preparation of a statement of the administration plan as submitted to the senate shortly before the adjournment of congress, were afforded today in conference held by the executive with Elinor Root, and Secretary Hughes.

Confers With Root

Mr. Harding was in conference for half an hour with Mr. Root, who was the single American who sat on the commission that drafted the statute outlining the procedure, membership and other details of the international court. The former secretary of state, after his conference, declined to discuss his conversation with the president beyond saying that he called to pay his respects, but it was assumed that the court proposal entered into the discussions.

The conference with Mr. Root was followed by a call at the White House by Secretary Hughes. It was considerable probable that Mr. Hughes may have delivered information on the world court proposal requested by the president earlier in the day at the cabinet meeting.

Sees Danger Ahead

Nothing developed after Representative Wood's private conference with his warning that continued advocacy of the court proposal by the administration would bring about a schism in the republican party had any effect on the president. Mr. Wood frankly said he detected no weakening on the part of the president and later in the day a White House spokesman, without mentioning the call of the committee chairman, said the executive received many visitors hearing pessimistic views and often was a "rather helpless victim" to their representations.

Mr. Wood on leaving the White House explained that the views that he had presented were purely personal ideas but added that scores of telegrams from republicans in cities and conferences held during a recent trip to Indiana had convinced him that he stood far from alone in believing that the court issue was freighted with danger to the solidarity of the republican party and to its success in the 1924 campaign.

HIGHER MARKET LEAVES LIMITED POTATO SUPPLY

Buyers Report Stocks Well Cleared Up as Result of Price Increases; Local Quotations Change

The recent increases in potato prices have resulted in the local offerings being disposed of in quantities, according to buyers, who state that the amount of potatoes on hand now is about the same as at this time last year.

Prices on No. 1 whites are quoted at 50 to 75 cents; bakerys at \$1.25, and 80 to 90 cents is the reported price paid on the few offerings of russets.

The local market, however, appears to be undergoing constant fluctuations and few of the larger companies are buying in any considerable quantities.

GET SUGAR BEET ACREAGE

Amalgamated Company Signs Up About 3,800 Acres Around Twin Falls; 12,000 for Other Factories

A total acreage of about 3800 on the Twin Falls tract has been signed up by the Amalgamated Sugar company for the local plant and will be delivered to the Paul and Burley factories, according to District Manager James Bellamy.

The company has paid \$6.75 per ton for the 1922 crop to date and farmers are sure to get at least \$1 more per ton for the past year's crop, it is claimed.

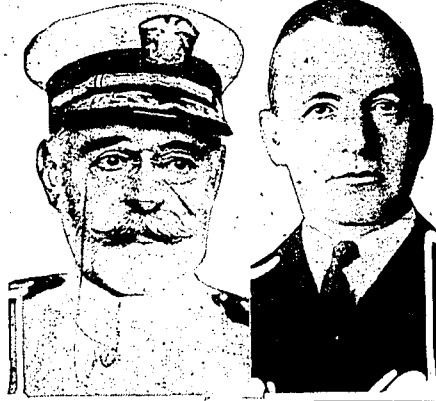

Admiral Robert E. Coontz, Chief of Operations of the United States Navy, has been designated to take command of the entire American fleet in both oceans, succeeding Admiral Hilary T. Jones. Admiral E. W. Eberie, now commanding the Pacific fleet, will succeed Admiral Coontz as Chief of Operations.

SEEKS DAMAGES FOR KIDNAPING

California Man Charges Former Governor of Samoa and Secretary with Abduction

CHICAGO, April 20 (AP)—Kidnaped in the south seas and held prisoner while his prison, the Sonoma, made various trips in the south Pacific, including Sydney, N. S. W., was the experience of Samuel S. Ripley of Richmond, Cal., according to papers in a \$30,000 damage suit filed by him today against Wally Evans and W. A. MacDonald of Lake Bluff, Ill.

Evans was formerly governor of the island of Samoa and is now commandant at the Great Lakes naval training station, according to papers in the suit. MacDonald was said to have been Evans' secretary at the time the latter was governor of Samoa.

Ripley left San Francisco on the ship Sonoma for Samoa on August 1, 1921, to inspect property there owned by his parents, according to the bill. The steamer arrived in Pago Pago, Samoa, two weeks later when Ripley deposited \$100 with the ship's purser as customary.

As he was about to leave the ship, MacDonald and a man who said he was A. Dabell, collector of customs, but who Ripley asserts, is Wally Evans, arrested him, he alleges, without cause and demanded \$100 from him.

Despite his payment of the money, the declaration continues, he was kept in custody on shore until passengers had left the ship and then, still a prisoner, he was taken aboard again and kept prisoner until the ship sailed. After 30 days he finally managed to escape from the ship at Honolulu and made his way back to San Francisco after an absence of seven months.

Ripley's attorneys said the affair probably resulted from some personal differences between Evans and Ripley.

FILM ACTRESS BANKRUPT

Juanita Hansen's Fears of Financial Ruin Following Arrest on Narcotics Charge, Soon Realized

NEW YORK, April 20, (AP)—Juanita Hansen, screen actress, who predicted when she was arrested last January on a charge of possessing narcotics, that her "career would be ruined by this frameup," filed a petition in bankruptcy today. She listed liabilities of \$11,058 and no assets.

Miss Hansen asserted at the time of her arrest that she had been cured of the drug habit, which she contracted at Hollywood, Cal. A magistrate dismissed the charge.

A Plain Public Statement

In the mayoralty campaign just closed by the election of Mr. Hodgkin, there were only two issues presented, these were:

GRAIN TRADERS GIVEN LIBERTY WITHIN BOUNDS

Department of Agriculture Denies Intention to Put Exchanges Out of Business or Hamper Legitimate Activity

WASHINGTON, April 20 (AP)—The department of agriculture issued a formal statement today declaring that trading in grain futures would not be interfered with by the operations of the grain futures act, upheld by the supreme court, so long as the exchanges complied with the law. Several exchanges, the statement said, already had met the requirement and the Chicago Board of Trade had announced its intention to cooperate in enforcing the regulations.

"Reports that this law will put the grain exchanges out of business or interfere with the legitimate functions are entirely without foundation," said the statement. "It does not interfere with hedging transactions on the boards of trade that receive designations as contract markets. Neither does it interfere with ordinary speculation in the buying and selling of contracts for future delivery on such markets."

"It, however, there should be evidence of undue manipulation, or attempts to corner the market, or of the dissemination of false or misleading information about crop or market conditions by members of the exchanges, such conduct would be required and promptly dealt with as required by the law."

"The law gives authority to observe and inquire into the operations on grain exchanges and to speak with authority concerning such matters."

EGYPT DECLARES FREEDOM

Constitution Signed by King Fuad Asserts Independence; Oath for Obligatory Education of Both Sexes

CAIRO, Egypt, April 20 (AP)—The Egyptian constitution signed by King Fuad declares the country to be a sovereign state free and independent, succession to the throne shall be hereditary in the family of Muhammad Ali. All the official religion shall be the Islamic, and the official language Arabic. One article provides for the obligatory elementary education of both sexes, to his provision, free of charge in public schools. This marks a great educational stride, especially in the case of the girls.

Bandits Lock President and Assistant Cashier Into Vault and Escape in Automobile with \$3,000 in Currency

OKLAHOMA CITY, Okla., April 20 (AP)—Two masked bandits today forced J. E. Sackel, president, and Fred Knowlton, assistant cashier of the bank of Winters, near here, into the institution's vault and escaped in an automobile with about \$3,000 in currency.

WIVES OF "WITCH DOCTORS"

Important Personages Among the Wild Tribes of New Guinea Remarkable for Cleverness.

In the New Guinea islands when a man is ill and has been reduced to a state of delirium, the witch-doctor arrives, an old man with matted hair and an exceedingly dirty skin. Around his neck he wears a collection of oddities, consisting of bits of crystal, pointed sticks, human bones, and perhaps some native incense. Around his loins he sometimes carries a second bag with a supplementary supply of these valuable articles, and, some where he is sure to be concealing stones and pieces of glass which he is going to charm out of the body of the sick man, writes H. W. Clemen, in Asia Magazine.

The sorcerer proceeds to examine the patient with elaborate ceremony and then announces to the anxious relatives that it is just as he expected; certain stones have been wished into the man's body by a neighboring magician or some other evil agency. Bending over the sufferer, he begins to mutter long incantations and to rub vigorously. Sometimes he is a skilled masseur, and uses a hot stone wrapped in bark, to knead the sore muscles. By this treatment he frequently relieves the rheumatic pains which accompany so many infections. Some time during the course of his message, he produces one of his stones or fragments of glass, and the sick man, if he be conscious, generally experiences great and immediate relief.

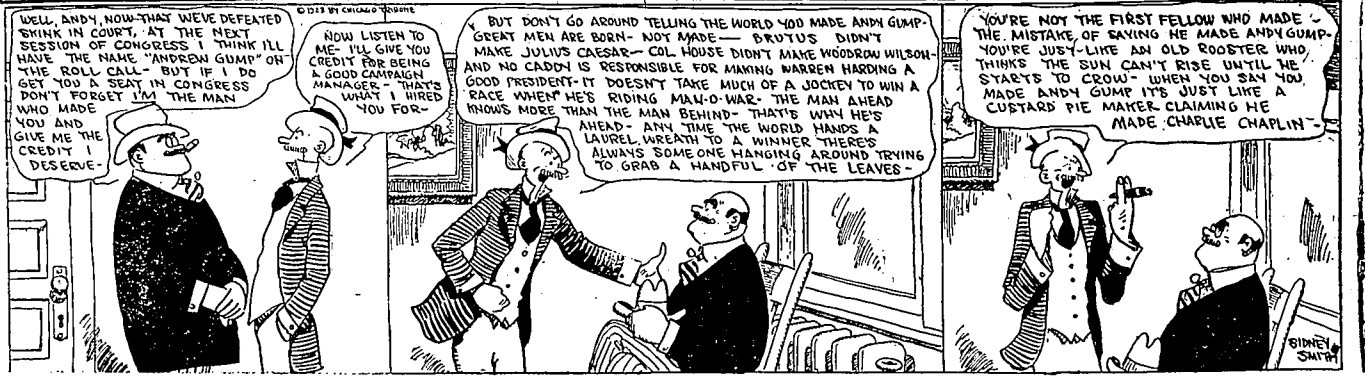
