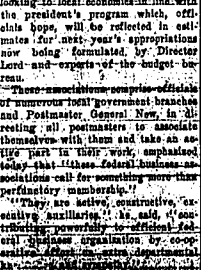

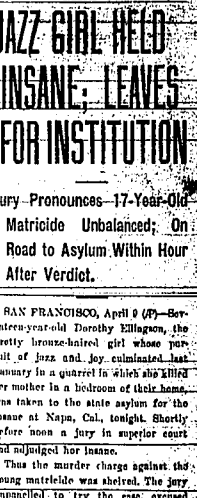

Crucifixion to be Commemorated in Many Twin Falls Churches Today With Appropriate Exercises.

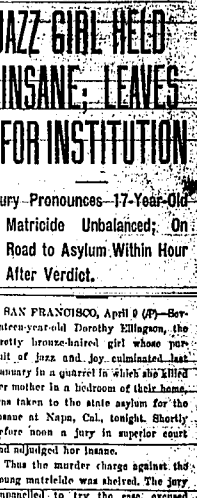
Good Friday commemorating the crucifixion of Christ, is to be observed today with appropriate services in several Twin Falls churches.

Members of Scottish Rite From All Southern Idaho Meet Here for Ceremonial.

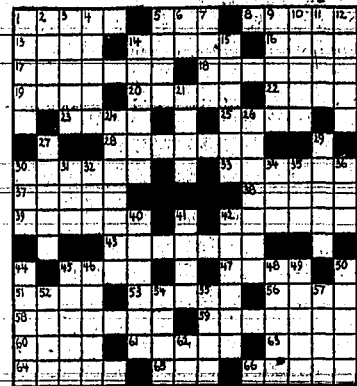

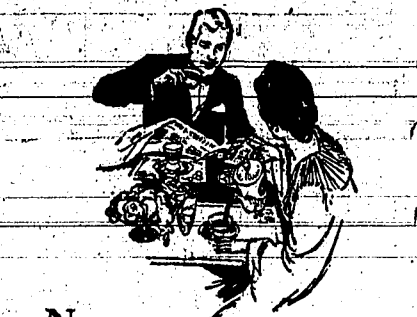

WORK ON FARMS WELL IN HAND

Weather Bureau at Boise in Preliminary Report Summarizes Conditions.

In lower agricultural valleys of southwestern Idaho all reasonable work is well in hand, according to a preliminary report for the season of 1925 contained in a weekly summary of weather and crop conditions in Idaho just issued by Clinton E. Norquest, United States weather bureau chief at Boise. Regarding conditions in southwest Idaho the report states: A considerable portion of the winter-tolerant small acreage of winter wheat sown in this district was winter killed. Clover also suffered heavily. Alfalfa, in the north, came through its fall to good advantage although the rains spoiled in many fields. Whether these are due to winter killing or have resulted from the heat and drought of last summer, it is difficult to determine. There can be no doubt that fruit-trees were damaged by the unusually low temperature experienced in December. Peaches, apricots and sweet cherries were hardest hit, though by no means a total loss in all commercial orchard districts. Apples, pines and some cherries suffered less.

In a few localities cattle are reported thin because of scarcity and high price of feed, but for the most part there have been no serious losses to the stock. Sheep, where properly cared for, have wintered well. Early lambing was carried on under fairly favorable weather conditions with satisfactory increases.

In the lower agricultural valleys the frost went out of the ground early, making it possible to begin field work in good season. The ground had been deeply frozen and moisture had penetrated well. As a consequence the soil has worked up in excellent condition and seed beds have been fitted with a minimum of effort. All reasonable work is well in hand. In the high districts the fields are still snow covered and no field work is yet possible.

Southeast Idaho.
Due to its elevation much of this portion of the state is still under snow cover and it was not possible to determine the extent to which winter wheat has been damaged, if at all. Over the southern half of the district spring wheat advanced from the first to the second stage in two or three weeks ahead of normal. In this section winter wheat suffered considerable damage. Other crops in the area indicate that in spite of the hard winter cattle and sheep have come through in very good shape. Winter pastures are in excellent condition, so far as present moisture conditions are concerned, are good.

North Idaho.
The crop season has opened up in fine shape. Weather conditions in February and March were such as not to interfere seriously with seasonal farm work—mowing, plowing and fitting of the soil was accomplished in the early districts. Spring seeding was finished in good season. Just now there is some complaint that the soil is dry and hard, due to the drying winds and lack of rain, but field and orchard work is generally very well in hand. The extreme cold last December caused considerable damage to crops in some localities. Winter wheat is particularly affected materially, both from frost-killing and from leaving the loss amounting to as much as 40 to 50 per cent in some counties. There was some winter killing of alfalfa also, the loss being approximately in the same ratio as the loss of wheat. Damage to fruit was not so severe as was at first supposed. However, there was some loss, not only of fruit but for this season's crop, but also of young trees. Peaches seem to have suffered most, than pears, cherries and apples, in the order named. Cattle have come through the winter in only fair shape. In the sections the high price of feed tended to make thin stock. Winter precipitation was quite favorable and prospects for abundant feed on the range are very good.
