BATH OF OFFICE TAKEN BY MAYOR AND COUNCILMEN
E. L. Ashton, R. B. Smith and T. J. Douglas Assume Duties; Leslie Relieved of Police Department.

Mayor-elect E. L. Ashton and Councilmen Robert E. Smith and T. J. Douglas were sworn into office Monday evening at the regular weekly meeting of the city council which took up as the first order of business under the new administration the rearrangement of the duties of the various offices and of the mayor. With the exception of taking the police department out of the hands of V. L. Leslie, commissioner of public safety and placing it in the hands of the mayor, the other rearrangement will be up before the city council during the next administration. With Mr. Smith, assuming the duties of street commissioner and Mr. Douglas those of commissioner of parks and public grounds and having the retiring councilman and mayor resigning their last session with the reading of the report of the chief of police for the month and the passage of routine bills.

Born in By Meo
When this work was completed City Clerk J. L. Meo administered the oath of office to Mayor Ashton and Commissioners Smith and Douglas who then took their places at the council table while Mr. Ashton, street commissioner and Mayor Hodgkin stepped down. When the new members assumed their seats the new councilman, Mr. Meo, reading of a proposed resolution defining the duties of the commissioners. The resolution was adopted and the council then adjourned until the next meeting. Mr. Meo is an able police commissioner. It was unanimously agreed by the council that Mayor Ashton should have charge of the police. Under the new system J. S. Reed will continue as commissioner of public safety; W. T. Leslie as commissioner of public safety with the care of the police department; T. J. Douglas as commissioner of parks and public grounds and R. B. Smith as commissioner of streets which includes the water department. Mayor Ashton is to be head of the department of public affairs.

No Appointments Announced
No appointments were announced at the meeting Monday. Mayor Ashton announcing in response to an inquiry as to whether changes would be made, declared that he had no intention to make at the present time. He said however that in all probability he would be ready to resign in a moment for the next regular meeting of the council.

Members of the city planning commission were present and praised the work done by city engineers in removing the rubbish from alleys but declared that they believed the engineers should be left on their feet to finish the work. This was agreed to by the council. The matter of a storm sewer was then taken up and before the council it was agreed that the city engineer should make surveys as to the advisability of driving a tunnel from Hook Creek to the lowest spot in the city so that storm waters might be drained off. Whether the sewer should be taken care of from waters and drains would be better than the construction of a storm sewer. Cost of such a storm sewer and tunnel will be taken up by the council when figures are available from the city engineer.

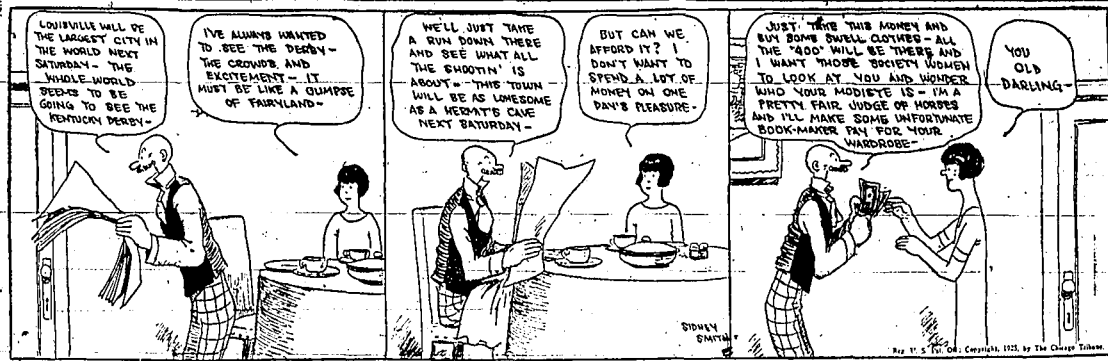

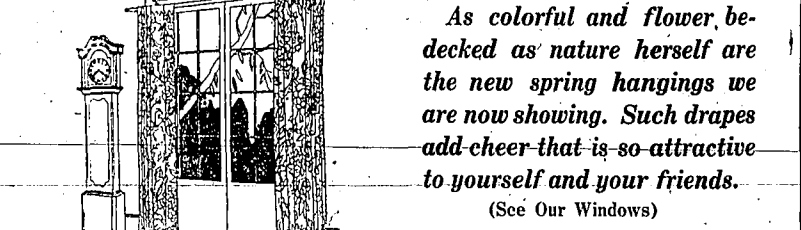

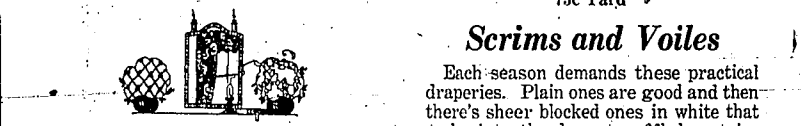
