MANY AVIATORS FAIL TO BREAK FLIGHT RECORD

Shade of John Rodgers Smiles Encouragement on Former Mates as They Contemplate Result of Recent Attempt.

(By The Associated Press.)
WASHINGTON, Nov. 25.—The shade of John Rodgers smiled and encouragement today to his former mates as they rested and contemplated their future to write a new chapter to the annals of new aviation.

The feat of the valiant aviator who had 15 months before had his eagle wings beat the Pacific flight through haze and low clouds to a record of the fastest of 1811 miles from the starting point to 8111 miles before a six engine biplane left the island of Kauai, remains the greatest non-stop performance for any flier in P.N. planes.

Two P.N. aviators, improved in design and construction over those which Rodgers and his companions flew, were shown today by the pilots of the flight.

Friday's non-stop attempt was expected to take 2000 miles from Hampton Roads, Virginia, to Colon, Panama.

All Hands Safe

That of Lieutenant Commander H. T. Bartlett, the P.N. No. 2, was taking inventory today of her flight, at 8 a. m. going back to the P.N. No. 1, which was leaving the voyage. Bartlett, with Lieutenant H. T. Bartlett and C. E. Schellhaas, and aviator chief mechanic J. M. G. Jones, were seen at Newport News, Va., at 6 a. m. on Saturday, their only supply exhausted.

Manning Declares Marlborough Suit Discredits Church

Bishop Characterizes 'Whole Proceeding' in Annulment of Vanderbilt Marriage as Injury to True Religion.

NEW YORK, Nov. 25 (AP)—The "new preaching" of the annulment by the Catholic church of the marriage of the Duke of Marlborough and the former Consuelo Vanderbilt "is a discredit to the Christian church and an injury to religion," said Bishop Manning Monday at the cathedral of St. John the Divine today.

The bishop's statement took the form of an extended message to the flock of New York, in which he said "of marriages are to be dissolved and void in places as moral as this, no marriage, and no home, can be regarded as safe."

"That any woman of middle age, after years of married life should be willing to swear that her parents sold her for worldly gain and against her will, is in itself a scandal, and the more so when one of the parents is no longer here to deny such a proposition."

"The whole proceeding is a discredit to the Christian church and an injury to religion. It has done more than this by revealing to the world the sin of polygamy."

"At this time when so many industries are at work which threaten to destroy Christian marriage, the outbreak is indeed if the Roman Catholic church is to take such acquisition as this done represents."

TRIAL WAITS ON COURT DECISION

Vital Point at Issue Must Be Settled Before Government Counsel Can Proceed.

WASHINGTON, Nov. 25 (AP)—One of the vital points at issue in the trial of Edward L. Bremer and Albert R. Kelly awaits decision in the District of Columbia supreme court tomorrow before the government can proceed with the production of evidence by which it hopes to prove the ill-gotten and the former secretary of the interior guilty of conspiracy.

The question is whether the record of the so-called letters, containing the testimony of Bremer that he advanced \$100,000 while negotiations for lease of the Elk Hills reserve were progressing should be admitted as evidence. Counsel for both the government and the defense have advised that they consider the ruling of the court on this point to be of the utmost importance.

Attorneys Lay Groundwork.
Groundwork for the prosecution of the Bremer case was laid Wednesday, after a brief appearance of the witnesses stand by Senator Walsh of Montana, who called the senate committee meeting at which Bremer made his disclosure. But when the government of evidence is admitted, an emphatic objection was raised by the defense, and the question was now made to the court when arguments as to its admissibility will be continued.

The defense holds the law prohibits the introduction of testimony before a congressional committee in a criminal proceeding if the defendant was the source of the evidence. This contention was advanced in the brief period of argument before court adjourned yesterday for Thanksgiving.

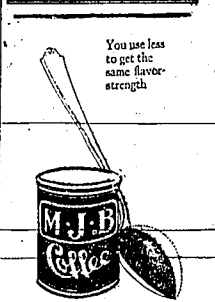

CHICAGO CENTER OF WORLD GRID

Not Only Army-Navy Game Host, but Also Convention Site of Big Ten Directors.

CHICAGO, Nov. 25 (AP)—All of the excitement in Chicago tomorrow will not concern the arrival of the cadets and the midday football game, but rather the big game of the gridiron season. The athletic directors of the big ten and the football coaches will meet here today to discuss the two-day session to arrange their 1927 schedule, and indications were tonight that a visitation of the city will develop over new forms expected to be presented.

The directors will consider a proposal that each university should have a campus to play at home and the other to play on the campus of the opposing school on the alternate days. Under such an arrangement, for example, the Michigan-Minnesota game would be played at Ann Arbor and at Minneapolis on the same day. This proposal has the endorsement of President Clarence Cook Little of the University of Michigan who believes a change in the present system is imperative.

Demand for Action Grows
There is a persistent and growing demand for some sort of compromise action to make various members of the big ten meet each other in football. The rotating schedule proposed two years ago and voted down will come up again tomorrow.

Minnesota is strongly in favor of a compromise method to make other teams play the Gophers, who claim they have been shunned by several conference universities.

Fewer intercollegiate games probably will be arranged for 1927 because of the demand for more games within the conference. While the football coaches and athletic representatives who schedule the faculty representatives will meet to consider expanding the big ten to the big twelve by admitting Notre Dame and possibly Nebraska or Michigan State. It is considered certain that the conference will not be enlarged as at least one is regarded as too uninvited. Coach Knute Rockne of Notre Dame is silent upon the question of possibility of Notre Dame's entrance.

The Reichstag today adopted a resolution intended for the middle parties, which include Bavarian peasants, German Socialists, economic party, Bavarian people and German nationalists, requesting the government to inquire into the possibility of making the world court to investigate the question of war guilt.

Only the socialists and communists voted against the motion.

German foreign policy under the guidance of Gustav Stresemann, which throughout the summer and autumn has sought to bring about a settlement without parliament's participation, met with overwhelming approval. The policy has a feature—reconciliation—beginning with France. In a vote of non-confidence in the foreign minister's policy, only the extremists of the right and left, namely the fascists and communists, voted against the government, which was supported by the other parties by a strong vote.

Even the German nationalists who in the past had proclaimed unfriendly opposition to the League of Nations and their arrangements, remained passive and abstained from voting.

Senator Marconi and his wife obtained a civil divorce at Fiume, their being the last case noted on under Italian law before the city was annexed to Italy. Later the former Signora Marconi married the Marquis, with whom she lives at his magnificent villa at Spilimbergo.

Beats Press Statement

The inventor tonight categorically denied the statement published in an Italian newspaper that he had discussed the annulment question during his audience with the pope yesterday.

The audience, he said, was occupied almost entirely with scientific subjects, the pontiff taking the keenest interest in the latest radio developments.

Marconi also denied the declaration that he had instituted the annulment proceedings because he desired to marry a young English girl who has been negotiating for his hand for some time, as well as a rumor that he intended to marry a Roman society woman.

DOUGLAS COMPANY BEGINS DELIVERY OF PLANES TO GOVERNMENT OF MEXICO

SANTA MONICA, Cal., Nov. 25 (AP)—Three of a squadron of eight new Douglas airplanes built for the Mexican government by the Douglas company here, left today for Mexico City.

The planes were delivered to the field and were being placed in readiness to take the air. They are the first modern American airplanes built for the Mexican government, local aviation authorities declared.

They are of the observation type and Mexican officers here suggested that they would be converted into bombing planes by the installation on Mexican soil of machine gun and bomb racks.

Information as to the exact destination of the planes was not given out by local aviation men who contracted with the Mexican army fliers said that their understanding was that the planes would be placed in immediate readiness for use against the English.

These planes are built along similar lines to the American army bombers which circumnavigated the world.

About 200 Spanish engineers and technical experts will arrive the day after tomorrow to assist in the industrial activity in response to a Moscow invitation.

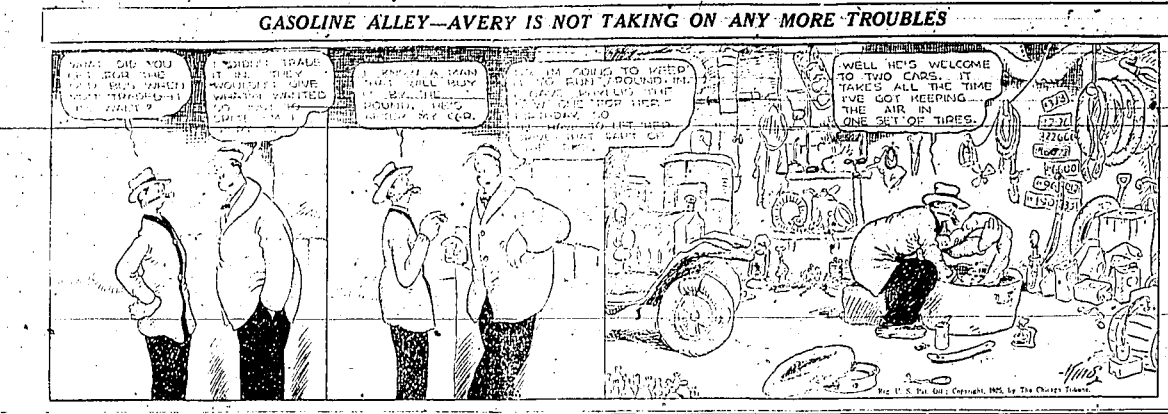

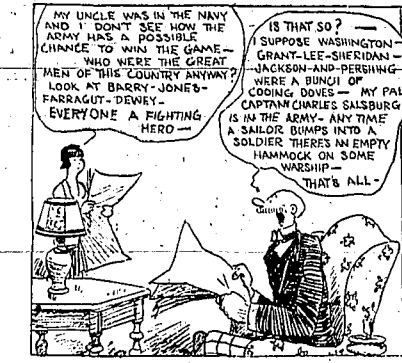

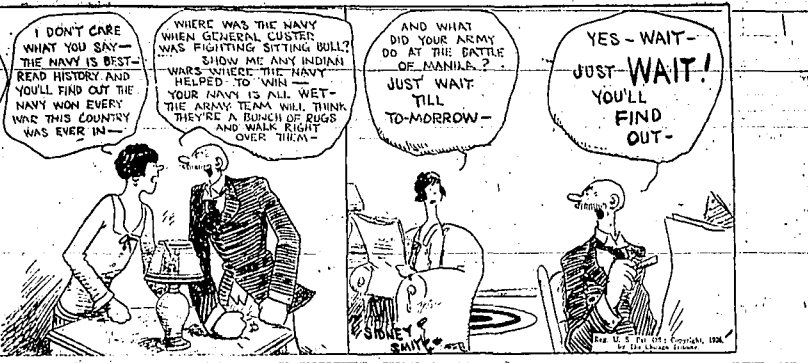

Rev. E. C. Barton, in Sermon at Union-Thanksgiving Services, Points Way to Goal of Desire of All Humanity.

World peace will come when every person in the world has made his peace with God. As long as five-sixths of the world has not made his peace with God, how can we expect peace among men? It is a Utopian dream, human philosophy is continually giving things that are not things, and no world which has not been evangelized is not a league of nations but a league of nations.

Shows Dark Side. Quoting his own words of St. Paul, "I have hated, whatever my outward appearance, to be content." Mr. Barton referred to his own life as a boy, a student of the Christian church, and as a minister of the gospel, and as a man of letters.

Ancient Psalmist's Question Topic of Holiday Sermon

The ancient psalmist's question, "What shall I render unto the Lord for all his benefits toward me?" was the text of the sermon delivered by the Rev. John Gilchrist, pastor of the Christian Science church, in his Thanksgiving day service Monday in the Lutheran church here.

The outstanding blessing for which we all are indebted to God, the speaker declared, "are his mercies, and his love, and his goodness." "Handily confounding our own sins and those of our nation, we praise God who has bestowed manifold blessings upon us, purely out of fatherly divine goodness and mercy, without foresight or recompense to us." Let us also thank God for the spiritual blessings that during the year 12 months we were permitted to hear and word which is able to save our souls. You, even in days of affliction, of sickness and death, of losses caused by fire or famine, had or were spared from, we are comforted by God's word and promises, all things were rendered for good to them that love God, and whom the Lord loveth he chasteneth.

"Now the question, 'What shall I render unto the Lord?' means the money? Money is by no means the only thing which is to be given unto the Lord. The Christianian Christian, before giving money, first of all gives their own selves to the Lord." "When you ask, 'What shall I render unto the Lord?' it means the will of all give yourself to Him—the health and strength and abilities of your body, the power of your mind, your soul's love, affection, devotion. Having thus given yourself to the Lord, you will naturally and cheerfully also give your earthly possessions to His feet."

"But no man can in great degree, if I am not giving to the Lord, what will become of my family? Next, less fear. This, too, Christ has said, 'Seek ye first the Kingdom of God, and these things shall be added unto you.' The Jews were commanded to give first fruits of field and flock into God's house, where it is evident that the needs of the poor should be considered in the first, not in the last place. Nevertheless the Jews, adhering to God's command, brought in all their tithes and offerings (tithing) into the Lord's house, besides the church, family and state are also God's property."

"When you, a Christian father and mother, provide your family with the means of life, are you giving them gold and money and personal service to the Lord, whose will you are fulfilling?" "When you, my Christian fellow citizens, pay your taxes, you are giving to the Lord, who remunerates, I tender therefore unto all their dues, that is to whom I owe it, custom to whom—custom!" "When, moved by the love of Christ, you help the sick and help the needy, you are giving your love, sympathy and personal service to the Lord, who commands, 'Do good and to communicate freely.'"

Significance of Thanksgiving Day Theme of Sermon

Significance of Thanksgiving day as a national institution was emphasized by the Rev. Ioni S. Revere, pastor of St. Edward's Catholic church, in his Thanksgiving day sermon delivered in services Thursday morning.

"Once more this nation," Father Revere said, "stands before the president of the United States and the governors of the several states of the union, and observes with glad hearts the public manifestation of the religious belief of a nation in a solemn and patriotic manner." This public manifestation of the religious belief of a nation in a solemn and patriotic manner is not only in that they stand before the very statue of human society and acknowledge that man's higher nature, but because it is most useful as a means to bind its citizens together in the pursuit of a common and religious duty and in the strengthening of the foundation of private and public morality.

Duty to Acknowledge Dependence. As it is the duty of the individual man to proclaim in word and deed his total dependence on the God who made him and that deity is later affected, when he merges his individual life with another within the sanctuaries of the home; so it is the natural duty of the community, as the aggregation of many families, to acknowledge in a very special way its dependence on the generous favor of the Most High.

For the needs of the state are more manifold than those of the family; its front of government is more intricate and its duties are as varied and multiplied as the number and the condition of its citizens. Its laws must be framed for a common good, its borders protected from unlawful aggression and its resources exploited and distributed with wise equality and for the benefit of all the people.

Now since the state with its proper spheres stands committed to the task of procuring for all its citizens the realization of their temporal happiness, it must, in the first instance, secure the abundance of its lands, the exploitation of its natural resources and the successful growth and expansion of its legitimate commerce—that it fail to recognize the sunshine and the rain, the fertility of its soil, the riches of its minerals and the products of its agriculture, as factors of a prosperity whatsoever nature's gift has bestowed it, and if this land is great in all these things greater than any other nation on earth, then it is clearly the duty of America to take the lead and stand in its strength, to honor the praises of its heavenly creator in the God that who has blessed it as He has blessed all.

Battle Cry Should Be Prayer. "For Alms and Hearthings" is the bathery of a nation; it should be the gift of its citizens as well. This sacred duty of public thanksgiving and prayer furthermore binds our citizens with closer ties of religious sentiment and mutual devotion. We do not need more internal devotion, we do not need more spiritual vigor. We do not need more moral power. We do not need more social improvement. We do not need more national unity. We do not need more religious fervor. We do not need more things that are seen; we need more of the things that are not seen.

The dangers of our times are not found in the scientific or mechanical. Our evils are not mechanical but moral. Philosophy reverses Order. "Human philosophy is continually giving things reversed. The world is upside down. World as we know it, come when the world has made peace with God. Man's chief business is not his foreign policy, but that every man in the world has peace in God through Christ."

If there were to be peace in the world, there must be peace in the individual hearts in that home. As long as five-sixths of the world has not made peace with God, how can we expect peace among men? It is a Utopian dream. Legislation and diplomacy have exhausted themselves in trying to reverse God's plan of bringing about a brotherhood on the earth.

Step Toward Peace. "When we Christians stop relying on demagogues and unbecoming philosophy and take God as our only teacher from the first commandment first, we shall have gone a long way in bringing about universal peace."
