PRESIDENT COOLIDGE DISAPPROVES BRITISH PROPOSAL AT GENEVA

Chief Executive Will Not Agree to Construction of Greater Navy; New Terms of English Delegation Are Unacceptable.

By The Associated Press. RAPID CITY, S. D., July 29.—Word of Great Britain's reported Geneva naval armaments conference call for a larger navy than President Coolidge will sanction.

This is the main obstacle in the conference in the opinion of the president, who will not agree to a program calling for construction of a navy which has been had, the conference would bring about an understanding for reduction of armaments.

Still Hopeful. Still hopeful that further discussion may bring about modifications in the British proposals, Mr. Coolidge is plainly determined not to accept the terms presented by the British delegation.

More important than would be the development of peace, good will and better understanding among the nations which in turn naturally would aid in the reduction of armaments and in the furthering of peace.

Disagreements in the conference upon tonnage of cruisers and battleships are considered by Mr. Coolidge as only collateral to the main issue of the size of a navy which England would require this country to build up its proposals.

At the executive office it was reiterated today that the president has rejected no decision on the revision presented to him by President Massey of Cuba "but that Coolidge is very early next year when the Pan-American conference assembles there. He understands that a treaty involves the desirability of a treaty which is based on native soil but thinks that this may not prove too serious an obstacle.

Lived Abroad. Mrs. Pulitzer had lived abroad much of the time during the latter years of her life as her health necessitated frequent taking of treatment in both France and Germany.

Married in 1874. The charming Kate Davis, daughter of Judge William Worthington Davis, and Catherine Lee Washington, married Joseph Pulitzer in the Episcopal church of the Epiphany, Washington, D. C., on July 11, 1874.

BITTERNESS BETWEEN FRANCE AND GERMANY GRADUALLY VANISHING

European Nations, Once Enemies, Dispelling Enmity; Mental Divergency Gulf Slowly Being Spanned, Says Italian.

By The Associated Press. WILLIAMSTOWN, Mass., July 29.—"The bitterness between France and Germany engendered by the Versailles treaty is disappearing and a rapprochement between these states is developing which promises a stable European peace," said Carlo Sforza, Italian diplomat, said today in an address before the institute of politics.

The rift between France and Germany, he said, had its deepest cause in their mental divergence, a gulf which is being slowly spanned. He branded as militaristic.

In the years following the war, Sforza's opinion was, "France was surrounded by an isolation that was painful to her and notwithstanding all her deeds, shepherds still attempt to perpetuate the world as militaristic."

"This what was really her effort to strengthen and fortify her victory at all points, which the world mistook for aggressive militarism, was in reality only the French impulse of self-defense," the speaker declared.

CHICAGO YAWALKERS

Chicago, which is always on the move, is going to move with more precision in order to make better roads.

The present effort is directed especially at pedestrians. They are being given a thorough of the streets after which they will be required to "lay their feet" and "stamp the road" as the yawwalkers will be able to measure as high as one hundred feet.

Apparently the two accidents have this in common—the passengers lost their heads.

It is all too apparent to anyone familiar with the behavior of boats that the thing which caused the "Favorite" to sink was the fact that the passengers could not be prevented from plunging to the side of the boat.

One sympathizes with the desire of Chicago people for fresh air and cool breezes and it is easily to be understood how mothers and tiny children would welcome an opportunity for a rail on the lake, but the dangers of the "Favorite" are too numerous for this and sometimes the thought suggests itself that the sandy beaches, which form part of Chicago's waterfront, are after all the safest places for mothers and children.

EASY LION-HUNTING

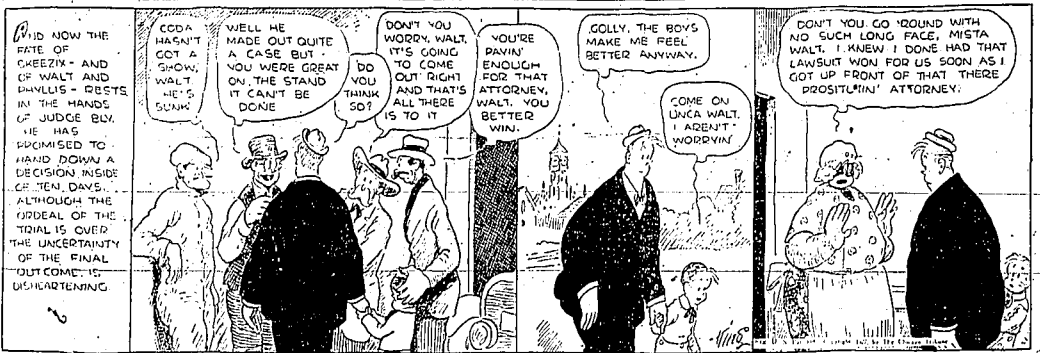
