TRAIN'S HALT UNDER RIVER IN NEW YORK INJURES 8 PERSONS

Grounded Third Rail Causes Stampede 30 Feet Beneath Stream Bed and 35 of Passengers Enter Hospitals

(By The Associated Press)
NEW YORK, Dec. 20.—Eighty persons were injured today in a stampede when a crowded subway train, speeding through a tunnel 30 feet under the bed of the East river, was halted by a grounded third rail. Thirty-five of the injured were taken to hospitals.

All of the 80 were suffering from inhalation of smoke from burning insulation on a conduit, and many had been trampled and cut as they beat with their fists against windows and doors in their frenzied attempts to get out of the train.

At no time were they in any particular danger from the burning insulation, which was blown away by a repair crew which worked rapidly at work on the conduit and had dropped back on the train's approach.

In their terror, however, the passengers would not listen to guards and a policeman who was one of the passengers. They broke the windows, and clouds of smoke came into the train.

To quell the frenzy inside the cars the guards had to open the doors before the current was off, thus adding to the danger of electric shock by the third rail.

Some of the passengers made their way all the half mile back to Queensboro Plaza. Long lines of people were not out through the emergency exit to Welfare Island. All of those who could be controlled by the guards were taken to another train heading toward Long Island city, and taken out without further difficulty.

The accident occurred as a Brooklyn-bound train, packed with office workers, early morning Christmas shoppers and passengers whose bundles were traveling back, started to pull away, leaving down for the tunnel shortly before 8 A. M.

Winter Blankets Highways Over Galena and Trial Creek and Traffic Halts

EMMETT MAN FACES CHARGE OF MURDER

John C. McClurg Must Answer in District Court for Death of Young Wife

EMMETT, Idaho, Dec. 20.—John C. McClurg, real estate and automobile salesman, was today on a charge of murdering and burning his wife, Mary, 21, on Decker.

The body of the girl was found, buried almost to ashes in the remains of the McClurg car after it had plunged over a steep grade on the road between Emmett and Caldwell. McClurg claimed the death was accidental, that the car got out of his control and he leaped to safety after calling to his bride two months to do likewise. After the accident, he said, he was arrested and two miles to his wife's home to ask assistance in rescuing his wife from the flaming car.

PANIC REIGNS OVER CALIFORNIANS WHEN BLAZE SWEEPS PARK

Clouds of Smoke Billowing From Brush Fire On Mile-long Front of Spread Fall Over Los Angeles District

(By The Associated Press)
LOS ANGELES, Dec. 20.—A brush fire, racing over the dry hillsides of beautiful Griffith park on the edge of the city before a 30-mile-an-hour wind, three residents of the exclusive Los Feliz district into a panic today, burned one frame and was hurried to a standstill by thousands men after five hours of frantic effort.

In the confusion attending the blaze five men were injured, one probably fatally. In traffic accidents as well as visible fire apparatus in the city was sped to the scene by a tire alarm call.

When the motor was ready Darby signaled the volunteers to get on. Combe did not hear the warning and soon found himself clinging to the tail.

Unaware of his predicament, Darby flew his craft for the seven-mile distance between Moorestown and Camden at an altitude of 1,000 feet. As the plane leveled to make the landing the boy jumped and rolled over several times. He was taken to a hospital where it was said he suffered only a shaking-up.

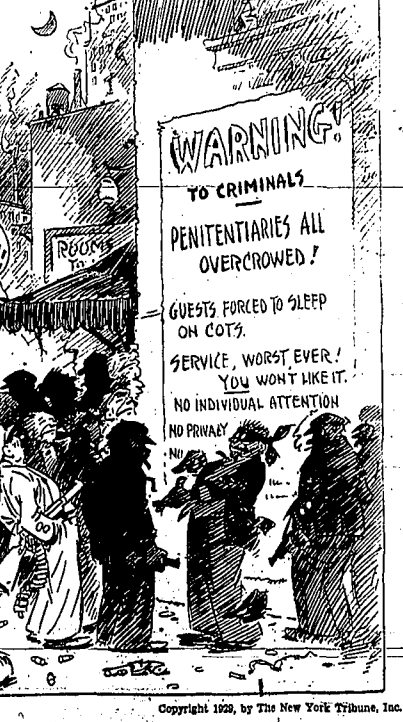

SOVIET AMBASSADOR ARRIVES IN LONDON

LONDON, Dec. 20.—Soviet Russia and Great Britain today formally resumed full diplomatic relations in London. The prince of Wales, acting for King George, received K. Sokolnikov, the first ambassador of the Communist government in London.

The prince, wearing the full dress uniform of a colonel of the Welsh guards, received M. Sokolnikov and his staff in the presence of the staff of the palace, which will be used by the five-power naval conference in January. The Russians were in diplomatic uniform.

M. Sokolnikov, whose the successor of L. Two minutes after the ceremony the Russians returned to their carriages and proceeded to the hotel where they were staying temporarily. The prince of Wales shook hands with diplomats before their departure.

Athletic Commission Orders Probe of Bass-Morgan Battle

Seattle Pugilist's Defeat Results In Rigid Investigation

Chairman of New York Committee Demands Purses Be Withheld From Principals in 'Tudor Bout'

(By The Associated Press) NEW YORK, Dec. 20.—Chairman James A. Farley of the New York state athletic commission tonight ordered the purses of both fighters withheld after Benny Bass, Philadelphia, knocked out Ted Morgan, Seattle, in two rounds to become the junior lightweight champion of the world.

Before the match, Commissioner Farley warned referee Jim Crowley to be on the lookout for "anything suspicious." Crowley did not hesitate in consulting Morgan out, and declaring Bass the winner on a knockout in the second round.

The match itself displayed an amazing reversal of form. In the first round Morgan several times slaughtered Bass with right hand punches to the chin only to go down himself under a sweeping right smash to the head at the start of the second. He rose at the count of nine, protect himself for a few seconds, and then was floored again for the knockout.

Farley said that a rigid investigation of the match would be conducted by the commission and in meantime the purses of both fighters would be retained by the fight club. He indicated his belief that the match had not been fought on its merits. He summoned both Morgan and Bass to appear before the commission Tuesday with their managers.

As a general rule unless there is suspicion of a "fix," the commission withholds purses of fighters only when a foul occurs. Before the match Bass rated as high as 6 to 1 with the crowd.

Startles 9000 Fans Fighting back through a first round bombardment that left him gray and weak, Bass knocked Morgan out in 21 seconds of the second round in a reversal of form that both fighters and spectators gathered for the 15-round title test.

Ridgeway had his rival brought down to the clinch by a floor or finish him. Ridgeway weighed 120; Englishman 127 1/2.

Mentor of Oregon Eleven Finds Name in Shake-Up List

Trouble With President of University at Eugene Cause of Ouster, Says Captain John J. McEwan

(By ALAN GOLLD (Associated Press Sports Writer)) NEW YORK, Dec. 20.—The victim of an ouster apparently effected under extraordinary circumstances, Captain John J. McEwan, one of the all-American and head football coach at the University of Oregon for the last four years, today found his name involved in the rapidly growing list of gridiron shake-ups.

McEwan joins Enoch Bagshaw of the University of Washington in the general upheaval among the principal coaches of the Pacific Northwest but under different circumstances. Bagshaw yielded to pressure and resigned in the midst of an unsuccessful season to be succeeded by Jimmy Phelan of Oregon. McEwan, who with a contract carrying him through 1930 has been released in spite of his willingness to continue and after one of Oregon's best seasons, ending with a tie for the Pacific coast conference title.

"My only trouble was that the president of the university and I could not agree on whom to substitute at critical moments," Captain McEwan told the Associated Press today in making it clear that he would not put up a fight as Bagshaw did to fulfill the remainder of his contract.

Another curious sidelight of McEwan's case was an apparent attempt to show that as a former Army player and coach, he attempted under cover to supply West Point with motion pictures of the Stanford-Oregon game designed to aid the cadets in their forthcoming engagement at Palo Alto.

No one at West Point saw the pictures in connection with McEwan's visit but this incident resulted in an exchange of telegrams between Army and Stanford coaches.

McEwan will remain in the East. He announced today plans to conduct a line-coaching school hereabouts, with spring and summer courses, but also may seek a new job as head coach.

The former Army star has been mentioned as a possible successor to Major Frank Cavanaugh at Fordham. McEwan Cavanaugh, in spite of a successful year, has not yet signed for 1930 and Fordham's graduate manager, Jack Coffey,

BILLY LAVAL, University of South Carolina football and baseball coach, was once a professional baseball player, serving in several good leagues as a smart, left-handed pitcher. Although he turned his back on organized baseball a profession many years ago, he keeps in touch from a distance and during the summer months does some scouting in the lower class leagues, looking for prospects, both for the majors and faster pitchers.

He was talking baseball in a group of football coaches and grew reminiscent. "I went down to look at a pitcher in a Class D league last year," he said. "On a day when I had noted that the schedule called for a doubleheader and I figured surely the boy I wanted to see would work in one of the games."

"The club I wanted to own by a wealthy manufacturer, who likes his base and is willing to stand for the losses he suffers each year, as he thinks it is a good thing for the town to have professional baseball."

"When I went to the park, I found that there was no box office open for sale of tickets and apparently no spectators in the stands, although the teams were having infield practice and it was almost game time."

"I finally attracted the attention of a gatekeeper and told him I wanted to come in. 'You can't,' he said. The crowd razed the ball team when it last yesterday, and the colonel (the club owner) said they couldn't come out and see his ball players, so he's going to see this doubleheader all by himself and won't let anybody else in."

"I sent word to the colonel, and he entered me admitted, so he and I saw the two games, all by ourselves."

"I HAD another odd experience," Laval continued. "I went up to a little town to look at a prospect playing semi-pro ball. It was a hot day, and I soon grew thirsty. I did not see any soft drink vendors, so I asked a boy if they did not sell drinks in their ball park. 'No,' he said; 'we sell watermelons. I thought he was joking; but, sure enough, in a few minutes a wagon drove up, loaded with watermelons. They were really cold at ten cents each and cut open on the spot. THE FOUR YEAR TERM

The long expected decision on the question of the validity of the amendment to the Idaho constitution intended to provide four year terms of office for the executive, judges and members of the officials has finally made its appearance.

The Idaho Supreme Court holds that the amendment was not legally adopted in that the language in which it was drawn was ambiguous and capable of more than one construction.

A majority of those voting endorsed the four year term by voting for the amendment. Probably they would have again, in any event, should have another opportunity of passing on the matter.

The news favored the passage of the amendment on the broad ground that a four year term of office would result in greater efficiency and a curtailed expense. There are, of course, objections to the plan but it is a question if these are not far outweighed by the advantages.

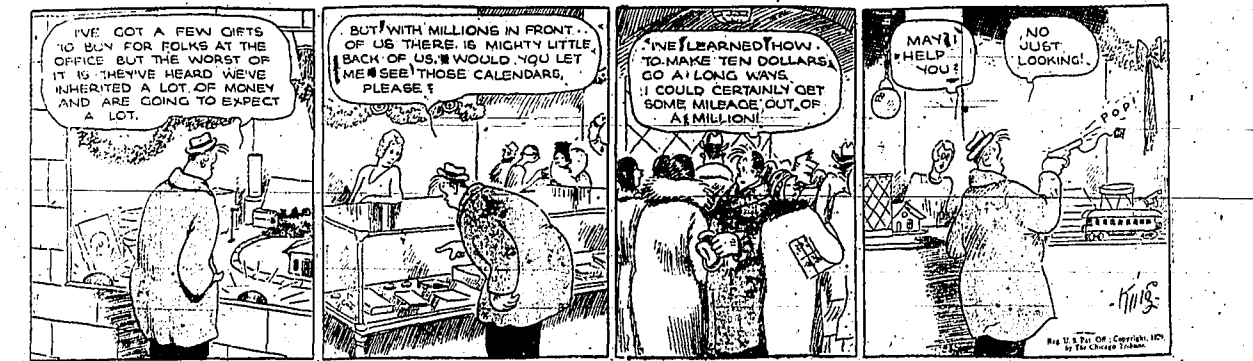
