



CLOSE CONTESTS IN COUNTRY'S VOTE PROLONG CANVASS

Commissioners Check and Re-
Check Count of Election
Returns; Dr. H. N. Leete
Wins With 14-Vote Margin

Twin Falls county commissioners and clerk returned to the court house last night, after completing their canvass of the vote cast in Twin Falls and surrounding districts last Tuesday, to check and double-check the results of their labors.

The official count, as first stated, certified the results and announced in the first published official returns, with a single exception.

Dr. H. N. Leete, Twin Falls Democrat, whose count showed defeated F. E. Drake, Republican candidate for state representative from the district, by only 14 votes, Dr. Leete polling 3409 and Mr. Drake 3395 votes.

Beginning with Twin Falls and first proceeding and continuing on down the list in alphabetical order the tabulation showed first one candidate elected, then another, then another, and it was not until the voice in all precincts had been counted and then re-counted that the result was known.

Another close contest was recorded in the race in which O. W. Whitam, Democrat, defeated E. V. Larson, Republican, by 10 votes for re-election by a margin of 13 votes.

The official canvass goes to Senator Borah, who carried all precincts by his wide margin of 1,000 votes and as against 1915 for Joseph Tyler, Democratic candidate for United States senator.

Conrad Addison T. Smith, Republican, re-elected for a tenth consecutive term, polled 1,610 votes as against 1,418 for W. P. Alworth; Fred J. Pifer, Democrat, who carried all precincts in the county except Buell 1, Buell 2, Deer Creek, Filer, Luerne, and Marra. It was his 10th consecutive victory for this county's vote in his entire career.

John McMurray, Republican candidate for state representative in the county 246 votes as against 401 for C. Ben Ross, Pocatello, Democrat, who was swept into the governor's chair by his 1,000-vote margin.
