

LEADER IN FIGHT ON CHAIN STORES OUTLINES ATTACK

Montaville Flowers, Portland,
Sounds Call to Arms With
Arraignment of Methods
and Appeal to Liberty

Scouting a call to arms in a fight against the chain store system, Montaville Flowers, Portland, president of the National Retailers and Manufacturers Association, addressed an audience of between 500 and 600 persons in the new high school auditorium.

The speaker charged the chain stores with deliberate purpose to put other stores out of business by the hands of a few men in New York and brief about economic encroachment of the whole country.

He said, through Wall Street

processes for which the New York Stock Exchange is a great symbol, the chain stores have been responsible for recent large-scale deflation of stock prices.

Idaho State Game Department Summarizes Fishing Law

1931 Legislature Enacts Sweeping Changes in Rules

New Enactments of Solons In Recent Session at Boise Include Streams In All Parts of State

(By The Associated Press)
BOISE, April 17.—As a guide to fishermen, the state game department has compiled a brief synopsis of the fishing laws, revised in conformance with enactments of the last legislature.

It follows, in part:

Snake River and tributaries—In all Idaho waters, except those of the Snake, from January 1 to May 25, inclusive.

Beginning April 1 is the Snake river from Minidoka dam to the west line of the state, including the portion of the river which is open to fishing the year round.

Elk River and tributaries—In all Idaho counties, except those of Elko, Lander, Lincoln, and Madison, April 1 to October and November; Penitentiary, Priest and Coeur d'Alene lakes closed to fishing during the month of April.

Clearwater river and tributaries—In all Idaho counties, except those of Kootenai, from the mouth of Kassel creek on the south fork up to the mouth of the Clearwater river, April 1 to May 15.

North Fork of the Little Colorado—In all Idaho counties, except those of the North fork closed to trout fishing from January 1 to April 15.

Salmon and steelhead may be taken at any time of the year with hook and line or spear.

Shallow water—In all Idaho waters, except those of the Snake, from January 1 to April 15, inclusive, for salmon, trout, whitefish, and steelhead.

Bull trout—In all Idaho waters, except those of the Snake, from January 1 to May 15, inclusive; all other counties close during the months of May and June.

Salmon or steelhead may be taken with minnows in Snake river from confluence of Captain John Creek in Hells Canyon and southward, permit.

All fish, including trout, may be taken with minnows in all Idaho waters, except those of the Snake, and in Lake Pend Oreille until December 31 of each year.

Salmon and steelhead may be taken at any time of the year with hook and line or spear.

Shallow water—In all Idaho waters, except those of the Snake, from January 1 to April 15, inclusive, for salmon, trout, whitefish, and steelhead.

Bull trout—In all Idaho waters, except those of the Snake, from January 1 to May 31, limit 4 down a day.
