FILER, Aug. 7.—Twenty years' residence in the county will qualify persons for membership in the Twin Falls county Old Settlers' society, it was decided at the annual picnic of the organization at the county fairgrounds at Filer today.

The picnic was held on the twenty-sixth anniversary of the coming of the railroad to Twin Falls.

The new qualifications broadened the limitation of membership to persons residing in the county prior to February, 1911, when the county was created.

EGG PRODUCERS GET BIG PRICE FOR POOL

Latest Shipment of Idaho Association From Twin Falls Reveals Increases

Members of the Idaho Egg Producers' association have received checks this week for a recent pool of eggs which brought considerably higher prices than have prevailed recently in the South Central Idaho district. The pool shipment was made August 21.

Prices received by the association were: Extra, 21 cents; brown and cream, 18 cents; white, 16 cents; standard, medium size, 13 cents; standard, 14 cents; pullets, 11 cents.

Producers received 2 cents less per dozen, the difference going to pay handling and shipping charges.

It was pointed out by officials of the association, which is a poultrymen's non-profit association, that the price paid to growers by the association is considerably larger than those offered by cash buyers in Twin Falls. Careful grading, along with the system of marketing in large quantities, brings better prices, officials insist.

The Idaho Egg Producers' organization has recently purchased a building at 210 North Main street, and is accumulating a substantial surplus, besides paying members a generous price for eggs.
