

STATISTICIANS AT COURT HOUSE FIND BUDGET UNBALANCED

Commissioners' Apparent Neglect to Allow For Tax Delinquencies Causes Congestion in Two Funds

Twin Falls county's tentative published 1932 tentative budget is out of balance, according to conclusions reached by some of the courthouse statisticians.

The budget, provided for current expense fund expenditures totaling \$192,785, and for hospital and poor fund expenditures amounting to \$112,035, and the statement of estimated revenues to cover these expenditures, checks out all right, but the statisticians say, it will be impossible to make tax levies high enough to pay their assigned share in the income, because the maximum levies which state laws prescribe are not sufficient.

Under the state law the maximum levy for current expense fund is 40 mills, which was levied in Twin Falls county last year. The 40-mill levy on Twin Falls county's \$24,700,000 property valuation last year, called for \$9,880 tax income. The 40-mill levy on the courthouse statisticians say, that property valuation this year will exceed last year's, with the assurance of a recent reduction of livestock schedules clipping off something like a quarter of a million dollars in the county's valuation. So they say, \$9,880 tax income for the 1932 current expense fund is all that can possibly be raised—and the published tentative budget shows \$114,143 to be raised by tax levies.

There is a difference of \$145,000, an excess of proposed expenditures over the maximum possible revenues. Hospital involved.

Similarly in regard to the county hospital and poor fund, the law sets the maximum levy at 25 mills, which was levied last year. And the 25-mill levy on the county's \$24,700,000 property valuation is expected to yield \$61,750. But the published tentative budget shows \$121,000 to be raised by tax levies.

There was no such lack of balance when the county commissioners adopted the tentative budget last week and turned it over to the county budget for publication; but, the statisticians say, the thing that threw the budget out of balance was the budget incident that the commissioners should have made allowance for probable delinquency in the payment of this year's taxes.

The commissioners took into consideration, and counted as assets, this year, delinquent taxes amount-

ing to \$10,000 in the case of the current expense fund, and \$7000 in the case of the hospital and poor fund. The statisticians say, however, they made no allowance for any delinquency in payment of 1932 taxes.

The law, according to the budget officer, requires allowance for tax delinquency; therefore, the budget officer, in order to comply with the law, should have included a budget statement an item of \$15,000 as "probable delinquency of current tax" in the current expense fund, and another item of \$6000 probable delinquency of current tax in the case of the hospital and poor fund.

That, of course, unbalances the budget, and presents a problem to be solved on or before February 1, the time for adoption of the county's 1932 final budget and appropriation bill.

The published tentative budget, incidentally, calls for expenditures on all accounts totaling \$317,042.20, of which \$257,594.20 is to be raised by tax levies.

Tax Boost Looms

Continuing necessity for balancing the budget must, of course, reduce to some extent the amount to be raised by tax levies—because the legal maximum levies cannot in any event be exceeded. But there seems to be no way around an increase in county taxes this year over last year. The comparison in the levies, on the basis of the tentative budget for 1932, is as follows:

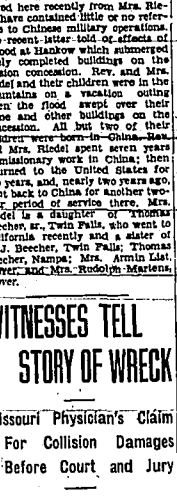
Missouri Physician's Claim For Collision Damages Before Court and Jury

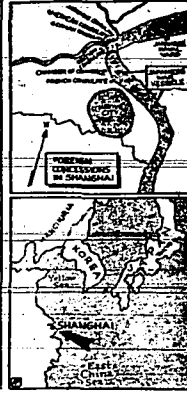

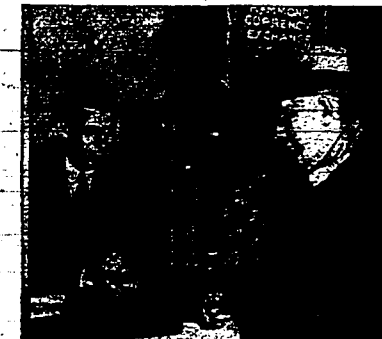
