The special will leave here tomorrow afternoon for Butte, Montana, and the Northwest.

LAWYER PUBLISHES SUICIDE'S LETTER

Charles E. Dubois Claims Wive Ended Own Life, and Tells of Burying Corpse

QUINCY, Mass., Sept. 17 (AP)—Charles E. Dubois in a letter left behind before he committed suicide, and made public tonight by his attorney, said his wife committed suicide and that he accepted her body because he was convinced "people" would not believe my story.

The letter was made public by Attorney Jeremiah J. McManamy who said he found it in a drawer at the home of the late Mrs. Dubois.

Dubois, who made conflicting statements to police and others after the mysterious disappearance of his wife, committed suicide in a QuinCY boarding house a few hours before his wife's body was taken from a boat in the harbor of Plymouth.

Dubois, in the letter, said he had not told the attorney "the whole truth" before because he wished to "cover the good name of a good, pure woman." The name of the woman was not released with the letter.

The letter told of vexatiousness of his wife, Charles E. Dubois, and his intention to get a separation from her husband. He said that "over the good name of a good, pure woman" he had decided to step out of my life and perhaps we would both be happier.

Dubois, in the letter, said that on the 15th of August he and his wife were getting breakfast when he heard a loud report in his wife's bedroom. He said he went in and found her lying on the floor.

"It was overcome with the belief that no one would believe my story," he wrote. "I could not bear the thought of my wife being buried as dead (defeated) because blurring my mind was the thought I would never be able to further through I secreted the body."

The world will not believe my story and if it did there is no happiness in my life.

In a postscript Dubois said he "could not tell Mr. Sullivan (Assistant District Attorney John V. Sullivan) the truth because I was afraid of a name in the papers."

In the temporary absence of McManamy from his office yesterday, Dubois, who had been in conference with his counsel, wrote the letter.

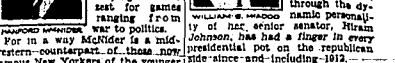

HIGHWAY DISTRICT MAKES DEEP SLASH IN NEW TAX LEVY

Board Appropriates \$35,000 From Motor Vehicle License Revenues To Help Meet Payments on Bonds

Twin Falls highway district, which pays off a \$1,250,000 bond issue at the rate of \$125,000 a year and which will pay its fourth annual installment on August 1st, has today adopted a 1932 tax levy, which represents a reduction of practically 33 1-3 per cent. under last year's levy.

The district for a second consecutive year made no levy for operation and maintenance of road and bridge funds, and in order to effect the reduction in levies for bond redemption and interest funds, it cut \$20,000 of its share of the state's motor vehicle license revenues and applied that amount to the bond redemption fund, and appropriated \$10,000 from surplus in the interest fund to apply on next year's interest bill.

The district's total 1932 tax levies, which the district's commissioners adopted yesterday, is to be 80 cents on each \$100 of valuation, as against \$1.30 last year. Of the total levy 60 cents is for bond redemption and 20 cents for interest.

The levy will apply on a valuation of \$127,415, which is approximately \$20,000 under the preceding year's valuation.

The requirements for bond redemption next year will total \$127,415, and for interest payment, \$47,904.

Twin Falls district commissioners under agreement heretofore reached with the Marist and Park Creek highway districts, adopted yesterday the tax levies for those districts, which were created out of the original Twin Falls district and assumed a proportion of the parent district's obligation for bonded debt.

The levies for each of the two districts total \$1.13, as against \$1.30 last year. The new levies comprise 87 cents for bond redemption and 26 cents for interest.

Twin Falls district commissioners applied \$25,000 out of the parent district's share of motor vehicle licenses to apply on payment of this district's proportionate share of the bond payment, thereby reducing its levy for this purpose under that of the other districts.

Twin Falls district has received this year approximately \$60,000 of motor vehicle license revenue, as compared with \$77,000 last year, and additional \$1300 receipts from that source.

The district has no outstanding warrants or current indebtedness.
