





CASSIA-TREASURER GETS TAX MONIES

Collections Exceed Last Year's Payments At Burley

BURLEY, Dec. 27 (Special to The News)—Current taxes paid on the 1933 first installment, in Cassia county totaled \$14,152.21 compared with \$14,152.21 a year ago, according to available figures in the office of W. R. Sturgeon, tax collector. Straggling checks were still coming in by mail in transit prior to the delinquency dead line Saturday night.

Delinquent payment during the same period from November 21, were \$41,705.84 for the next three months. The 1933 tax collector's office compared with \$39,000.13 paid in the last year of 1932. Payroll are being paid by the treasurer since many delinquencies from 1931 are being collected. The 1933 tax collector's office will close on January 1.

Peak collection days were December 21 for current taxes when \$43,187.34 was brought in and December 24 for back taxes, when \$37,150 was paid.

TAX PAYMENTS HIGH IN JEROME COUNTY

Current Collections Good While Delinquencies Exceed \$35,000

JEROME, Dec. 27 (Special to The News)—County Treasurer Earl F. Kennedy revealed today that tax collections during the past ten days had been extremely good, reaching as high as \$20,000 in a day, excluding the \$20,000 in delinquencies paid. The Idaho Power company paid over \$20,000 on one time and the Oregon Lumber company over \$16,000. Out of \$200,000 in outstanding taxes, collections will approximate \$100,000.

Mr. Kennedy estimated that the amount of delinquent taxes which will be paid by the end of the year will be approximately \$35,000, a larger payment than has been made in the month of December in the county. The reason for this, Mr. Kennedy stated, is that a vast number of taxpayers for 1932 to 1933 inclusive are making every effort to pay before January 1 when the 3 per cent penalty goes into effect.

# Coaches Plan Drive Against Tide Of Unfair Criticism

## Mortality Rate Alarms Nation's Gridiron Men

Convention Delegates Decide To Form Committee and Investigate Charges of Unwarranted Dismissals

By PAUL MCKEON (Associated Press Staff Writer) CHICAGO, Dec. 25.—The "mortality rate" of college football coaches is going to fight back the tide of "unfair" criticism that annually washes scores of them out of their jobs.

At the mounting "mortality rate" within the ranks year after year, they decided at their annual convention today to form a committee to investigate charges of unwarranted dismissals.

Six reasons why football coaches don't last long were outlined by H. J. Stegeman, athletic director at the University of Georgia, who said that since 1925, 14 of 10 coaches had served in two southern conferences, which have a total membership of 23 colleges and universities.

What are the causes for the "mortality rate" among coaches? The coach didn't mix with the faculty; he failed to do his job; he was too young; he was too old; he was too nervous; he was too greedy; he was too selfish; he was too ignorant; he was too ignorant; he was too ignorant.

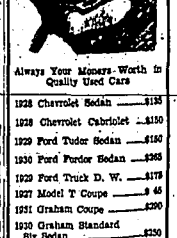
