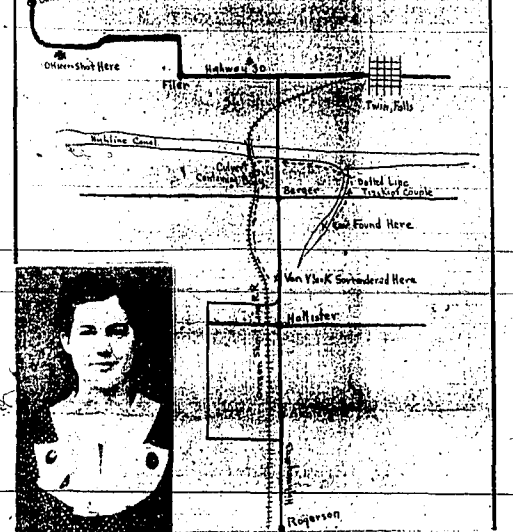

Her head had been pierced by a bullet and crushed by a rock. Douglas Van Vlack, her former husband and confessed slayer of State Officer Fontaine Cooper, last night admitted the second murder after first claiming that he had left the girl unharmed. Stolid Killer Confesses Guilt of Fiendish Crime When Body is Discovered

Coroner's Jury Finds Tacoman's Kidnaped Former Wife Came To Death From Blow And Shot In Head

REBELEY (Associated Press Staff Writer) With a nod of his head and later with a firm "yes, I killed her," Douglas Van Vlack, 31, of Tacoma, Washington, accused slayer of State Officer Fontaine Cooper, last night admitted to this reporter that he shot and killed his former wife, Mildred Hook, whose body was found early yesterday morning stuffed in a railroad culvert, her head crushed and ripped with a bullet.

Confronted with the fact that his pretty 22-year-old former wife had been found dead, Van Vlack, strangely quiet and with little of the confident air he has thus far shown remaining, admitted the crime, saying "she knew before she left Tacoma what was coming to her. I told her father before I took her that if he didn't leave us alone, I'd kill her. That's why I did it."

Banks at Oath Prosecutor Edward Babcock, who declared last night that he will file two separate first degree murder charges against Van Vlack, was unable to get a sworn statement from the prisoner.

FATHER FORECAST SLAYING OF GIRL Grief - Stricken Parents of Mildred Hook Near Collapse

TACOMA, Nov. 20.—(AP)—The grief-stricken parents of slain Mildred Hook of Twin Falls were near collapse tonight as realization of uncertainty ended an era of hope for the return of their daughter.

A trained nurse cared for Mrs. Joseph Hook, whose condition was serious after news that her daughter had been found shot and beaten to death today in southern Idaho. Clyde and Vinson Hook, brothers of the slain girl, were expected to return to Twin Falls today, where her body is returned to Tacoma. Funeral arrangements here were held in a ceremony pending release of the body by Idaho authorities.

News of Mildred's death today again confirmed Hook's ability to diagnose crimes in advance. In the Wertheimer kidnaping stories he had an accurate prediction as to the fate of the kidnap victim. It proved to be almost exactly true.

Forecast Death When an alleged abduction struck in his Tacoma home Monday night almost immediately forecast his daughter's death. He told reporters he deduced the girl expected death from her kidnappers as told by Doris Clark, her companion at the time she was allegedly forced into Douglas Van Vlack's car on Tacoma street.

She saw the Clark girl get hurrying, containing a large check given her to Doris Clark. She told her father she was cashier at a bank. Mrs. Clark said Mildred begged her to tell her father she was in the car with the payment.

GOVERNMENT TURNS RELIEF TO STATES

Administration Promises 3,500,000 Jobs by End of Week

WASHINGTON, Nov. 29 (AP)—Setting the goal of providing 3,500,000 jobs for the unemployed would be attained by Sunday, the administration tonight announced an abrupt halt to the flow of further federal relief funds to the states. Parcelling out final, supplemental "dole" allotments to 22 states, the new deal relief spokesmen declared that henceforth—aside from the 3,500,000 on work relief—all responsibility for the needy rests with the "local government."

Complete liquidation of the federal emergency relief administration was announced by the agency of Henry L. Hopkins, as of December 1. Hereafter, the works progress administration will stand as the government relief agency.

Officials of the Federal Emergency Administration of Public Works, which has spent more than \$3,000,000 since it was set up in May, 1933, during the absence from the capital of then President Roosevelt and Hopkins.

Both, however, were in touch with developments. The president earlier in the day had declared in his Atlanta speech that with 3,125,000 jobs at work on last Wednesday, the job objective had been virtually attained.

Aubrey Williams, assistant chief of WPA and FEPA, talked by telephone with Hopkins in New York City before receiving reporters and amending the president's statement. The entire 3,500,000, he announced, would be at work by tomorrow night.

Williams conceded, however, that direct relief would be continued in December. That the allotments made today may be used next month for that has been called the "dole" was acknowledged even as he asserted that 22 states not previously aided now had "received their full allotment of federal funds by FEPA."

Two problems still face the work relief high command: one translation of the other permanent. They were:

1. Some able-bodied needy must continue to receive the dole for a time in localities where job quotas have not been filled, while everywhere day in actual payment of work relief salaries will require similar extensions of direct relief until paychecks are received.

2. About 4,000,000 unemployed—blind, crippled, widows with dependent children and others who are unable to work—are to receive no further federal assistance and must depend on state and community and the just-starting social security maintenance.

Williams maintained, however, that both these problems would be solved. He said efforts were being made to speed delivery of work relief paychecks.

Telling newspapermen that he wanted them "to keep their right," Williams emphasized that the state relief administrations have a free hand in spending their final allotments. Quickly he added, however, that there wouldn't be any more from Washington.

Williams asserted he did not know the amount of unpaid bills of state relief administrations, or the amount of carry-over into December of the federal allotment.

He said the money was distributed on a three fold basis:

1. Progress of the employment program.

2. What they've got in un-encumbered balances of our money.

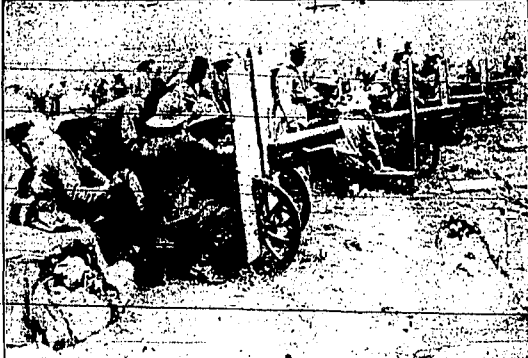
3. What they've got in way of problems and what they have of their own money.

Tragedy No Surprise To Mildred Hook's Brothers

Tacoma Youths Tell Intimate Story Of Girl's Ill-Fated Romance

Brothers of Mildred Hook, 22, Tacoma girl, did not expect to find their sister alive when they started on an 800-mile drive to Twin Falls from Tacoma at midnight last Wednesday.

The brothers, Clyde Hook, 21, forest service clerk at Olympia, and Alton Hook, 21, Tacoma barber, employ, driving throughout a day and night on the road arrived in Twin Falls yesterday morning. They breakfasted at a cafe here and then went to the sheriff's office.

There they learned that word had just been sent of the discovery of the girl's body in a railroad cut, about nine miles southwest of Twin Falls.

Discarding the suggestion of Dr. H. L. Sizer, coroner, that it might be better "not to see what was to be seen there," the brothers returned to their car, and trailed the official car to the sagebrush-covered gulch where a group of men stood about the rail body of their sister. One still beneath the mass of blood and despite a horrid stench that a heavy blow had caused.

Identify Sister's Body
Recognition was positive and instantaneous. They stayed there a while, until others came to carry the body away, and then came back to town to draft a message to their parents, Mr. and Mrs. Joseph F. Hook of Tacoma.

Trusting to news services to carry word to them of the grim discovery, they made no attempt to tell what they had learned.

They merely asked their father for instructions. The hour, acting on the instructions that came back to them, they had made their plans. The older brother was to return on the train with the body; the younger youth was to drive back home alone.

A little later they were summoned to attend the coroner's inquest, and the older brother, gravely and with careful attention to the import of his words, testified that the dead girl was his sister with whom he had grown up; that he had been told and believed that she had been abducted at the point of a pistol by her former husband, Douglas Van Vleck, from the streets near their home as she returned from work last Saturday evening and that he believed Van Vleck had cruelly saved her death.

During the afternoon, Clyde Hook had told simply and without apparent reservation the story as he knew it, of his sister's ill-fated romance, withholding no detail when questioned regarding the family circle that had been broken by her tragic death.

There was no raucous in his statements; only a little impatience perhaps over what he considered unnecessary details.

Washington officials in starting the pursuit after the kidnapping were told by the brothers that they started on an 800-mile drive to Twin Falls from Tacoma at midnight last Wednesday.

Tells of Sister's Abuse
There were no violent outbursts of feeling as he related incidents of the girl's life. He said that Mildred had been treated and abused by her former husband, through there was plain evidence of an abiding affection that bound together the little family of father and mother, two sons and one only daughter.

"Maybe you should see this," he told his questioner holding out the letter that Mildred had written to her father from those last Monday—a brief message of "insurance and of courage." "I'm not right, don't worry. Will return soon as I can."

He quoted the dead girl as having told her mother at about the time she obtained the illegitimate divorce decree last October 11, "No body can know what the consequences of this divorce will be. Two weeks before the alleged kidnapping last Saturday, the girl's brother said, Van Vleck caught her on the street and detained her all night."

"She was afraid to tell the brother," he said.

Couple Secretly Wed
He told of his sister's secret marriage to Van Vleck following a brief acquaintance in the spring of 1933. Sister Van Vleck, only one of a trio of children, had been a pet puppy that had been introduced to her occasionally by her father's sister, who was a regular girl, she said he had occasionally introduced his pretty sister to young men of his acquaintance. "She never cared much for men; she didn't seem to cotton to three other fellows, but she was nuts about him, at least until just before they were married." The lieutenants were two weeks before the marriage, he explained.

"She was a regular girl," he said he was a regular girl, she brother said with a note of pride in his voice. He told of her graduation from a Tacoma high school, her membership in the Rainbow girls and in the Order of the Zephyr Star.

Before and after her marriage, he said, she was employed in the Tacoma office of the Washington Gas and Electric company.

Returning to the unhappy marriage, he said she had found in marriage, youth related that she had started out for divorce the "morning" following the marriage in the spring of 1933. Van Vleck, he said, had persuaded her to return to him. They made their home in the Hillbush over what he considered unnecessary details.
