



# WOMAN REPEATS STORY OF SLAYING

## Vera Stret Ends Three-Day Ordeal in New York Court Room

NEW YORK, March 31 (AP)—Vera Stret concluded a three-day ordeal on the witness stand today, repeating to a state's attorney her story of how she shot and killed her lover, Dr. Fritz Gebhardt, in an attempt to save her unborn child.

She repeated several times, but she was calm under the probing questions of Assistant District Attorney Miles O'Brien than when she recounted to her attorney, Samuel J. Morris, the bloody story of the end of her illicit romance with Gebhardt last November 12.

Later in the day, O'Brien asked her a few questions, after O'Brien had finished, and then announced the defense had rested.

Mrs. Stret denied she told a police detective after her arrest that "she had killed her lover." The state had her retell the entire story of her relationship with the secretary of a German export-import firm with whom she testified she had been intimate before he went to Europe in 1935.

She said she had told Gebhardt she was a married woman with a wife and two children.

Again she described how Gebhardt asked her to testify in defense of the defendant, and she screamed during the alleged assault.

He also questioned her in detail about her actions before the time of the alleged attack and the time she shot Gebhardt.

"I assume that you were greatly shocked by Gebhardt's action," O'Brien asked.

"Yes," she replied.

"You were horrified?"

"But you didn't run out of the room when you got up?"

"No."

"You went to look for your shoes?"

"Yes."

"While she was putting on her shoes near the bureau she said, Gebhardt got up and started to walk toward me."

"Where was the woman when you picked up the gun?"

# JURY TO DECIDE SLAYER'S SANITY

## Utah Judge Dates Second Hearing In Boyer Murder Case

PARMINGTON, Utah, March 31 (AP)—The sanity of ex-convict Paul L. Boyer will be decided by the same jury that convicted him of the murder of Mrs. Blanche Nelson, pretty Woods County woman.

District Judge Eugene E. Pratt set the second trial for April 17 today.

Defense Counsel P. Verne McCullough declined to examine prospective jurors for the sanity trial, provided under a new state law on the ground the state supreme court might construe his action as a waiver of right to object, should the case be appealed.

If the jury finds Boyer was sane when he shot Mrs. Nelson, he will be sentenced to death. He will be given the choice of shooting or hanging.

Should Boyer be found insane, he will be committed to an institution, subject to the death penalty should he ever be adjudged sane.

# Conservationists Launch County Wildlife Federation

## Major League Pilots Guard Predictions With Series Of 'Ifs'

### Stewart Elected As Temporary President At Initial Meeting

#### Organization Perfected Prior To State Meeting At Boise; Priebe, Powell Explain Purposes, Plans

Twin Falls county sportsmen, representing some 20 organizations, gathered in Twin Falls Chamber of Commerce last evening and formed the Twin Falls County Wildlife Federation. C. Stuart Stewart was elected temporary president and Milton Powell was chosen temporary secretary.

Organization of the county body was perfected preliminary to a statewide meeting of the Idaho Conservation Council at Boise next Sunday, Monday and Tuesday, and Harry Heller was selected as delegate from Twin Falls county with Stewart as alternate. Several other members of the county were present to attend the meeting.

Plans for obtaining representatives from each of the 350 clubs and societies in the county in the federation were outlined and the president appointed a committee of five to obtain a list of all clubs in the county and to secure their membership in the federation. Committee members were Paul Gilman, Harry Heller, Stuart Stewart, and Roy Washburn of Twin Falls and Charles L. Sherwood of Hansen.

The adopted constitution, recommended by the national federation, has as its object: "To protect, propagate and increase fish and game and to improve the habitat of all wildlife; to secure the enactment of laws for the protection and restoration of wildlife, forests, marshes, streams and lakes and to promote the observance of laws; to create and foster public opinion in favor of the protection and restoration of wildlife; to promote sportsmanlike methods in hunting and fishing and proper respect for the rights of landowners; to cooperate with all associations or agencies having similar objectives. This wildlife federation shall be non-political."

The constitution goes on to state that membership shall consist of one representative from each organization, society or club within the county which is interested in the restoration and conservation of wildlife and game. The membership of all organizations, societies and clubs which have representatives in the federation shall be official and non-voting members of the organization.

To Name Board

The constitution provides for the election of a board of directors to cooperate with all clubs and societies of the organization and the board will be named, along with permanent officers, at the next meeting of the organization. This constitution was adopted, subject to recommendation and change from membership of the entire membership of the organization.

Major portion of the meeting was devoted to an explanation of the national organization and the manner in which the county must cooperate with all clubs and societies. W. R. Priebe, president of the Southwest Sportsman's association, presided at the meeting. Other speakers were W. R. Priebe, president of the Southwest Sportsman's association, and C.
