SPEEDING UP PROCESS BEGUN IN PEACE CONFERENCE TODAY

ALL ANGLES OF PEACE ARE CONSIDERED AT MEET

Committee Holds Meeting on the Subject—Time of Reporting the Plan or the Method Unsettled—Meeting Every Evening—Territorial Claims of the Czech-Slovaks Come Next—Preamble of League Announced.

PARIS, Feb. 5.—A preamble and two articles of the text of the league of nations constitution was agreed upon last night by the commission appointed by the peace conference to draft the plans for the league, it was officially announced today.

The text of the announcement follows: "The commission on the league of nations met last evening at the Hotel Crillon at 8:30 p. m. and commenced its detailed discussion. A preamble and two articles were discussed and their texts were provisionally agreed upon. Satisfactory progress was made in regard to other parts of the draft. The question of adding representatives of other powers to the commission also was discussed. The commission will meet again this evening at 8:30 p. m."

(By John Edwin Noble, U. S. Staff Correspondent) PARIS, Feb. 5.—All possible speed is being made to get the league of nations into shape before President Wilson will be compelled to return to the United States.

The committee on the formation of the league of nations held a meeting last night which did not come to an end until early today.

President Wilson being the head of the committee presided. It was the first meeting was held today in view of the fact that no previous meeting had been held.

The question whether a plan for the league can be reported to the plenary session of the peace conference has not been yet settled.

It is known that the president frankly desires that such action be taken before his return to America. However, many delegates consider such a step premature in view of several conditions which apply to many angles of adjustment, chief of which is whether the United States should accept mandatory powers in the near east. This is being urged here despite the fact that it is opposite to the American policy.

It has been decided that the committee shall meet every evening this week in the hope of getting the outlines of a constitution framed in time to allow at least a preliminary report to the plenary session of the peace conference, thus releasing a certain amount of detail. The president would make known the outlines to congress, if such progress were made.

There was another meeting of the council of ten representatives of the big five powers of the world today.

The territorial claims of the Czech-Slovaks were taken up following the demands of Greece which had taken up the attention of the conference during the two preceding days.

The preliminaries are being worked out on the literary staff. The signatures to the peace treaty will resume their pre-war status.

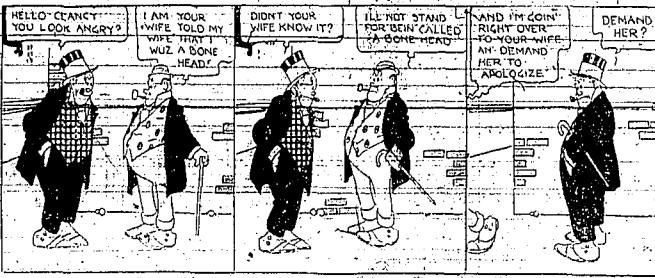

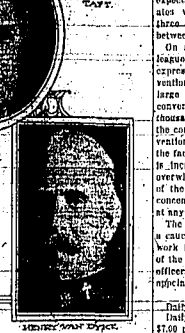

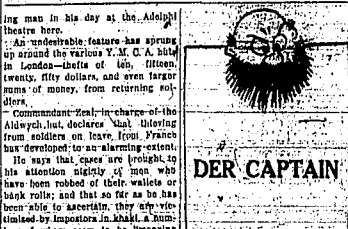
