SUNDAY SCHOOL LESSON

REVEREND UNION LITERARIANS

LESSON FOR MAY 11.

BIN AND ITS CONSEQUENCES.

LESSON TEXT—Genesis 3:1-7.

UNION TEXT—The wages of sin is death; but the gift of God is eternal life through Jesus Christ our Lord.—Rom. 6:23.

ADDITIONAL READING—Psalms 51:1-3.

PRIMARILY TOPIC—Eating Our Bread.

JUNIOR TOPIC—How Disobedience Brings Punishment.

INTERMEDIATE TOPIC—Destructive Results of Sin.

SENIOR AND ADULT TOPIC—The Nature and Penalty of Sin.

An outlook upon the world reveals that man is not what he should be. There is something wrong with him. There is no sign of improvement. The only way of accounting for the discrepancy between what man is and what he should be is by the Fall. This is the way that the Bible accounts for it. The introduction of sin into the world.

1. The Temptation (Gen. 3:1-7).

Men possessed a free will, in the exercise of which he turned away from God and his commandments. It was done at the instance of the devil working through the serpent. He did not even see really good in the forbidden fruit. He was merely employed was (1) finding the woman well alone; (2) insinuating doubt into her mind as to God's love and care; (3) his suggestion she began to believe that God did not mean what he said, and that he was really plotting against her. In this the devil slandered God, even accusing the Almighty of jealousy and fraud. (3) Appeal to innocence. (4) The serpent acted upon the fruit which God had forbidden. Looking now began to eat. (5) She ate the forbidden fruit. (6) The serpent hid. (7) That which God had forbidden should not be looked at let the flesh abstain but for it.

From lust to Intolerance was a short step. This act of disobedience brought on all the world's woes and sufferings. It was our disobedience that invited Adam in her sin. Angering the gods, they became the slaves of sin. They tried to know good and evil, but by that experience. They knew sin without the power to free themselves from it.

2. The Consequences of the Fall (3:8-24).

The disturbed relationship with God was the first consequence. The course which man enjoyed with God was marred and broken by sin. Sin makes life intolerable to the man who is not saved. Adam and Eve not only hid from God's presence, but Adam began to make excuses and even talk to himself. This was the first sin. The serpent was degraded and beastlike because a type of sin and sinners (v. 14; cf. John 2:23; John 8:14; Heb. 12:2). This disobedience was not without trial. In the case of man it was (v. 15):

1. The immediate penalty between the two seeds (v. 12; cf. John 8:12-14; Matt. 23:35). The antagonism thus began reached its climax in the crucifixion of Christ. Satan's seed has been ever since endeavoring to destroy the Lord's seed and his workers.

4. The ultimate victory of the woman's seed (v. 15). Satan harassed the woman's seed; bruised his heel, but finally the snake was made useless by crushing the serpent's head (John 2:21; Heb. 2:14; 1 John 3:8). This was the first plan of the glorious light of the gospel of Christ. The victory was marvelous, but the cost was infinite (cf. 1 Cor. 5:21).

5. Judgment upon the woman (v. 16). This relates to her as a wife and mother; also to her subordination to man. This is God's decree, and all efforts of freeing one's self from it are futile against God.

6. Man's free responsibility to the truth (v. 17-19). The result was the growth of thorns and thistles, man must make his own effort to escape. Men with the devil nature were to be in a bad state without the necessity of toil (Rom. 8:19-22).

7. Temptation (v. 13). This includes physical and spiritual desires beyond the result of sin.

8. Repulsion from the garden (v. 22). This was an act of great mercy. To have partaken of the tree of life and live forever in a sinful state would have been intolerable.

Exercise is Necessary.

THIRTEENTH AMENDMENT TO THE CONSTITUTION

Senator Gore, the blind representative of Oklahoma in the upper house of congress, has been digging around in the archives of the nation, and recently unearthed a constitutional amendment that has never been ratified, but which he says for a quarter of a century or more was printed in school histories and nearly all of the modified copies of the constitution of the United States as the thirteenth amendment.

The constitution, as it was framed, provided that no person holding office of trust or honor in the United States could accept any title of nobility from any king, prince, or foreign state without the consent of congress. Congress, in a yielding mood, capitulated the party, who, voting that she would never consent, consented, and passed a law permitting the acceptance of titles. An effort was made to repeal this law without success.

In 1808 and 1810 congress came to regard the constitutional provision as too lax and sought to remedy it by submitting a constitutional amendment prohibiting any citizen from accepting any title of nobility or honor either with or without the consent of congress. There were only five votes in the senate and only three votes in the house against the submission of this amendment; it failed of ratification by the one by only one state. Indeed, it might be said that it failed by only one-half a state, as the South Carolina senate ratified the amendment, but the house of representatives failed to do so. The notion became widespread that the amendment was passed, and enterprising publishers always included it in their copies of the constitution and amendments, thus perpetuating the popular error. This amendment, according to authority of Senator Gore, is still pending before the states, and is still subject of ratification.

If some enterprising politician gets busy and has a few states go on record in favor of the amendment, he might make it a popular

election campaign issue. Under the amendment President Wilson would be forbidden to accept any gifts from any foreign king or potentate, and would be forced to give up some that he is reported already to have accepted. Ratification of the amendment would forbid Josephus Daniels, secretary of the navy, to accept the honors of a British knighthood.

Senator Gore may be a bit sarcastic, but he is none the less truthful in his discussion of the subject. In a statement made by him he says: "It has been admitted with lifting and care that this war has been waged in behalf of world democracy. The star of democracy is now in the ascendant and happily promises to remain so in perpetuity. Some of our Democrats, however, have betrayed an overreaching desire for the titles and trappings and spangles of aristocracy. If minor speaks true, we are to have our Sirs Tom, Dick and Harry. We are to have our Sir Jack and our Sir Josephuses."

But there's nothing like getting used to the nomenclature which royalty breeds, and the nation might get used to Sir Josephus or Prince Albert, unless somebody gets busy and has the thirteenth amendment to the constitution properly ratified.

BUSINESS CONDITIONS GROW STEADILY BRIGHTER

Economic aspects, while still reflecting many contrasts of light and shade, grow steadily brighter. Some of the dark spots, say those in the great iron and steel industry, remain conspicuous, but that does not detract from the fact that the general picture is one of steady recovery. From the effect of the war has been a general clearing of the atmosphere, and, just of all, there has been a further strengthening of that confidence which is essential to successful progress, says Dana S. Hooper.

It is not now a question, in short, as to whether conditions have improved, but only as to what lengths the continued revival has already carried, and as to how soon the general peace-time expansion which seems to be clearly portended will make its appearance. All the traditional elements of prosperity are present; economically, the country has moved into a powerful position, and but for the delay in the adjustment of those complex international problems which have inevitably come as an aftermath of the greatest war in history, the domestic business development would probably be more far-reaching and rapid.

Yet, as it is, there is not now a geographical section in which actual transactions are not broadening in some quarter, dispatches from parts of New England and the Middle West being especially prominent among the week's favorable advices, and a disposition to anticipate forward wants more freely, but without evidence of unwholesome speculative tendencies, is a feature more widely commented upon.

The way in which consumptive demands hold up in retail channels, in spite of the extraordinary commodity prices and the reports of unemployment, has been gratifying to many interests, and not only is a well-defined preference being shown for the better classes of staple merchandise, but purchases of luxuries are increasing.

Behind all this, and affording a solid basis for national sentiment, is the great wealth-producing capacity of the agricultural community, and it is reassuring in this connection that crop prospects, although modified in some localities by the recent unseasonable weather, continue highly promising.

RED FLAGS

There is no national law against carrying the red flag in this country. Few states or cities have regulations against it. And yet almost every time the red banner appears in an American city there is trouble for its devotees.

The public, law or no law, will not stand for it. Let it appear at the head of a procession, and almost inevitably it is snatched from the hands of its bearer, and the marchers are subjected to rough treatment. Usually, to be sure, they themselves start the disturbances, by their insolence or violence. But even a quiet procession of "reds" is intolerable to most American communities. This was shown with striking force in the May day riots.

Why has this traditional symbol of socialism, once endured without a murmur, become to most citizens as irritating as a red rag to a bull? It is because the significance of the flag has changed. The public used to accept, even though dubiously, the socialist explanation that it meant human brotherhood, that its color stood only for the warm blood flowing alike through all human hearts. It accepts that version no longer. The flag is now taken to mean bloodshed, and the overturning by criminal evidence of cherished institutions.

It is the socialists themselves who have given their flag that significance, by their championship of Prussianism during the war and by their more recent support and annihilation of bolshevism with all its brutality and crime.

There is much agitation for legal enactments against the red flag. The socialists would take that, naturally, as proof of persecution, and adopt the role of martyrs. But whether their banner is banned by law or by voluntary civic opposition, they have only themselves to blame for turning a once admirable symbol into a by-word and a hissing.

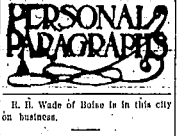

This same advertisement offers a ladies' set silk lace, full fashioned, at 75c. This lace is full fashioned in any part.

Whether this kind of advertising is due to a lack of knowledge of merchandise or is intentional, it is nevertheless misleading and unfair to the purchasing public.

I have heard of a merchant who advertises that he is connected with a number of other stores and is buying goods in carload lots from the manufacturer and paying cash for his merchandise, when in a matter of fact he does neither, is apparently doing this with the thought of misdirecting the purchasing public.

A merchant who is in good standing with those from whom he buys goods and is financially sound, does not find it necessary to buy for cash. Confidence between him and his supplier is the most important element in business.

To buy merchandise where it can be bought the cheapest is not proof of good merchandise. I believe in buying goods where they can be bought to the best advantage and the matter of quality is far more important than price alone.

I hear more complaints of goods sold in stores where price alone was the main point than from all other sources.

What would you think if a storekeeper who advertised that he was the sole representative of a well-known brand of garments, when in a matter of fact there were two, one a large manufacturer carrying the same line of goods in the same town and having been carrying them for some time? This has occurred right here in Twin Falls.

How do you regard a man doing business supposedly in a regular way, who would conduct a special or "one-day" sale and then, after the sale, advertise by this comparison in a regular way at 50c and resell them under the guise of a big bargain at 65c? This has been done right here in this little city.

What would you think of the methods of a store advertising the best quality of Rockford socks at a special price, when as a matter of fact they were not best quality and hardly a good second quality? This has been done here.

END OF SUMMARY PEACE TREATY

The full text of the peace summary of the treaty was received late for publication yesterday. The remaining portion follows:

The German government recognizes the right of the allies to the replacement for the top and class for class of all personal effects and fishing boats lost or damaged, owing to the war. An additional part of reparation, as a German government agrees to build merchant ships for the amount of not exceeding 20,000 tons gross annually during the next five years.

Germany undertakes to devote her economic resources directly to the physical restoration of invaded areas. The reparations committee is authorized to require Germany to replace the destroyed articles by the delivery of animals, machinery, etc., existing in Germany, and to manufacture materials needed for reconstruction purposes.

SECTION EIGHT Powers for which Germany territory is to be given... Germany is required to pay the full cost of the armaments of occupation from the date of the armistice as long as they are maintained in German territory.

SECTION NINE Germany shall impose no tariff duties higher than the lowest in force in 1914. Germany must give most favored nation treatment to the allies and associated powers.

SECTION TEN The allied and associated powers accept the principle of religious minorities in territories belonging or which to them shall continue in their work under control of the powers.

SECTION ELEVEN Germany must grant freedom of transit through her territory by land, air, water, by means of goods, mails, messages and mails from all allied powers without customs or transit duties.

SECTION TWELVE Germany shall be permitted to hold a debt draft... Germany in addition to more favored nation treatment on her railways agrees to cooperate in the development of a common railway system for passengers and freight.

SECTION THIRTEEN All members of the league of nations agree to establish an organization to promote international adjustment to economic and social conditions.

(October, 1919, at Washington, to discuss the 48-hour day or 48-hour week; prevention of unemployment; extension of the application of the international conventions adopted at Bern in 1896, prohibiting night work for women; and the use of white phosphorus in the manufacture of matches; and employment of women and children at night or in unhealthy work; maximum benefit of aid to children as recipients of minimum pay.)

SECTION FOURTEEN As a guarantee for the execution of the treaty, German territory to the west of the Rhine, together with the bridgeheads, will be occupied by allied and associated troops for 15 years.
