FUTURE PUBLICATION OF THE PEACE TREATY

How futile was the attempt of the Republican senators who a few days ago insisted so strenuously upon the publication of a book purporting to be a copy of the original peace treaty as presented to the German government for signature is indicated by the news developments of yesterday. It has been known for a long time that such resolutions, having partly on the German counter-propaganda and partly upon recommendations of Premier Clemenceau, Premier Lloyd George and President Wilson, were being made. Experts of the several nations have taken account of the German ability to pay, and of the nation's capacity for meeting the obligations imposed by the treaty terms. As Premier Clemenceau said yesterday in addressing the national assembly, the world has agreed that a lasting, just peace cannot be found while people are working for starvation. The German workmen must hear the whole truth of the advice of the interests who have held their destinies in the palm of their hands. The wealth demanded by the peace terms cannot be produced in the counting houses of Berlin, in the national assembly halls, nor anywhere except in the fields and factories of Germany by the working people. The wealth can be obtained from the producers by the financial magnates, who in turn will pay the indemnity demanded by the allies, but the terms finally agreed upon must be such as to leave the producers of the wealth enough to live on, else no real resolution will be reached. The financial magnates will be able to sell, and the allies can trade for their indemnity, or go to war again to collect it.

So moderation in the demands, estimated rationally upon the ability of the workers to produce the wealth necessary to pay and still leave them enough to live on, is the very first essential of a lasting peace. It was to arrive at this nearly accurate figures involving this ability that the experts have been working. It is in the spirit of compelling payment to the uttermost, without throwing the world into anarchistic chaos, that the original treaty terms were modified. As a result of their deliberations there has been evolved a simple, straight treaty, embodying the later findings of the experts. The committee have devoted a large part of yesterday to perfecting and approving this substituted treaty, which will be presented to the Germans as soon as it is printed. When the document is finally approved it will be printed in its entirety and will replace the previous treaty agreement.

What has been accomplished by the senate's fight of the president and the peace conference except to raise false hopes in the minds of the German people that further definite consent can be forced, fostered by the belief that the American nation is not back of the president? The treaty published by name of the senate is not a copy of the document that will be signed by Germany, and not the document that the senate will be called upon to ratify, and not the treaty that will enlighten the American people as to what has been going on in the peace conference. If it is anything, it is the original rough draft as presented to the German nation as a basis for beginning negotiations. The publication did neither good nor ill, perhaps, but the fight on the president has been the fruitful cause for a whole lot of agitation in Europe, which may result in another world war, or world anarchy.

That the administration leaders realize the traffic consequences which may follow, and are following it, the news dispatches are to be given credence, the fight on the president, proceeding to the world, nation divided against itself, is manifested by a conference yesterday in high American official quarters with the peace conference and Senator Hitchcock, acting senate administration leader, followed in the Senate by a series of Democratic statements at which a program was decided on for urging a faith fight to prevent action by the senate on the resolution of that high-minded patriot, Senator Knox of Pennsylvania, which resolution would separate the treaty and the league covenant. The name of the official was not made public, but it is known that he conferred with acting Secretary of State Bloor and with Senator Hitchcock, as to the probable effect of the Knox measure on the peace situation, and that the decision was to fight to the finish any attempt to bring it home to force the senate.

Verily, the senators in Washington who are now trying to make campaign material for the 1920 presidential contest are playing with the most dangerous situation that ever confronted the world. If the world is not made safe for democracy by the terms of the new treaty, democracy will be swept away by something that will be safe any where for itself, but unsafe for anybody or anything else. The Republican senators in fighting the president of the United States in vain effort to make political capital have very largely lost the hinges of the infernal machinery, and have placed the corpse of his statesmanship and his culture as well, upon a helpless world.

STAND BEHIND THE PRESIDENT

Last fall during the campaign the insistent cry of the Republican candidates, aided and abetted by all the "well-to-do" who could afford to, would have been the people protesting their sincere opposition and disapproval of the president. A lot of men, these people took them at their word, and voted to put some of them in office down at Washington. The results are manifested every day now, when, even more seriously than when active warfare was on, the American people should present a united front to the enemy.

Instead of "standing behind the president," they are doing everything in their power to discredit the president as the spokesman of the American people, with results that promise most disastrous consequences. That their failure to keep their word with their constituents should thus threaten the whole world with rebellion, may temporarily cause them to drop their propaganda-prologues propoganda if ever there was any such in America—and really get behind

President Wilson and the peace conference in their efforts to arrive at a just and stable peace. The high-minded patriotism as a candidate is to be commended, but high-minded patriotism as the candidate is to be commended, not the trouble with the Republican politicians is that they regard their platform in the same light as the one William Pitt carried the other platform. He insisted that passengers must go into the car, and not stand on the platform. Upon being pressed by his reason, he insisted it was the rules of the company. Then he was asked what he meant the platform was for if they were not to stand on, and he came back thus: "Well, I tell you, boss, these platforms is made to get in on, not to stand on."

And that is the attitude of the Republicans. Their platform carried the other proposed victorious declaration that they were "truly patriotic." Just try it once more, and they would stand behind the president in the nation's peril. All they wanted was a chance. And a few of them got it. See the results. Instead of standing behind the president they are using their best endeavors to push him overboard, and with him the hope of the world for a peace that will be worthy of the twentieth century.

MEXICO OF MEXICO?

Villa, whose plunder raids and attacks on Americans in Mexico led to a practical state of war, and who, if he had been captured by the United States army when it entered Mexico to get him, would probably have been either a convict or an angel.

Of course if Angeles wins, and Villa reforms, agreeing and keeping friendly with this country, all will be serene. Otherwise, so far as Mexico is concerned, the United States is like the man who swallowed a cash balance.—He was a dollar in and a dollar out, and could not make his cash balance.

Who has not read "The Gold Bug" by that immortal American, Edgar Allan Poe, or "Treasure Island" by that great romanticist, Robert Louis Stevenson? They are classics in the field of literary treasure-trove. Readers will be reminded of both by the new story, "Pieces of Eight," by Richard L. Galliano, which will appear in regular installments in The Times, beginning Wednesday afternoon, June 25.

RUSS ROYALTY

IN HARD LINES TO FIND HOMES

PARIS, June 14.—The Rothschilds, former reigning family of France, are under the darkest cloud in Russia. Series Inroads by Tuberculosis To Be Discussed

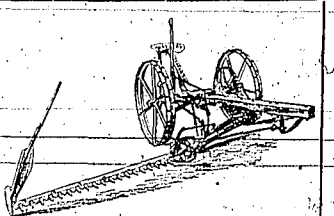

Galloway, Washington. A feature of tomorrow's program will be an address on the growth of the modern health crusade in this country during the war years by Charles M. DePrest, national consumer executive. Under the banner of this crusade more than 2,000,000 school children have been reflected in health activity.
