Strike Ca. Goes To All Of Coast's Maritime Workers

Assistant Secretary of Labor Announces Union Leaders' Decision To Seek Complete Shipping Tieup

(By The Associated Press)
SAN FRANCISCO, Oct. 29—Assistant Labor Secretary Edward F. McGrawy announced tonight he had been informed of a decision by maritime workers to call a strike at mid-night affecting all the Pacific coast's 37,000 maritime union workers.

McGrawy said he had been informed of the strike call by F. M. Kelly, secretary of the Los Angeles negotiations committee, which met tonight to discuss the threatened strike action.

The assistant secretary said Kelly informed him the strike would be called against all three groups of operators on the Pacific coast.

Negotiations fall through as organizing session breaks off here in an apparent disagreement to night, and one federal official said a strike involving 37,000 workers at midnight, appeared likely. "It looks like a strike," said Assistant Labor Secretary McGrawy, who attended the conference.

McGrawy, who said he probably would communicate by telephone with Washington, would not reveal details of the conference, which involved the crews of the coast's 37,000 maritime workers.

It was indicated however, the off-shore operators refused to negotiate "fundamental issues" of the strike, involving demands for post-employment union hiring and cash instead of time off for overtime.

The more toward the threatened strike was expected after a meeting of the joint union negotiating committee, representing all major maritime unions, called for D. M.

The committee is empowered to call a strike of all the maritime workers, or declare a walkout against one group, such as the off-shore operators, leaving the other employer groups, the coastwise freight operators, and eastern and foreign shippers free to continue regular operations.

14-Hour Armistice
The shippers' association, of the United States Pacific Coast, said it is ready to accept a 14-hour armistice, with the sailing of the ship to be delayed until after the mariners cook and stewards. After that strike, a strike call for that midnight was postponed.

Operators of eastern and foreign lines awaited reports from the inland.

LOYALISTS OF SPAIN REGAIN THREE TOWNS

Socialist Troops Smash at Tighening Fascist Lines South of Madrid, Government Reports Declare

(By The Associated Press)
MADRID, Oct. 29—Spurred by reported reinforcement of tanks and aviation, Socialist (leftist) troops smashed at Fascist lines south of Madrid, the war ministry said tonight.

The government counter-attack against an insurgent reapture of three strategic towns, the leftists reported, Socialist officials claimed.

(Government reports were not confirmed by officers from the Fascist side of the lines where the fight against Jose Varela were being fought.

The government counter-attack was reported to have shattered the last of a Socialist assault near Chaparral, 25 miles west of Madrid, where the insurgents high command declared.

More Out at Dawn
Beginning at dawn in response to a militant proclamation by the leftists, Socialist troops, the Socialist militiamen advanced rapidly southward along the Madrid-Madrid highway, retaking Torrejon de Arcaz and Torrelodun.

East of the highway, other forces drove Fascist warriors from Escama, just west of the Madrid-Aranjuez road and approximately 19 miles south of the capital.

Insurgent commanders continued to consolidate their forces in the Madrid area, marshalling 200 "baby" tanks and armored cars for prospective drive against Madrid.

(U. S. A.) reported pushed ahead into Humanae De Madrid's small settlement about 10 miles southwest of the first city, the high command asserted. Other columns moved between San Diego De Los Angeles (Mills of the Angeles and Pinto on the Madrid-Aranjuez highway).

ONE MAN DIES, SIX INJURED IN FLIVER WRECK

Ten of 13 Cars Leave Rails When Pennsylvania Train Breaks in Two, Blocking Four-Track Main Line

PRINCETON JUNCTION, N. J., Oct. 29—One man was killed and six others injured tonight when the Cleveland, crack Pennsylvania railroad flyer, was wrecked here, blocking the railroads four-track main line.

Ten of the 13 cars, mostly Pullmans, left the track.

The train broke between the 17th and 8th cars and the engine, traveling at 75 miles an hour, dragged the forward seven cars almost a pole.

The man killed was riding in the 7th car which was dragged on its side and crushed.

E. Z. Donjee, of Westchester, Pa., said he saw the man killed when he was sitting beside him in the 7th car after his shoulder.

The wreck occurred at 9:00 p. m. one-quarter mile south of the Princeton Junction station. The wreck tipped up a quarter-mile of track.

It came three days after a Pennsylvania railroad freight train wrecked near West Park led up the main line.

When the seventh car in the line left the track it smashed into the piles of the piles supporting the electric wires used by electric locomotives, the impact bent the steel car.

One of the injured, Russell L. Davis, of Franklin Institute, Philadelphia, who said he was riding behind the man killed, said: "I was sitting in the 7th car when it was hit by the engine and pulled me out of the wreck."

Landon Demands Answer By President To Question Of Stand On Constitution

Republican Nominee Receives Ovation In N. Y.

MADISON SQUARE GARDEN, NEW YORK, Oct. 29—Governor Alf M. Landon closed his eastern campaign tonight with a personal demand before tumultuous crowds that President Roosevelt state "his purposes and intentions" toward the constitution "be more up to speed."

Summarizing his contest to oust the new deal and presenting his own "point" political creed to voters, the Republican nominee told a shouting, gala waving throng over the shouting arena, the 18,000 seats the Madison Square Garden "responsible for nine acts declared unconstitutional" and other actions, strikes at the heart of the American form of government.

Challenges to President
"Forty-eight hours from tonight, standing where I am standing, there will be a president of the United States who is not up to speed."

Challenging Repulsion
A defiant, steam-raising reception greeted Landon when he appeared on the speaking platform for his last personal effort to win New York's electoral college votes. Many Times Landon sought to begin his address before the cheering throng but he was cut off by a cheering throng.

In a dark, pin striped suit, soft spoken, Landon stood with white gloves and white shoes at the speaker's stand decorated in red, white and blue flags and emblems. He was flanked by his son, his wife and party leaders—John D. Hamilton, national chairman; William E. Miller, state chairman; and Governor Landon, who stood up to greet his arrival.

Gauche of Confidence
"The people of this country will not trust a man who lost his trust them," Landon said in making his challenge. "If he trusts them he will answer the question being asked: 'How long will he stand up to the other?'"

Gallant Fight For Boy's Life Proves Futile

CHICAGO, Oct. 29 (AP)—The revival that evoked nationwide interest in his case today resulted in death for seven-year-old Phillip Little.

Five blood transfusions, a flood of medical attention, the pleas of a plea of friends of aid failed to bring the boy back to life. During his four month siege, scores of persons in all sections of the United States begged an opportunity to give some of their blood to the boy.

He volunteered by letter, by telephone, by telegram and in person. He was induced into membership in some one of his kind by the boy. His malady was mysterious.

His mother, Mrs. Julia Little, 3-year-old son of City Commissioner R. Mack Oldham, Lexington, Ky., refused the specific diagnosis of the boy's illness. She reported that the boy was tapped during his 13 day mission of mercy. Little Phillip rallied, but five days ago the infection entered about his heart caused another sinking spell.

William Purman, 34, unemployed Chicagoan who had survived a similar attack, gave a transfusion, then, in a final desperate effort, the father, Morris Levitt, an insurance broker, submitted to a transfusion for his son yesterday.

POTATO SUPPLY AT RECORD LOW MARK

Smallest Crop in Decade Reflected in Rising Prices

CHICAGO, Oct. 9.—The 1936 double potato crop, planted by the department of agriculture at around 322,450,000 bushels, based on October 1 conditions, will be the smallest with the possible exception of 1933, in a decade, and afford the shortest per capita supply on record.

Normally, in short-crop years, prices of potatoes reach their seasonal low point in October, and then rise to a greater level than during the latter part of the season. Present Chicago prices, evidenced by the range of the current Chicago-Mercantile Exchange futures contracts, which recently moved into new high ground for the year, in the spring of 1935, following have ranged double or more the average earlier price a year ago.

In the spring of 1935, potatoes went to \$20 a hundred pounds, that market registered a top of \$7.

STEPHAN BARRAGES BOURBOONS' CLAIMS

Republican Nominee Scrutinizes Administration in State

BURLEY, Oct. 9.—Five phases of Democratic claims were barraged here tonight by Frank L. Stephan, Republican nominee for governor.

In an address before a large audience of Cassia county citizens, the Republican nominee attacked one after another of the opposition's claims of tax reduction, credit for the reduction of the state bonded debt and interest, efficient highway development, economy in government, and development of the state's natural resources.

No Credit Earned

"In not a single one of these matters has the Democratic party earned any credit," the speaker declared. "On the contrary, the party, particularly with reference to taxes and economy, to show that the past six years of Democratic administration have been the most wasteful and extravagant in the history of the state."

Mr. Stephan declared that instead of reducing taxes, the present administration, starting in 1931 or 1932, has enacted by recent sessions of the legislature, has practically doubled the cost of

state government to the taxpayer during the past four years.

Eliminating Taxes

"In 1933 the total taxes, both direct and indirect, collected by the state amounted to \$4,924,774.16," he said. "On the other hand, for the current year of 1936 will be an estimated total of \$8,000,000. Seeing these figures in mind, it is difficult to see how my opponent can promise a reduction of taxes in the future."

Turning to the matter of the state bonded debt, the speaker explained simply that at the time those debts were created the legal machinery to pay them off was set up.

"Thus the reduction in debt and interest is nothing more or less than an indication that these obligations were paid when they were due. The opposition must be desperate to try to claim credit for that," he said.

He charged that the people's money is being wasted in the operation of both the attorney general's office and the liquor commission.

Natural Resources

Touching briefly on natural resources, Mr. Stephan asserted that very little development of these valuable assets to the state has been achieved under Democratic rule. "Should millions have been squandered by the federal government during the past four years," he said, "and much of this money has been spent in our neighboring states for irrigation development, but only a look at the records is needed to show that Idaho has received only a few paltry thousands of this money. Certainly that does not constitute a record of development in which my opponents can take any great pride," he asserted.

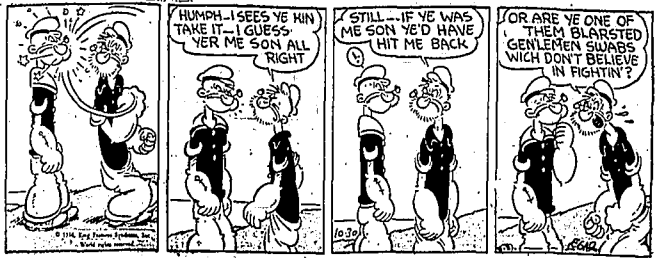

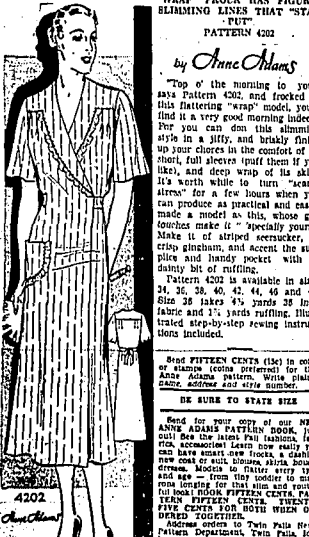

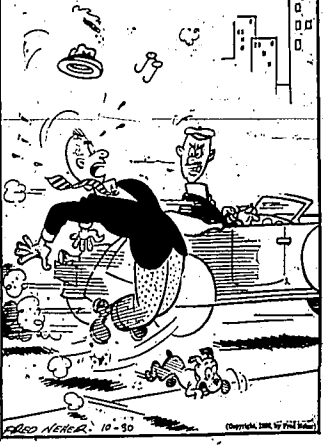
