Battle on Ratification of Peace treaty Begins in Week or Ten Days, Says Lodge

BITTER PARTISAN FIGHT INDICATED BY REPUBLICANS

Administration Forces Feel Confident Treaty Will Be Ratified Without Reservations—Opponents Equally Positive It Will Not Get Sufficient Support.

WASHINGTON, Sept. 5.—A week or ten days may elapse before the treaty of Versailles, as amended by the senate foreign relations committee, is taken into the senate for ratification, according to the majority report.

Lodge will begin at once the preparation of the majority report which will point out the amendments which will be made to the treaty.

Several days probably will be occupied by Lodge in preparing the report. Lodge also pointed out that the voluminous document will have to be reprinted, so that it may include textual changes.

More time will be consumed by the preparation of a minority report by the administration senators on the treaty.

By the week after next, the final fight over the treaty is expected, however, to be in full swing in the senate.

The four amendments are just an indication of the nature of the textual amendments, Hittcock said.

The actual value of business transactions continues at an extremely low level, and the situation is not likely to improve until the transportation difficulties and shortage of labor have been hampering business.

On the whole the agricultural outlook was "found distinctly less favorable" than it was a month ago, although the larger acreage now in certain crops will compensate for the decreased yield per acre.

IMPROVED UNIFORM INTERNATIONAL SUNDAY SCHOOL LESSON

By THE REV. P. H. STEWART, D. D., President of the Board of Christian Education, Public Institute of Chicago

LESSON FOR AUGUST 31

SELF CONTROL (Temperance).

LESSON TEXT—ROMANS 12:1-2. GOLDEN TEXT—"Every man that loveth his neighbor as himself loveth himself." 1 Cor. 13:4-7. ADDITIONAL MATERIAL—Romans 14:1-13. PRIMARY TOPIC—Keeping our hearts from being defiled. SECONDARY TOPIC—The story of a boy who was a temperance hero. INTERMEDIATE TOPIC—A learning lesson. SENIORS AND ADULTS TOPIC—Securing the secret of success.

It is somewhat strange that the lesson committee should select this Scripture as a temperance lesson, for it says nothing about temperance as ordinarily understood. Total abstinence from intoxicating liquor is forbidden by the law of every Christian's life, but it is not so taught in this Scripture.

1. Daniel Tereed (ev. 57). Daniel, child of tender youth, was torn from his mother and made a captive in a foreign land to be trained for service at the royal court. In order to be of the highest service it was necessary that he be brought to love the king and nation, and be detached from his own people and religion. To accomplish this duty:

1. Anticipated his duty previous to the king's meat and wine (v. 2). This was for a twofold purpose: (1) To make the good will of Daniel manifest to his friends. Such recognition would encourage them to give themselves up to the king's service. (2) To supply them with food delectable to their physical and mental development. To partake of the food offered was against Daniel's religion. His conscience would not allow him to partake thereof. Doubtless the meat and wine had connection with heathen feasts.

2. Changed name (v. 7). The object of this was to obliterate national and religious connection, and to identify them with the heathen people. Daniel, which means "God's judges," is a Hebrew name, meaning "He's perfect; He's strong," which means "The gift of Jehovah," which is "Shadrach," signifying by the sun god Bel Shazzar, which means "Who is as God," to Meshach, meaning who is like the Babylonian Shadrach, signifying "The servant of Jehovah is our help," to Abenezer, meaning the servant of Negro. He held this change of name was the attempt to make an impression upon the king, these young men the name of the true God and to cause them to lose their place of separation.

3. Daniel Standing the Test (v. 8-14). Though a captive in a foreign land, Daniel purposed in his heart that he would not defile himself with the king's meat and wine. His heroism was such that in his trying hour he had the decision of character to stand firm in his own position. He was the detester of his conscience. While unflinchingly loyal to God he did not lose his gentlemanly courtesy. He was requested to be tested ten days in the food which the law of his God allowed, agreeing to abide by the results. Loyalty to God and conscience need not interfere with gentlemanly behavior.

4. Daniel's Reward (v. 15-21). 1. Physical health (v. 15). "Gently and temperate living ways. The king's meat and wine would have been very palatable, but to have partaken would have been a compromise with his conscience. The statistics of self-control, that is, temperance, are of the highest importance, and also improved his physical health. 2. Mental growth (v. 17-20). It was ten times the superior of his associates. 3. Spiritually (v. 19). He stood before the king, not only as the king, but also being president of the college of wise men, and prime minister of the empire, continuing through several dynasties (v. 21). 4. Spiritually (v. 17). God revealed to him Nebuchadnezzar's dream and gave him visions stretching across the history of the world. The secret of Daniel's success was (1) conscientiousness; (2) loyalty to God; (3) decision of character; (4) firm certainties; (5) diligence; (6) courtesy.

Public Forum

In a previous article we pointed out conclusively that it is competition in service and not competition in price that will settle the U. S. L. and remove the trouble between capitalist and labor. We pointed out also, how this could be brought about.

Price fixing as a means to the end sought, depends upon certain primary essentials or principles, which cannot be ignored. To ignore any one or any part of any one of them spells failure to cure the disease. It might be palliative, and render temporary relief as a medicine to a patient, but would not cure the patient. The first and important, if not the most important, is sufficient supply for all day labor regardless of supply and demand, or of the sex or the kind of work. Clean work as much as work of dishonorable work, if there is, such as in the case of agricultural operations, as much as professional, unskilled as much as the skilled.

Now it is quantity and quality of service in junior or teacher that counts for the teacher, not the number of pupils, as an consumer or a taxpayer also. This is service with price fixed, no junior or teacher, who had the advantage of a teacher, would work by the day, but by a month, and the teacher being greater proficiency in producing quantity and quality, less pay and distinction in that of some other calling for the same kind of work.

If we are to be governed by the unchangeable and irrevocable law of the brotherhood of man and the brotherhood of God, as Jesus taught, we must change our aims on this point. What we want, and what God intended us to have, and what Jesus taught us must have, is the liberty of free and equal opportunity. Providing day labor and skilled service, does this.

God does not believe in paternalism, and Jesus never taught it. If all the things that God made are worthless in it paternalism, just give to him and he will give to him if you want to ruin him. The more he gives for nothing, the more he wants for nothing.

What we want is the liberty of equal opportunity with all men in our struggle. Sept. 3, 1919.
