NEW YORK, March 17.—Athletic officials of the United States representing fifteen sport bodies met here today with the American Olympic Committee to outline some of their plans for preparing Uncle Sam's Olympic team for the games to be held at Antwerp, Belgium, next summer. The meeting went into session at the New York Athletic Club, this afternoon.

It is believed that the American Olympic Committee, of which Gustave T. Kirby is president, will adopt plans which will make up for the loss of which will go away with much of the conjecturing that has been prevalent in the discussion of American Olympic matters to date. At least, some thing tangible in the way of definite plans is expected.

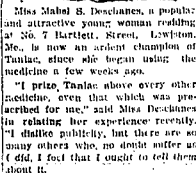

"Offering to forgive and forget if his wife would not confide in him her misdeeds of the past," John W. Best has a novel titled "The Woman" which is a discussion of guilt from the wife and then used the knowledge gained in this way to secure a divorce.

Barron, of Green, La., 97; Mrs. Sarah Fowler, of Dallas, Texas, 96; Mrs. Mary Stamp, of Carnesville, Tenn., 96; Mrs. Sarah Gordon, of Mayville, Ga., 95; Mrs. Elizabeth Summers, of Newnan, Ga., 95; Mrs. Almina Swallow, of Norman, Oklahoma, 94; Mrs. Julia F. Howard, of Benton, Arkansas, 93; Mrs. Miss Stephens, of York City, Florida, 94; Mrs. Emeline March, of St. Juliet, Tenn., 93; Mrs. Evaline Williams, of Sylvan, Ga., 92; Mrs. Sarah A. Hemphill, of Athens, Ga., 103; and Mrs. Dicy Lewis Crosby, 97.

### GUN SALE SHOULD BE CHECKED

Restriction of the sale of firearms is demanded in every community in this country. There should also be amendment of state laws, so that laxity in this matter in one state may not undo the good which is accomplished by stringent regulations in another.

At Montauco, Wash., ten men, alleged members of the I. W. W., were on trial for the murder of a young man during Armistice Day riots. The defense complained to the presiding judge because state troops were called to guard the court room during the trial. The judge refused to interfere because of information given him which seemed to point toward armed interference by friends of the accused. Among other evidence submitted was the statement that 600 high-powered rifles had been sold in that section of Washington during a period of two and a half months, where the average sale of such weapons would not be more than 100.

Even were there no such disturbing situation as in Washington, the sale of 900 rifles would be a suspicious and alarming thing. Whatever the charge brought, the intention is toward rifle sale rather than rifle by law. So long as anybody who wants a gun can walk in and buy it unquestioned, there will be gunplay.

It is sometimes necessary to curb violence by armed force, but there are laws covering this necessity. Prompt execution of the law will help to do away with mob rule and individual showings, but restricting the sale of firearms will do more. If the bad men cannot get guns the good men will not need them.

### THE PROHIBITION SUIT

The prohibition case now being argued before the supreme court of the United States is deservedly receiving a large amount of public attention. It is fortunate that the suit brought by the state of Rhode Island, to annul the federal dry amendment, is being handled so promptly.

The plaintiff's brief covers a great deal of ground, including the validity of the congressional act submitting the dry amendment to the states, the validity of state ratification, the validity of the resulting proclamation declaring the amendment adopted, the validity of the enforcement law giving enforcement authority to federal and state governments, and the validity of alleged confederation of supporters.

The court may be expected to pass definitely on all of these points. It may also hand down opinions elucidating certain disputed points involved only indirectly, for example the right of congress to place the "Intoxicating" alcoholic limits as low as it has done in the enforcement act.

There is little expectation in most people's minds that the court will interfere in any substantial way with the main purpose of prohibition. It need surprise no one, however, if some minor changes are made. In any event, an early and comprehensive decision is desirable from every standpoint, in order to clarify a situation that is now full of confusion, conflict and discontent.

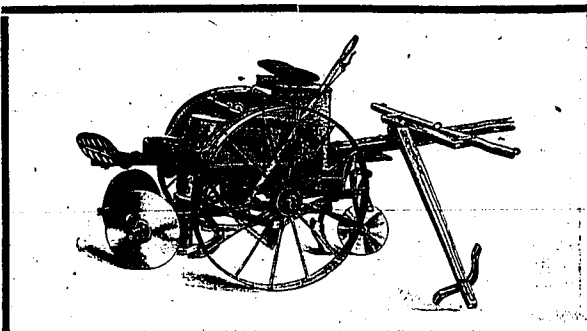

STAGE FRIGHT IS THE BANE OF DESCHANEL

PARIS, March 17.—President Paul Deschanel is one of the greatest orators of the day in France, but he is always suffering from a kind of "stage fright" when he rises to make a public speech.

"The waiting is awful. I always feel ill before I go to the tribune, but when I am there I feel a relief all the same every minute is precious. In the Chamber, just as on the battlefield, it is victory or the gallows."

Deschanel was with all the aid of the orator, a majestic presence. He is an extraordinary orator—calm, imperable delivery and diction. M. Deschanel is always a calm and collected speaker. He is less of a debater than his predecessor, Mr. Poincaré, which is probably due to the fact that his function is that of President of the Chamber, which position he held for many years before his elevation to the Chief Magistrate of the Republic.

"For me," wrote M. Deschanel to his friend Agon, "there is no such thing as a speech. I am only a man that I am obliged to write my speeches beforehand, but I must not write them in a hurry. I must think deeply before speaking."

It is impossible for me to speak. Very often the clearness of my pronunciation gives the illusion of abundance of language. I say that I have an illusion because it has happened that I have had to correct faults of syntax when I have reviewed my speeches for the second or third time. The words I remarked to me: "Oh, you have nothing to correct in that speech." But I have found several faults and not slight imperfections of syntax but of a faulty choice of words or expressions. And always the clearness of my pronunciation covered up the mistakes.

Once I have my work in mind I do not know what I am doing. I am walking all the time. I am speaking of prepared speeches, but my mind is not turned over in my mind during a walk, in the country, without the aid of pencil or paper. The words rise and walk with you."
