### THE "FARM PROFITTEERS"

The farmers are getting restive under repeated charges of "profiteering," and are producing facts and figures tending to prove that they are not making fortunes out of the necessity of city folk. In fact, it is they who are being exploited. They admit having made more money than usual for a couple of years during the war, while prices of foodstuffs were rising and their own expenses had not yet risen accordingly. But that time is past. Today nearly everything the farmer buys seems to have gone up about as much as his own products have, and his production is hampered by inability to get help.

These facts are substantiated by investigations made by the United States Department of Agriculture. A particularly thorough inquiry has been made in the essentially agricultural state of Iowa, to see whether the charges of profiteering there was justified. Attention had been attracted to Iowa because of the land speculation there.

It was found that outside reports of land prices and farmers' profits were greatly exaggerated. It has been said that "for nearly selling at \$200 an acre" has gone up to \$500 or more an acre, with the farmers reaping a profit on their products sufficient to make good this "inflated capitalization." The federal investigators find that land has not sold near \$30 an acre for 30 years; that the average selling price of good Iowa farm land now is not more than \$250 to \$375 an acre; that the profits of speculation have been made mostly by city people; and that as a general proposition, the higher values merely mean higher taxes for the farmer to pay.

The average net income of a large number of Iowa farmers for 1918, which was "good year," was \$3,480. Allowing 5 per cent for interest on the investment in land and equipment at prices prevailing before the recent speculative boom, the Department finds that the average farmer in the richest part of Iowa had left only \$1,121 to pay for his own labor and the risk of the business.

If interest is reckoned on present values, there is hardly anything left in a normal year for labor and risk. Or if a fair allowance is made for labor and business risk, there is little left for interest. In fact, when farmers make an unusually good showing it is generally for this very reason—they do not figure interest on their investment as any other business man does.

### LITERACY TEST IMPRACTICAL

The literacy test for alien seeking admittance to this country has been weighed in the balance and found wanting. A record has been kept by immigration authorities which proves that the test undoubtedly reduces the number of those who seek entrance here, but the falling off is among the kind of folk whom the United States needs, and could safely welcome. The farm laborer and domestic servant all too often cannot pass this test, and knowing they must face it, they stay away. On the other hand, thousands of undesirable can pass with ease, and they are the ones who enter the country.

Farm laborers and domestic servants are needed here, and would not compete dangerously with any laboring class in this country. Obviously it is a mistake, other guarantees and prospects of behavior being good, to keep them out because they cannot read a few ordinary English words. They could be taught to read later on. As has been pointed out many times, the thing to do is to combine immigration bureaus here with similar bureaus abroad; to make immigration a matter of applications, with references which can be verified to a fair extent, and then, when the immigrant arrives in this country, to make his residence conditional on good behavior, educational advancement and the like. If we are reasonably sure when they were before they came, and if, in connection with a helpful policy we keep informed as to what they do in each community after they get here, we shall come near to intelligent elimination and assimilation.

In spite of all this phenomenal growth of population, there are still quite a few towns in the United States that do not need highways and elevated lines just yet.

#### PICTURES ARE NOT ALWAYS TRUTHFUL

Some Mail Order Houses Find Them Very Useful in Their Business.

#### CAN "DOCTOR" PHOTOGRAPH

Concerns Can Give Wrong Impressions With Illustrations While Sticking to Truth in Descriptions.

"Figures never lie," "pictures never lie," but this is far from the truth. The definition of "pictures never lie" is such a way that he has escaped detection for years. This that figures can be made to lie. Know the statistician, who knows how to make a table to say that is far from the truth.  
But there is another medium of expression which is also supposed to be a reliable for truth, but which is a greater deceiver than figures. That is a picture. A picture of any person or thing, supposedly, is an exact reproduction of the original, but this is frequently only a wild appearance. The photographer who did not make his pictures tell a little bit more and then would soon be out of business for lack of patronage.  
Pictures Better Than Words.  
Pictures have come to occupy a very important place in the life of the world in recent years. It has been said that for newspaper purposes a picture which tells its story strikingly is worth more than columns of written words on the same subject. Newspapers and magazines have realized the truth of this fact and as a result pictures are used profusely in illustrating the news and fiction of the day.  
One has been quicker to realize the possibilities of the picture when properly used, than the mail order merchant. He has realized that a picture will do more to sell his goods of merchandise than a column of words and figures. One reason for this is that it is harder to catch a picture in a lie than it is printed words and figures. For instance, if you sell a man a table on the strength of a printed statement that it is 48 inches wide and if when the table reaches the customer it is only 32 inches wide, the customer not only loses a moral right in life, but he has a legal right to accuse the seller of obtaining money upon false representations.

#### PICTURES ARE NOT ALWAYS TRUTHFUL

Some unscrupulous mail order houses have taken advantage of this selling power of pictures in a dangerous way. They adhere strictly to the truth in the actual measurements given in their catalogues of the articles which they have to sell. They may employ descriptions which exaggerate the qualities and appearance of the articles offered, but when it comes down to actual measurements the descriptions given are technically correct—throughout.

A former manager of a mail order house tells how his concern manipulated pictures in this way to suit its purposes. It had pictures of its chairs repositioned so that the legs seemed to be an inch and a half in diameter, when they were really less than an inch. It made narrow beds appear in the picture to be wide and comfortable. Posts of iron beds that were really an inch in diameter were made to appear as if they were three inches in thickness. These things are easy for any competent artist to do.

This concern, however, adhered rigidly to the truth in the measurements included in the descriptions. Customers who found when they received their goods that they were not what they expected, could kick, but it would do them no harm. The small artist's house could show that it had set forth the measurements truthfully in catalogues, and there was no recourse for the customer.

There is no question but that pictures will lie, sometimes without any manipulation, and the person who buys an article of merchandise from a picture is taking his chances, even though the picture is not intentionally altered to give a wrong impression. Any amateur photographer knows from experience how the camera often will give a wrong idea of proportions.  
The only safe method is to buy from the local merchant where one can see the article first and not a picture of it. The artist's hand cannot lie about its dimensions, at least.
