

REPUBLICAN DEADLOCK BROKEN ON TENTH BALLOT

Recess Leaves Convention in Turmoil of Uncertainty

Longest Deadlock Since 1880—Drift to Harding Candidacy Seems to Be Gaining Momentum—Break May Come Late Today

OHIOAGO, June 12.—After four unsuccessful ballots, eight in all, followed by the marked progress made by Senator Warren Harding's forces, the convention recessed at 1:37 today until 4 o'clock this afternoon in a tumult of excitement and disorder. Pandemonium reigned in the Coliseum as the recess was taken. The crowd yelled, the band crashed, no one could hear and some of the delegates evidently voted for the recess without realizing it. It was the Lowden people who asked for delay this time; A. T. Hart, floor manager for Lowden, made the original motion. Harding had gained consistently in the four ballots taken this morning. Most of his votes were taken from Hiram Johnson of California, who last steadily until the balloting. Rumors flow thick and fast that the trend toward Harding meant his final selection, though Governor Lowden gained in the eighth ballot, taking strength from General Leonard Wood.

"No, it will help them; that's why I wanted it." "Why everything, the whole situation. Missouri had come in Harding's support with 17 1/2 votes on the eighth ballot and Wyoming's 6 went along for him. He had received none of these votes previously. "Texas gave him 8 1/2—how formerly he had received none; New York gave him 2; Indiana swung 21 to him and there were dribbles from other states in twos and threes. "Pennsylvania stood just the entire morning. Of her 78 votes, one went to Philander C. Knox each time and the remaining small block of 75 went to Governor William H. Murray. "Not since 1880, when eight ballots were required to nominate Benjamin Harrison, had a republican convention dragged so long in selecting a standard bearer as today. "After the ballot had been taken the Harding leaders said that they would create an uproar by announcing a change in the state's vote. "It was learned that the Missourians voted to three votes to Harding. One delegate blocked the attempt. "Cries of 'recess' were heard from all parts of the floor after official count was announced. Several leaders of Wood and Lowden forces urged Lowden to order adjournment. "The Harding leaders said that they would fight the effort to recess. OLD GUARD SUCCEEDS IN FORCING ITS WILL ABOVE PREFERENCE OF VOTERS AT PRIMARY

CHICAGO, June 12.—SENATOR WARREN G. HARDING, OF OHIO, WAS NOMINATED ON THE 10th BALLOT TODAY. HIS NOMINATION WAS ASSURED WHEN 50 OF THE PENNSYLVANIA DELEGATION JOINED THE LANDSLIDE THAT STARTED FOR HIM ON THE PRECEDING BALLOT.

Col. Murray threw her 26 to the next man and the crowd was wild. Then came Louisiana with Kansas delegates started a demand for a recess. 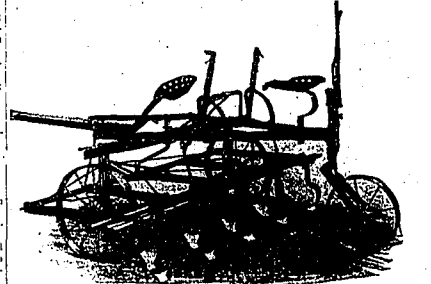
NEW YORK, June 12.—Two baffling crimes that contain all of the elements of a Sherlock Holmes mystery confronted the New York police today.

SUGAR HOUSES HOLD GREAT SUPPLY

\$75,000,000 of Commodity Is Found Stored in Chicago

By JOHN P. DELANEY CHICAGO, June 11.—A near trail—a pathway through the Chicago warehouse paved with approximately 75,000,000 worth of cane sugar, millions and millions of pounds—leads in and out of every dry storage warehouse in Chicago, into the switching yards behind the warehouse, into the freight terminals, out onto the tracks, down the tracks to railroads, on to a barge, into heavy-laden vessels and into refineries.

Every vehicle, whether it be hand truck, motor truck, horse-drawn wagon, automobile, freight car or steamship, is packed with sugar. Incoming freight cars by the hundred repose on the railroad tracks for from fifteen days to a month, with millions of pounds on board.

One could hardly trace a truck at random in the warehouse district without having the mischievous hand of a million pounds of sugar laid on it.

With the millions and millions of pounds of sugar condensed to sugar brokers, manufacturers, fruit canners, soft drink manufacturers, breweries, canneries and packers out is amassed at the annual amount of sugar reported to be consumed by the reputable wholesale grocers who make it a point to net their sugar into the hands of the retail grocer and thence to the public.

Out of one lot of fifty freight cars, double double, in some cases, with sugar was found in one or two cars were consigned to wholesale grocers.

On the other hand, in the same lot, sugar brokers, manufacturers and others who have or take no opportunity to all the public in the retail of their so-called "sugar shortages" were receiving the lion's share of the shipments.

In the West Side Warehouse at Grand avenue and the river there are millions and millions of pounds of sugar owned by various brokers and also by packers.

Walter Fox Brokerage Company, sugar brokers, have placed in this storage house alone within the last three days 30,000 packs of sugar, or 2,000,000 lbs.

On the same day the last of this shipment came in a freighter of Duluth, from the ship's owners refused to disclose the name of the broker that was receiving the same.

At the same time there were nearly 5,000 sacks of sugar in the warehouse. The same day 7,000 sacks of sugar were received at the docks by the Hering & O'Leary docks by the Peter Schoenhofen Brewing Company.

In the warehouse of Griswold at West side there are five to ten five-ton cartloads of sugar owned by Punta Brothers, which the Government has seized.

Millions of pounds of sugar were also taken from the Terminal Warehouse where the I. Wall Commission Company has its warehouse.

There is a large factory on the river, the large consignments of the sugar supply of W. A. Hatemeyer & Co. sugar brokers, was found. Other sugar was found in the docks and the indication of the length of time the sugar found there has been in storage was given by the date of the invoice.

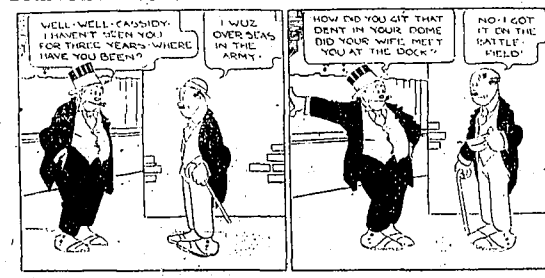

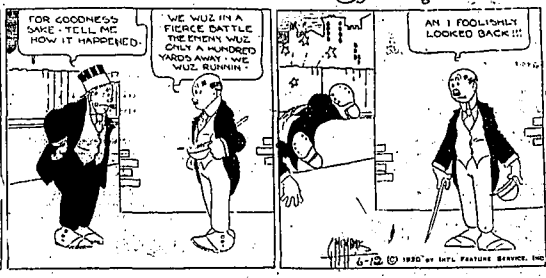

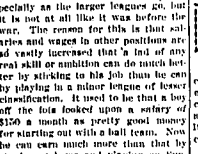
YOUNG BALL PLAYERS DECREASE IN MINORS

NEW YORK, June 12.—(Nationally known American Jews sailed today for the Lapland for London to attend the international conference which convenes July 4, considered one of the most important gatherings ever held in Jewish history. Capital of the Mail Order House Is Furnished by Its Customers.

WORKS ALWAYS ON 'VELVET'

Buyers Supply Money to Support Enterprise—Competing With Those in Which They Are Interested.

It is a mighty nice thing to be able to do business on the other fellow's money, but there are few people who can do it. Probably the only business man who, as a class, are able to do this, are the mail order men in the big cities.
