**AN ORDINANCE OF THE CITY OF TWIN FALLS, IDAHO, DECLARING IT TO BE UNLAWFUL TO SPREAD, SPREAD, OR LEAVE UPON THE HIGHWAYS, STREETS, AVENUES, THROUGHFARES, PUBLIC PARKS OR PUBLIC PLACES, ANY SUBSTANCE, EXCEPT IN ACCORDANCE WITH A PERMIT FROM THE MAYOR OF SAID CITY, OR SAID CITY, OR FROM THE BOARD OF TRUSTEES OF SAID CITY, EXCEPT IN ACCORDANCE WITH THE REQUIREMENTS OF THE PERMIT FROM THE MAYOR OF SAID CITY.**
