THE UNEMPLOYED

In the language of the street, Congressman Addison T. Smith said "a month left" when he declined to The Times yesterday that "the greatest question confronting the country today is the unemployment of over five millions men in the industrial centers."

Not alone is it the greatest problem that confronts the nation today but it is one of the greatest that the nation has ever faced. "There is an old saying but 'Hunger knows no law.'" It is safe to assume that there are more than five million men want work, that they would be willing to take, at least the majority of them, any work that would mean food, clothing and shelter for them and their who depend on them. Yet this is denied them with winter coming on. No wonder that Congressman Smith says it is the greatest question confronting the country.

There is something radically wrong with our system when the richest nation in the world cannot, or will not, provide for work for those who wish to work.

The president has called a conference at Washington to consider the question. It is hoped that the conference will be quick and loud on action and short on talk.

PROTECTING WILD LIFE

Marked improvements in federal and state game laws during 1921 are reported in a summary just compiled by the biological survey of the United States Department of Agriculture.

Perhaps the most noted improvement, at least to every trapper, but not to the "pot" hunter, is the growing tendency on the part of the lawmakers to reduce to a minimum, or eliminate altogether a practice that has long done much in the past to reduce every year, the number of migratory birds and big game. We refer to the practice of hiring a guide and then expecting him to get the limit for one or all members of the party. It has not been an unusual thing for some guides to get the limit for members of the party which engaged him while the fellow who carried the license had not gone a dozen yards from camp; nor has it been unusual to share some parts of the country at first, for a guide to get the limit for a half dozen or more in one day. We have known of some guides who will guarantee the limit to so many as wish to hire him at so much per.

Under an amendment to the migratory bird law it will be necessary in the future for the hunter to report the number of birds that he may have in his possession that was killed by others than himself. Briefly this means that if the law says "twenty-five ducks a day," the guide will have to quit killing when he has got his bag limit.

We do not know how the new changes will suit some men but we do know that unless the lawmakers in the majority of the states wake up and enact more stringent laws and the officers enforce these laws as now on the statute books, it will only be a few years before there will be little or no wild life as a heritage for future generations.
