## NEXT GOVERNOR OF IDAHO SHOULD COME FROM TWIN FALLS

The two Territorial and Two Republican State Meetings—Held at Twin Falls—For Far Blasted Place in State of Idaho—Not Known That Any Work Accept the Place.

In the meeting the citizens, fancy turned to thoughts of policies, an star, yet, Andrew, Henley, etc., have been unable to wholly divert popular attention from the state situation. There are no less than three delegates from the state, and one friend in the county for offices.

### The Delegates

For several years, a number of Democrats have been expressing the desire that the state should have a great government, having the initiative, leadership and ability to manage its own affairs. This is the reason that they have resolved to take up the more active and progressive practice of law in Twin Falls, and to do all they can to help the older, existing, the rare, last, remaining efforts to make his national commitment for the Democratic party. He has done his best, and it is not known that he has in the least degree changed his attitude toward the idea of refraining

from again running as a candidate for the position. Judge Howell is head of the Woodrow Wilson Foundation for the state, and he is the principal speaker at the meeting on the birthday of Jefferson, April 13.

W. A. Alward, vice-president of the Idaho State Federation of the Wheatonites, is another man talked about. He was the choice of Twin Falls for the first time, but always taken an interest in Democratic movements. Mr. Alward is a successful farmer. It is thought that he will be a good name to be used in connection with the gubernatorial year.

President Asher W. Wilson, of the Twin Falls High Court Department, is another man who has served his public business man, a good lawyer, and a good minister. His friends think that he would make a great governor.

John W. Graham, a prominent

Marion Martin, a lawyer, who formerly served this country in the upper chamber at Boise, is another Republican who has been talked about.
