## BULLET OF ASSASSIN FATAL TO IRISH HOPE

*Michael Collins, killed in County Cork by irregulars while on tour of inspection; No outstanding figure remains.*

DUBLIN, Ireland.— Fighting is the head of his staff officers against Irish rebels who kidnapped his car on the road to Cork, Ireland, Michael Collins, Ireland's leader, fell mortally wounded at the moment of victory.

As he died, the rebels were beaten off.

For half an hour, against overwhelming odds, the fiery leader of the Sinn Fein party fought off rebels who were in his party freight of rebels. At least three of the rebels were killed before Collins' body was recovered, back and front, so that Collins, hero of a hundred rapids, had gone more than once through the flames. He died, though, as he fell, dragging almost instantly.

As he lay dying in the dust, his hand resting on the chair in which he had sat, he closed his eyes and murmured:

"Forgive them."

The body of the slain leader was brought back to Dublin by water. A gondola-like capital prepared to receive him, the body was laid in state in the National Auditorium.

Collins was buried in protest. His heart, however, was given to the hospital at Cork, Ireland, where it lies in state.

The British government, which has been in command of Ireland since 1919, has sent a delegation to pay its respects.

The British delegation, headed by Sir Edward Thompson, has been received by President Eamon de Valera.

Collins, who was in command of the Free State forces in the Cork area, was with Collins in the car which was shot at.

Collins' son, Michael, was accompanied from London, England,

for Macroom, Ireland, where he was born.

A large crowd turned out to see the funeral.

Streets are filled with mourners. The Free State forces were paraded through the town.

As their leader falls, the Free State party slackened and the rebels were able to gain ground.

Two rebels were wounded.

The Free State party drove off in triumph, leaving the scene of their attack to Cork, where it was held on a steamer for Dublin.

There will be a "state" funeral in Dublin.

## Desperado Band Charged With Slaying of Wealthy Milwaukee Manufacturer

Strenuous One-sided Fight Marks Fatal Killing of Wealthy Manufacturer; Officers Arrest Nolay Gang in Few Small Hours; Investigation Taking Place Which Is Expected to Unearth a Clue Soon.

LOS ANGELES, Aug. 22.—Police officials identified the wealthy Milwaukee manufacturer who mysteriously met death at his home late last night, was John Nolay.

Not satisfied that they had reached a solution of the killing, with the arrest of an alleged bandit gang, 200 police officers and 100 men from the Nolay gang, which was composed of the uncanny crew.

Detective Sergeant Leon Cline directed the police investigation. He intended to question the dead man's wife in regard to her past life and recent activities.

Mr. Oesterheld, on the brink of a breakdown today refused to see newsmen who swarmed to scenes of the killing, but, after much insistence, he reluctantly acknowledged the death of his husband.

LOS ANGELES, Aug. 22.—Sixty members of an alleged bandit gang, including a woman, who police believe were members of the Nolay gang, and murderer Fred Oesterheld, wealthy Milwaukee and Los Angeles manufacturer, were taken into custody today.

## AUTUMN NOT FAR DISTANT

Fall is coming with its rich fragrance of the harvest season. The leaves of the trees before many moons will be turning to delicate tints, red, brown, yellow and mixtures of all three. What a wonderful way the Creator has of preparing us for the sunny, winter months and designating the end of the season of flowers and hot weather. Before we realize it there will be a noticeable chill in the air and we can see our silver breath upon the window pane. And we reacquaint ourselves with fall! We do not think so for the the following months may be a little frigid, they will fill us up with renewed pep and energy. They will spur us on to greater heights and then when spring with its fresh breezes and green vegetation steals softly over the hill we will welcome it with a new significance.

## COAL OUTLOOK

Union miners go back to work in most of the central competitive district, the strike over. Other districts will flock to the bandwagon. Eliminating Sundays and holidays, miners were idle about 115 days on account of the strike.

The union miner, however, normally is idle 100 working days a year, chiefly when mines are shut down for want of orders.

Reserve supplies of coal are practically exhausted, and production is far enough behind that the miners are fairly well assured of steady work until next spring.

Doing a little subtraction, you find that they really are "out" only about two weeks' work. They took their year's unemployment in one dose instead of hemophagically.

During the strike it was demonstrated that the non-union mines, if they get enough cars, can furnish at least five million tons of soft coal a week.

The country is using about eight million tons a week.

Open shop mines are able to supply five-eights of the nation's coal needs. And the non-union operator was undeterred in a dull market, because he has cheaper labor.

Making up the coal deficit should keep both union and non-union mines busy through the winter. Next spring, when there will be more coal than buyers, the consumer will begin to have his day again.

One permanent effect that is emerging from this coal strike is a big leap forward in the use of fuel oil. Caught in the pinch, many industrial plants that never before used anything except coal and coke have installed oil burners.

Fuel oil gives a hotter fire than soft coal. Increase in its use is logical; for it is a by-product.

To the selling price of coal, most operators now will be able to add the cost of keeping their properties idle during the strike. This cost includes such large items as interest on investment and overhead that goes on, strike or no strike.

Stripped to its skeleton, the root trouble in the coal industry is potential overproduction.



## What the Hot Wave Is Doing in Tenement Cities


