## BURLEY STARTS DEEP OIL WELL TO MAKE TEST

Thirty-five hundred feet of pipe is being sunk into the earth in Twin Falls East over statements of Professor A. H. Bartlett in the Times on Oil Situation.

American Oil can have its big reservoirs started and Twin Falls can see a north and south railway in sight up to Coeur d'Alene, and the shadow of a city that may overshadow the two projected enterprises before they are started, says the Burley editor. The oil well will be started as soon as possible to start work on a new oil field.

Last fall a carload of the best casting that could be secured was shipped by boat and landed to the west. There is still no sign of oil.

The starting up of the well at the West Pearl has been delayed because of other companies who have been trying to get a well sunk. All has not been completed, arrangements have been made for the preservation of the rights.

Those who do not agree with Samuel Gompers in many things will sympathize with him in his effort to keep the communists, the bolshevists and the members of the I. W. W. out of control of the American Federation of Labor. The regular unions which controlled by conservative men and women who try to carry out in good faith the agreement that they make and sign. The underlying principle of the I. W. W. is to break an agreement, where most injurious to the employer. In this it is in full accord with bolshevism. In view of this endorsement of the bolsheviki by the Seattle unions is fraught with danger to the republic and the head of the American Federation is working no less in the interest of the nation and its employers than in the true interest of workers when he announces this action. Even the regular socialists have repudiated the practical working of the Russian government. Those who endorse it are only extremists.

## "IMMORAL" BOOKS

Someone said the daughter of a New York supreme court judge, a book of recent publication which had been under fire by persons seeking to cleanse American literature. Angered that this volume should have come into his daughter's hands, the justice immediately announced he would seek the prosecution of those responsible for its circulation, and incidentally, take a bill to the legislature to put teeth in the present law against books likely to impair morals."

The suppression by rigid censorship of books which are within the reach of children has been talcified for considerable time, but if laws have been enacted their efficacy is not especially apparent. While much of an obscene nature has been purged from American literature—or American writings there still remain during authors and more during publishing companies which are willing to run the risk of public censure for the limited class they appeal to.

The American public, as a whole, not looking for the mean story, not looking for it necessarily becoming uninterested. Without discussing the merits of the book which aroused the ire of the justice, it is a fortunate thing for the mass that the lesson was brought so close to the lawmaker himself.

## THE PRICE OF PERSONAL LIBERTY

In confinement for a term of not less than six years, in a Pennsylvania penitentiary, a Philadelphia man of good family and high business standing is today reflecting upon what has come to him from using what some people regard as the inalienable right and personal liberty to get drunk. Having found a way to violate the prohibition law of the land, he did so it effectively that his way home in an automobile he killed three people, and is now under sentence of death in the second degree. The judge, in sentencing him, said truly: "The very worst punishment this man can suffer is little constant thought he has suffered on three lives."

In Pittsfield, Mass., a man who friends said that he had "three or four drinks of moonshine" is in jail, charged with second degree murder, two persons having paid with their lives the penalty of his offense.

The Times has no desire to enlarge upon the pathetic phases of these cases. The simple fact that two people in all were killed, one little child being benefit of a parent, as a result of the criminal indulgence in liquor, now prohibited by the law, tells the story sufficiently without any elaboration of its details. With these facts fresh in consciousness, it seems incredible that there should be found in the nation, as there are, men and women of good report and of high social standing, willing to defend alike the men who drink the liquor which made them murderers and the men who sold it, on the ground that both were exercising an inalienable right and liberty.

The law is, of course, insufficient in that it does not go to the real source of these crimes in its effort to root out and punish the criminal. The liquor seller was the true criminal, and those who are conniving with and excusing the drunkard in alcohol were in the highest moral sense accessories before the fact. If it were possible, it should be to discover the bootlegger from whom these unhappy men obtained the poison which dulled their minds and made them a public menace when at large; those sellers should be prosecuted quite as sternly as the actual criminals now under sentence. Beyond doubt it will yet be recognized by lawmen that in case of this sort justice has not been complete, nor the end of justice, which is to deter others from committing a like offense duly attained, until the愧者 of the poison is punished equally with the man for whose crime he is lawfully responsible.
