Paris, 22.—France is not responsible for the establishment of the Rhineland republic, French statesmen, usually regarded as the "journalistic multiplex" of the government, said in a signed editorial today.

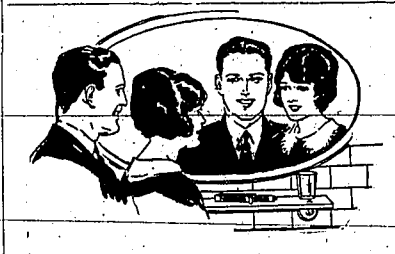

If the weatherman will be as considerate of the farmers of the Twin Falls tract for the week which is just starting as he was for the week which has passed, you believe that many more thousands of dollars worth of beans will be safely tucked away in the bin or in the car for shipment. This week should practically finish the bean harvest if the weather continues favorable.

Some apple growers find most of the growers of alfalfa seed are getting a pretty fair price for their crop but many others are not getting a just and equitable return on their products. The apple growers who have to sell his apples at \$20 per ton or less will hardly break even this year on the Twin Falls tract. Some have received much more than this but this is the exception rather than the rule. Concock alfalfa seed is producing a heavy yield and the price is strong, but the number of growers is not as large as we would like in this section of Idaho.

Some of the fellows around town who have figured on going out to help the farmers have apparently expected as much in wages as they received at their regular trade. This is unreasonable because the farmer cannot come out on his crop and pay six or seven dollars per day for help. We understand that the average wage is about \$4.50 per day and heard that this is a good wage and should amount to the facilities or otherwise. The wage is not what a union mechanic draws but we are of the opinion that if the farmer had to pay such a wage he would go broke much quicker than he does. But most of the business and professional men who went out did not go with the expectation of getting any wage but rather with the hope that the farmer would be able to save his crop with this wage.

Another check artist has been taken and he will perhaps get a stiff sentence at the hands of the court but some of the merchants of Twin Falls will still be holding the bag as far as recovering on their losses are concerned. Some more stringent methods should be adopted concerning the cashing of such checks by the business interests of not only this city but every community. We are all too anxious to get business and the clerks and others who deal directly with the trade should have stricter rules governing such transactions so it would be impossible for such artists to get by. The fellow who does business regularly with a firm should not object to having his check investigated and the other fellow needs investigation. In the third place the court should impose a stiff jail or penitentiary sentence and then those artists would cease their traffic.

BORAH FOLLOWS M'ADOO

In advocating the revival of the United States Grain corporation Senator Borah is following the plan suggested by William G. McAdoo in 1920, which was the one important point in which the former secretary of the treasury disagreed with his distinguished father-in-law, President Wilson. While realizing that Russia was not a market for farm products, McAdoo at the same time advocated greater trade relations with the Russians, but not recognition of Russia.

He pointed out that it was not necessary to recognize the bolshevik government in order to trade with Russia; something that the senior senator from this state does not seem to understand. As a matter of fact, McAdoo's advice in this last respect has to some extent been heeded and Americans are doing a prosperous business with many Muscovite concerns and co-operative unions. In advising the revival of the United States Grain corporation, McAdoo suggested a plan which in some form will ultimately be adopted.

Since the purpose of this plan is to find a market abroad for our surplus it is a clear recognition of what has sometimes been denied, namely, that the price of farm products is determined abroad, according to the law of supply and demand, and that the more directly we get in touch with that ultimate market, the better it will be for the farmers and the people in general.
