126,000 Miles of Cloth for Cement Sacks

To keep cement moving from the mills to the many building jobs always under way, cement manufacturers require an astonishing quantity of sacks.

This year the industry has considerably more than 225,000,000 sacks. These represent enough cotton cloth to make a skirt for every woman and girl in the United States—126,000 miles of 30-inch fabric.

When a customer returns a sack he gets credit for it, if it is usable or repairable. The convenient returnable sack means that each plant has to have large departments where men and women sew, sort, clean and count sacks continuously. This work alone costs the industry nearly \$1,250,000 a year.

And cement manufacturers keep increasing their sack inventories so that they can ship promptly. Last year they purchased a total of more than 100,000 new cotton sacks. For replacements alone over 50,000,000 were needed; for increased supplies over 30,000,000. In addition over 18,000,000 paper bags were used representing 7,000,000 pounds of paper.

Barnes will be sent here next week from Boise on preliminary work for the state's part and a contract for the construction of road between the pavement at Hansen and the gravel road in Cassia county at the approximate cost of \$200,000 will be let about January 15 and not later than February 1, assuming bids offered to be satisfactory. It was officially announced today by State Highway Engineer H. W. Gregory following a meeting at 10 o'clock today with the directors of the Murtaugh highway district who turned over to the credit of the state the proceeds of the \$30,000 in warrants which they received from the Twin Falls highway district.

The Twin Falls Chamber of Commerce has today turned over to the state the proceeds of the sale of \$3000 extra warrants, the sale of which they assumed at a meeting called at 5 o'clock last evening.

Mr. Gregory said this morning, "As that body has always cooperated heartily in the project, and without its cooperation it would not have been put over."

The government pays 58 per cent of the cost and the state and highway districts 42 per cent. The share of the Twin Falls district is about \$5000, and it is on account of there being \$3000 additional expenses attached to the road that the \$3000 in extra bonds had to be disposed of.

Mr. Gregory and Ashline arrived in this city yesterday afternoon at a meeting of the road's bureau of the chamber of commerce was called at once, at which arrangements were made toward the disposal of the \$3000 in warrants were made.

"I want to say that credit for the successful issue of this matter should be given to the chamber of commerce," said Mr. Gregory.

Senator Sweeley pointed out that land would never be so cheap again as at present and insists that the wisdom of showing courtesy to tourists had been demonstrated. He said that the new park might also serve as a playground.
