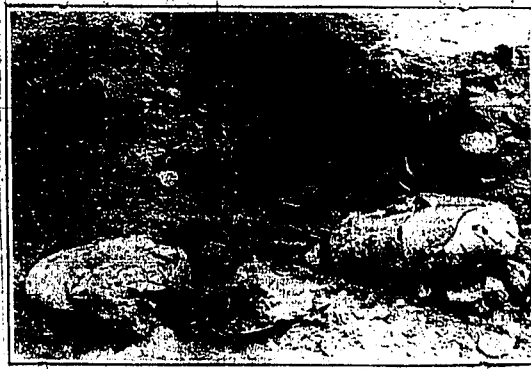


TEN-MILLION YEARS OLD!

Permanency of Nation's Agreement Doubted by Newspapers of France

OUTLOOK SUITS GERMAN PEOPLE

Tension Relieved for the Time Being in the Opinion of Many.

PARIS, Nov. 22.—The morning papers today emphasized that the agreement reached by the nations yesterday for notes to Germany dealing with administration of control of German armaments and with the reduction of the crown price is warmly endorsed.

The commission of foreign affairs of the chamber of deputies requested explanation from Premier Poincaré of his "concessions" to obtain the agreement.

Opposition members of the chamber were said to be planning a number of resolutions against the agreement, but they were strongly dissatisfied with the cost and to maintain the Anglo-French entente.

Andre Tardieu, one of Poincaré's strong political opponents, made the agreement the subject for a letter attack on the "strategic capitulation in four years."

LONDON, Nov. 22.—The Anglo-French agreement had thrown another bomb of contention into the British election battle.

Missouri Farmer Going Into World of Business

COLUMBIA, Mo., Nov. 22.—The "dirt farmer is going into business" is a slogan which has been used to pull himself out of the mud of past years.

After watching Pacific coast fruit growers, Kentucky tobacco growers and Texas cotton growers wax prosperous through co-operative methods, the Missouri farmer is taking Secretary Howard A. Cowden of the Missouri farmers' association, with a membership of 70,000, to take the Missouri farmer out of the realm of politics and put him on an economic footing.

The program of the Missouri Farmers' association, Cowden announced as follows: 1—Immediate organization of large tracts of cropland in different strategic points in the state; 2—Construction of warehouses, live stock shipping stations and public storage plants where needed; 3—Opening of acreage tracts in New York, Chicago and several other Eastern cities, which will sell direct to Eastern retail markets; 4—Eventual distribution of products—particularly butter—direct to the ultimate consumer.

Klan Is Blameless in Disappearance of Eastern Farmer

MIRANDA, Ohio, Nov. 22.—The Ku Klux Klan as an organization today was cleared of blame in connection with the disappearance of a farmer, who had received a number of letters slanted "in the name of the Ku Klux Klan" and ordering him to leave "the country within 20 days."

John Weber, county prosecutor, to whom Mrs. Lucille Foster is said to have written, also sent the messages of warning to Thompson; announced that he had uncovered no evidence to indicate that the Klan as an organization was implicated.

TO INTRODUCE LYNCHING BILL

Congressman Dyer Plans Legislation to Halt Rough Tactics.

ST. LOUIS, Mo., Nov. 22.—A national bill to introduce a lynch law which authorizes the federal authorities to punish the lynchers, was introduced at the session of congress starting in December by Congressman Dyer.

The bill is a revision of Dyer's measure introduced at the last session of congress. It provides that a federal grand jury to be called when a crime is committed to inquire into the commission of the offense, and to return a bill of indictment against a county which is found to have committed the crime.

Congressman Dyer announced his new bill at a debate with Congressman Henry H. Hawley on the question of whether lynchings should be made a federal offense, Dyer taking the affirmative.

Dyer declared that 4,382 lynchings had occurred in the United States in the last ten years. He pointed out that the federal government would supply local police forces, but that South Carolina's state law providing penalties against a county in which a lynching occurred had never been enforced.

He said that he believed his bill constitutional, and that former Attorney General Wickham and Palmer had expressed their approval of it.

The United States supreme court had said that the failure of states to protect their citizens from equal rights provided by law.

Dyer's bill is based on the Fourteenth amendment, he said.

CONVICTED MEN TO FILE APPEAL

Dr. Cook and Associates Object to Decision of Court.

PORT WORTH, Texas, Nov. 22.—Dr. Frederick A. Cook and his associates prepared today to appeal from the decision of Federal Judge J. C. Cook in the case of the oil stock promoters.

The former stock promoters draw a sentence of fourteen years and a fine of \$100,000 for their part in the operation of the Petroleum Producers' association, of which he was "president."

"You have stolen money from widows and orphans," Judge Cook told Cook in announcing sentences. "The deal of yours is damnable proof. You should not be permitted to run at large."

These who would understand the issues which are dividing the British electorate at the present time in the contest now raging since the dissolution of parliament can do no better than to read the little work put out this year by G. P. Putnam's Sons entitled "If Britain Is to Live," by Norman Angell, whose famous volume, "The Great Illusion," stirred the world a decade before the Great War.

Time has fully verified the two outstanding contentions of the earlier work, namely: that unless the piling up of armaments should cease and a better understanding of world economic conditions should be arrived at there would be a world war of unprecedented dimensions, and that one of the principal factors in bringing about such a calamity would be the "Great Illusion" that under modern conditions a nation could not rich by warring a war.

Angell contended that unless Great Britain should extend her fiscal system, the rest of the world, especially the rest of Europe would suffer, and England would eventually starve.

George united and with the labor party taking a relatively conservative and a very sane stand on the main issue, it looks as if the advice of Angell were not to be wasted after all.

There is a lot more in the work bearing on simple and frequently overlooked principles governing payment of reparations that will make the work one of the most valuable small books that have recently appeared.

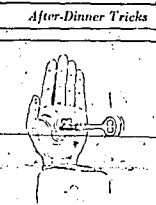

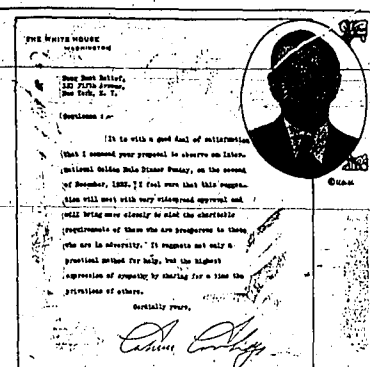

The plans for the observance of Golden Rule Sunday call upon the people of America to serve a menu in their homes similar to that served in the orphanage in the near east, the difference in cost of the orphanage menu and the ordinary menu to be contributed to orphanage work overseas. The observance is very appropriate today for the Sunday following Thanksgiving. Having on Thursday partaken from well-laden tables as a token of rejoicing in the prosperity of America, it is fitting that on the following Sunday people give special consideration to the needs and distress of those who are less highly favored.

REFUGEE MEAL FOURTEEN NATIONS. FOR AMERICANS SUPPORT COOLIDGE

Whole Country Asked to Adopt Orphanage Menu for Just One Sunday Dinner.

RELIEF HAS SAVED MILLION

People of All Nations Will Flagrantly Gather Around Same Table as Practical Sign of Sympathy With Near East Sufferers

How many comfortably fed, clothed and housed American orphans will it do to a Sunday dinner of rice, corn cereals and soup—typical orphans' fare on December 2, as a practical test of the golden rule?

The question is asked today by Charles V. Vickroy, secretary of the Near East Relief, who is in charge of the plans for the general observance throughout the United States of "Golden Rule Sunday," in an interview. Mr. Vickroy said:

"If American people will renounce for one meal the food they are accustomed to eat, and contribute the difference in cost to the support of starving children in the near east, the situation in Greece, Armenia and Palestine will be infinitely more relieved."

"I have recently returned from several months in those countries. America is a name to conjure with. The Relief reproaches are heard against nearly every other country, but none against America—because people realize that with a helping hand and a square deal, rather than with the mailed fist, America could help the most."

"America could well have afforded to have spent twenty-five million dollars a year on the Near East Relief, but she has not done so. The Relief proposition. The good-will that has resulted from relief work in the near east is invaluable. When these orphans we are caring for today grow to manhood, they will be the backbone of their nations and their eyes will turn toward America."

"At least a million people in the Near East would gladly today had, but it has not been for American aid. Even today, 10,000 persons are being cared for day by day by the Near East Relief, most of whom are children who would probably perish in a few days or weeks if the work ceased."

"Our workers are now concentrating not only on the physical care of our 10,000 orphans but also on the industrial training as well. At the age of 18, when an orphan leaves our care, he is equipped to enter some useful trade or profession. In Nassau, there are boys working in our carpenter shop a few feet from the spot where Christ died. In Greece, there are hundreds of Greek orphans are learning farming in the atmosphere where Paul spent many years in establishing the first European churches."

"Five dollars a month provides food and physical necessities for 13 orphans, and \$100 a year provides for his education, as well. The observance of Golden Rule Sunday in America, through which American families will provide enough funds for thousands of orphans. When people break bread together, they become friends. On the following Golden Rule Sunday people of all nations sympathetically will gather around the same table as those who the same food representing the men which the unfortunate children of the near east hope for. 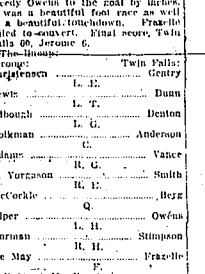

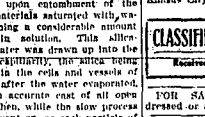

WALTON CLAIMS MANY MISTAKES IN HIS NOTICE

Notice of Filing of Motion for New Trial Declares That Numerous Errors Were Made in Attempt to Adjudicate Evidence and to Instructions by Court.

Various and number alleged errors are set forth by Attorney Homer C. Miller and E. M. Thompson as reasons why a new trial should be granted in the case of E. P. Walton in motion filed last evening.

It is claimed that the verdict of the jury was not in accordance with the evidence, that an article published Sunday morning in a Twin Falls paper contained errors liable to prejudice the case against the plaintiff, and that the court erred in admitting certain evidence and in giving certain oral instructions asked by the defendant and in refusing certain other instructions asked by the plaintiff.

The article in the morning paper as reproduced in the notice, holds that exception may have been taken to the fact that it was stated that seven witnesses testified that Walton's reputation for truth, veracity and integrity were bad, whereas the previous question asked had to do with his reputation as a law-abiding citizen and as to his business integrity, with a possible further reference to the technical construction of the sentence relating to the court's ruling on cumulative testimony.

It is claimed that the court erred in admitting over objection exhibits of copies of the Observer, which contained certain articles which started the controversy and continued it.

It is also claimed that 13 of the instructions to which Walton objected were incorrectly given. The objection is largely related to instructions to the jury in substance that it was their duty to consider the evidence bearing on the meaning of the various statements made in order to determine whether they would be understood in the community and to take all the facts and circumstances into consideration in arriving at a decision. On the other hand, the majority of the 21 instructions which the lawyers say were erroneously given are in correct directly or indirectly named, returned and the instructions were given by the plaintiff, declaring that each of the seven articles set out in the complaint. He also stated that the defendant had proven no justification for the publication of the matter and was therefore liable.

As to the claim that the two witnesses mentioned in the notice had no evidence on which to base their verdict, that improper evidence was in that the court erred 43 times in that the morning paper furnished its definitions, the record would indicate that the plaintiff thought things went about right.

The thieves did not, so that they could slip back and forth quietly. Red trucks were seen when they walked back and forth from the wagon to their car.

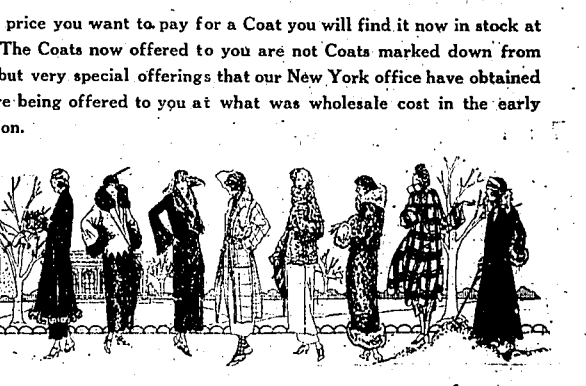
