



United States brass buttons on the uniforms of Turkish soldiers excited the curiosity of the Constantinian correspondent of a Copenhagen newspaper, who explains that they were captured booty taken from the Greek army, which presumably got them from the allies at Salonica. So widespread a war results in queer mussaqueras. He was even more interested to hear that the Kennedys had supplied themselves with ammunition from the stores in the sultan's residence, guarded by the British, resorting to the expedient of running a tunnel from the Bosphorus. Even cannon were carried away and replaced by dummy guns of wood.

Mr. Edison's sane remark that making Henry Ford president would be spinning a good man has had no effect on the Ford-president boomers in Dearborn, Mich. That is where Mr. Ford lives. The announcement of a national organization conference of all the Ford-president clubs in December, at Dearborn or Detroit, is convincing evidence that Mr. Ford himself is still maintaining a benevolent neutrality. Certainly no sign of the strangulation of the movement at his hands has been noted in any quarter. If the December 28th date is preliminary to the organization of a new party in the spring, it is time that Mr. Ford had a killing hand on it, if ever.

The doom of prohibition is read in the election results of November 6, 1933, says the M. E. Flywheel. A prohibition senator, Porter D. Dale, was elected by a smashing majority in Vermont. A dry legislature and dry local officers were approved in New Jersey. In Chicago, the vigorous prohibition law enforcement campaign of Mayor Dever was shown to be a political asset to his party. A dry was elected governor of Kentucky by a truly enormous majority to replace a man who is anything but popular with Kentuckians of dry leaning. In Maryland, a wet was named but it was a case of Hobson's choice as the drys had no candidates to support. Evidently the country not only wants prohibition but it wants maximum enforcement of prohibition.

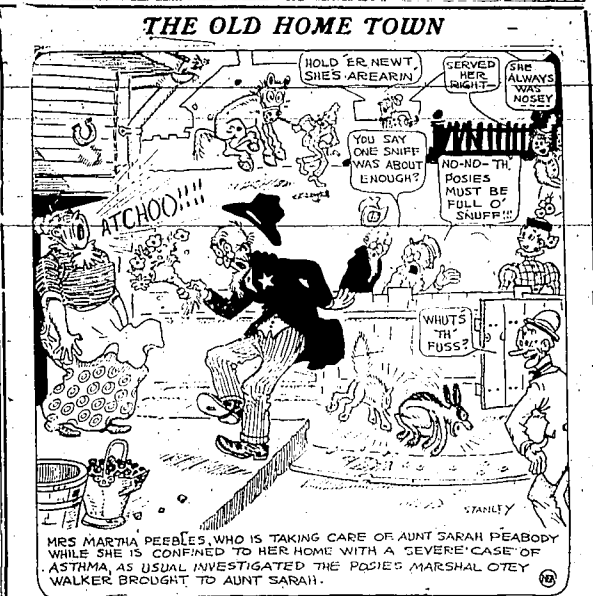

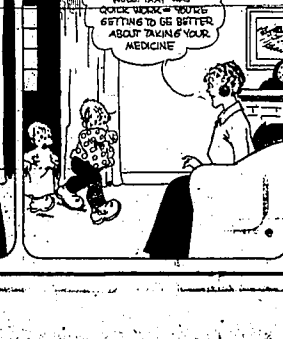

SETTLERS GET BIG VERDICT OF MEREDITHS

Nearly \$60,000 Given Brackett and Clark Interests in Contention Suit Brought by Idaho Development Company on Retrial of Action; Jury Raises Former Award Nearly \$7,000.

Sweeping victory was won by the defendants in the case of the Idaho Farm Development company in its condemnation action against Sarah B. Brackett, representing herself and the Ira Brackett heirs. D. P. Clark and J. H. Clark, in that they received a verdict this morning for a total sum of \$59,881.25, or nearly \$2,000 more than the verdict in the original trial from which the plaintiff appealed and which was sent back for retrial by the supreme court. Judge E. A. Walters and Attorney E. M. Wolfe and S. T. Hamrick of this city represented the settlers.

Interest will bring the judgment up to \$75,000, the largest ever given in the county.

The Brackett interests owned 262 acres of land embraced by the tract for the Howarth tract developed by the Merediths, and the Clark interests about 416 acres. In the first trial the Brackett interests received judgment for \$33,000 and the Clark interests for \$19,000, or a total of \$52,000. In the present trial brackets got \$56,225.25 and the Clarks \$3,656, besides interest.

The first case was retried on the ground that certain expert testimony given by the settlers was voluntarily admitted. The plaintiff development company expected that the award would be cut owing to the elimination of this testimony, but instead of the judgment was materially increased. The testimony closed at 2 o'clock last evening and the arguments occupied a couple of hours. The verdict was brought in this morning, just a week after the trial began.
