The boy scout tree planting at Shoshone Falls Saturday was another feather in the cap of that most worthy organization. The enterprise of B. F. Adams of Omaha, the present owner of the surrounding ground, and of J. A. Waters, a worthy worth of whom commendation in connection with this plan.

The dairymen seem anxious ready to carry into effect their long promised policy of marketing a great amount of cream through one source, President Gustav Kunze in his talk to the Jeanne girls Saturday, said they had 20,000 to 30,000 pounds of butterfat required, already signed and would soon have the rest.

According to C. Ben Ross, mayor of Pocatello, and chairman of the executive committee of the eight marketing association, the present status of that organization, in the drive which began Saturday, is "exactly" right. Accordingly, he praised Twin Falls for its work.

Those who thought that Senator Curtis of Kansas would content to be the "goat" and pretend to be "principal" in the oil scandal correspondence with E. B. McLean, little knew the war-like nature of the Jayhawker Indian. The attempt to try to make believe that Curtis was the real principal in the case was simply idiotic.

Hogie Barber ranks the city of Twin Falls as fair in his current monthly business map. The city and Boise were the only ones in Idaho given honorable mention and Pocatello, Utah, was given the "top rank" in the "intermountain" region. This map "gives" city a fair rank among the other cities of the nation as to sales opportunities.

"Coolidge says Congress is only to legislate," reads a Capital News headline. Yet only three short years ago, President Coolidge and his party were insisting that it was the function of one branch of congress to negotiate treaties. The fact that President Wilson had, "in doing the negotiating of a treaty without seeking the advice of Congress, followed 90 per cent of American precedent, was ignored in the flood of denunciation, pained on his head."

The bean growers' meeting got the Parish hall Saturday, following a very satisfactory banquet, was an evidence of what can be done in the way of co-operative marketing when conducted on sound principles. The sum of approximately \$250,000 net to the members, as reported by Director T. M. Baird, was very encouraging for the year's work. This sum, the last payment of which amounted to \$110,000, is only a small proportion of the total amount that has come to the tract for beans this year. The association, however, has benefited all because it was the means of eliminating the "wildcat" buyers who comes and goes as a "fly-by-night." Only, independent dealers' of financial responsibility could remain and compete.

We are not of the opinion that when the probate court held two former members of the Mutual Building and Loan Association to the district court for trial pre-emptively that this court intended to indicate by that action that these men were guilty but rather that there was sufficient evidence presented to warrant the court in saying to these men: "You may prove your innocence in the district court of Twin Falls county." Counsel for these two men did introduce some peculiar evidence toward the end of the preliminary hearing which to our way of thinking would have been omitted from the record.

The bean growers' association made a very commendable report last Saturday and the price they secured for the bean crop of Southern Idaho was most commendable. It must be taken into account that this association by its very presence or existence in this field materially increased the price the which buyers had to pay to get this product. The Southern Idaho Bean Growers' association may not have secured much for the beans as some of the members felt they should have secured but there are many things which tend to block the progress of such an organization. We have found that wherever such organizations exist the cash buyers always pay more because of the existence of such a marketing organization. The price of five and one-half cents per pound for beans is most excellent and we only hope that the association can continue to do as well by its members.

The appointment of Captain P. W. McRoberts and his confirmation by the United States Senate Saturday will meet, with general approval of the better people of this city and community. McRoberts will make an excellent postmaster we believe and should prove to be a credit to his party just as the retiring postmaster has done for the democratic party. There is no need of trying to sidetrack the issue. McRoberts had opposition and it looked as if his enemies were going to defeat his appointment but the number of opponents were not of sufficient consequence to prove to the congressional delegation in Washington that they should be thwarted. We understand that a certain few of the hooded order threatened Congressman Smith with defeat if McRoberts' appointment was confirmed but their ability to make good in this coming election will be another and greater problem. Congressman Smith will perhaps rise or fall with his party in the next campaign regardless of this little bunch of reformers.
