Major Martin and Mechanician Safe

FLYERS ARE ORDERED TO GO EAST AT ONCE

Pair Will Rejoin Round-the-World Aviators in Europe or Asia and Will Finish Flight with Others; Chief Patrick Says Confidence in Men Has Not Been Shaken.

WASHINGTON, D. C., May 12.—Major General Patrick, chief of the air-service, today ordered Major Frederick L. Martin, commanding of the American contingent, and his sergeant mechanician, Alvin Harvey, to Washington immediately.

Both will rejoin the arm-round-the-world flyers somewhere in Europe or Asia, depending on where they can reach them, traveling eastward from the United States. They will be sent with planes to some point to be determined later from which they will complete the flight with the other flyers.

The following message was sent to Martin today by Patrick:

"We rejoice and thank God that you are both safe and well. Confidence in you unabated. You have proved yourselves. Still wait for your emergency flight. Can't wait longer. Sergeant Harvey will report to me without delay.

Plan to send you to rejoin flight at furthest convenient point at which you can finish the journey with the rest of your command."

LOS ANGELES, Calif., May 12.—Major General Patrick, commanding of the American contingent, has been advised by Lt. Brown of Los Angeles may have saved the life of Major Fred L. Martin and Sergeant Alvin Harvey, round-the-world aviators.

Just before Martin left San Francisco, he had dinner with his two co-pilot hosts of a flight which he had had prepared for an emergency return.

On arrival in the state it was said to be as high as northeast as an ordinary meal.

Patrick's telegram read that this was "concentrated food." Martin referred to it in message.

ITS REPUBLICANS BEATEN TODAY

American Economist, organ of the American Protective League and in some ways the most influential republicans in the country, in its issue of April 11 ran an editorial under title, "Today Republicans Are Beaten," in which it declared that the democratic attacks on the republican tariff bill had won the morale of many republicans to such an extent that they were willing to modify the tariff somewhat. The Economist said that unless the republicans backed the tariff bill as enacted, no issue would have more worth fighting for. To the editor of the Economist its editorial still further frightened many who more strenuously than ever insisted that the thing was to yield something on the tariff. In its issue of May 2, it severely censures one of these, N. O. Messenger, a writer who in the Washington Star of April 11 upheld the law republicans and criticized the Economist articles as follows: "That is the extreme high protection point of view. It is not held by the progressive republicans, who think that the tariff is high already and who advocate lower rates."

Of course, it is absolutely rejected by the democrats, who are to make demand for lower tariff one of the principal issues of the campaign. A current statement from the democratic national committee has this to say upon the subject:

"Demands for reduction of the tariff are coming these days from various quarters, which the authors of the Fordney-McCumber bill probably least expected them when the law was being sent in 1922. Agricultural publications and thousands of individual farmers in the west have joined the cry for a revision toward the only sure and permanent relief that can be given agriculture."

In many instances the insistence on a reduction of the republican tariff is founded on the arguments which democratic leaders and representatives urged against its passage. The Nebrask Union Farmer, official publication of an important agricultural group, is making plain, to the farmers of that state that the republican tariff is one of the principal causes of their present difficulties.

Speaking of the McNary-Haugen bill now pending in the Nebraska Union Farmer says: "Instead of concocting import-tariff-lifting schemes to put the price of farm products in line with the world level, why not reduce the excessive tariff on manufactured goods and bring them down to the world level? Our tariff duties would permit the people of Europe to export goods to us, and thereby enable them to buy more of our products. Thus our foreign market would be improved, markets both at home and abroad would certainly increase for farm products."
