LOWER RATE IS ORDERED TO THE TETONS

Public Utilities Commission Orders Sweeping Reduction of Freight Schedule to the Hammer's Coal Mine. Total 70 cents a ton, less Twin Falls.

Ordering and executing the rates on the Hammer's coal mine was ordered by the Oregon Public Utilities Commission in its order issued late Saturday.

MRS FERGUSON IS SELECTED TEXAS CHIEF

Woman Candidate Receives An Overwhelming Majority Over Opponent in the Runoff; Defeated Aspirant Congratulates Winner and Gives Pledge of Warm Support.

HALLAM, Tex., Aug. 25.—Felix D. Robertson of Dallas, Kans. candidate, has criticized defeat by Mrs. Myrtice Ferguson of Temple, Texas, for the democratic gubernatorial nomination upon the basis of partial victory from Saturday's run-off primary.

Returns from 221 counties out of the state's 252, including 83 complete, gave Mrs. Ferguson a lead of nearly 50,000 votes over the Klan candidate, according to tabulation made by the Texas election bureau at its office Sunday night.

Mrs. Ferguson's vote, according to the latest tabulation, was 47,978, and Robertson's 27,781. Texas election law now affords a runoff election.

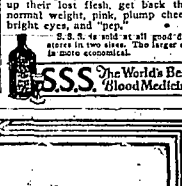

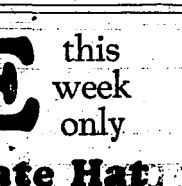

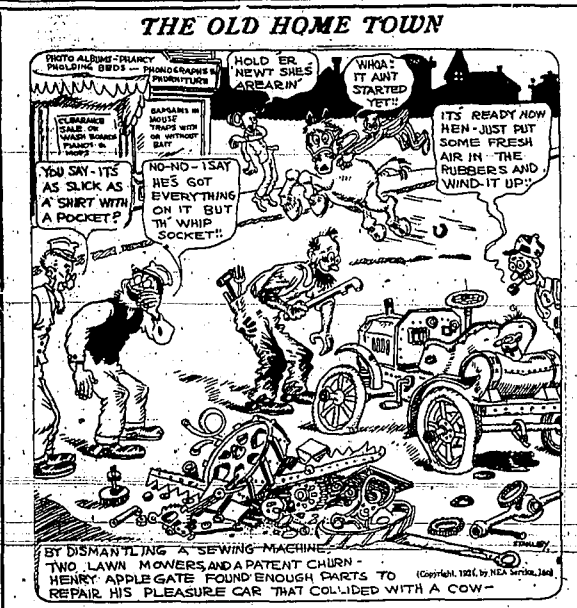

# DEMOCRATS GATHER FOR CONVENTION

## Anti-Fusionists Have Lead at Present Time; Moore Headquarters Opens at Perrine; Question Whether Agreement for Minor Offices Is Possibility Is Debated.

So far the anti-fusionists have the edge on the situation among democratic delegates arriving here today and today and how much the situation will change when a larger representation will arrive this evening is unknown. O. P. Mize, reputed to be the representative of Frank L. Moore arrived yesterday. He denied no existing an imputation but is heartily for Moore, who feels at home here, as he carried this county against Perrine in 1912. Mize is a good party man, less belligerent toward progressives than a few others seem to be.

It is probable that, beyond a doubt there will be two major candidates. It is certain that there will be a democratic senatorial candidate. It is also clear that John Rice will be the nominee of the democrats for justice of the supreme court.

Beyond this the situation is not so clear. In the event that Asahel B. Wilson should be the nominee of the anti-republican forces for congress, he can best address T. Smith, who was a minority candidate in this county two years ago. He might bring to the district a number of votes, and there are a number of places where he might be filed party tickets and carry by progressive, if the convention could agree on them. However, the cry "no fusion" is raised here. W. C. Chapman, who is leading this element, says that with the proper man at the head of this ticket, either candidate could be found. He is looking for Moore.

All in all—While there are few delegates expected on the noon train, a number of others were on hand to receive them. The state committee headquarters is in the Regroom. The Moore headquarters is at the Perrine, and the Smith, who seeks the state chairmanship, is at the Perrine. He is an irreconcilable foe of fusion. He reported that Ernest Anderson of Caldwell and Ben Coulter of Valley county also would like to run for the senate. The bold boys with the north Idaho delegates are on the way from the capital. As Ada county men are instructed for all the delegates and error. Speaking of the recently developed fusion movement at the meeting, the Statesman said this morning:

The seceding party is still in the air with many talkers of including Frank M. Perrine, James E. Hawley, T. H. Hawley, T. A. Walters and others. The Statesman's story:

Fusion plans of Democratic and Progressive state leaders Sunday night more definite shape as a result of a series of conferences which started early in the morning and lasted until after midnight. The delegates for placing Perry N. Mitchell, Nez Perce, as a candidate for congress from the first district; John S. Bunker, Democrat, and J. B. Eldridge, Boise Progressive, for supreme court, and a fourth man, yet to be determined, for congress in the second district; the second district, on both tickets, and will be submitted to both conventions Tuesday. Meetings Sunday were devoted to determining the legality of such an agreement, while Sunday's discussions were devoted largely to candidates.

Ada county republican delegates and representatives from northern Idaho left early Sunday morning for Pocatello to join the automobile caravan from there to Idaho Falls. Later arrivals, however, spent Sunday evening, waiting for the midnight train in consultation on the policies to be pursued in the Idaho Falls meeting.

The democrats will leave this morning by automobile for Twin Falls, delegates from the north and almost the entire north Idaho delegation will assemble at the capital and start at 10 o'clock.

The vanguard of the Progressive forces was in Boise Sunday night while Socialists were not expected to arrive here until today. Only a few of the state's 14 congressmen, representatives, justice leaders, and members of the short time since organization of the party.

While leaders of both Progressives and Bourbons announced they had "nothing to say" in regard to the fusion plan, both groups were expected to be nominated by both parties, and the same arrangement in regard to justice of the supreme court, all readily admitted. The fusion movement certainly be submitted to the conventions. The fate on the respective convention floor was in doubt.

however, elements in both parties have been strongly against the plan.

James P. Moore, Bourbons chairman, was noncommittal on the subject, answering all questions with the reply, "I have no statement for publication." Ray McKeig, Progressive boss, made substantially the same response, declaring that he could not commit one way or the other, could not affirm or deny that such a plan had been perfected.

Locality of the proposal to place the name of the tickets was being worked by three party officials. Democrats had pretty well agreed by Sunday night that the three counties in spite of an opinion of Roy Block, former attorney general, that such an action would be illegal, but the Progressives had mental reservations, and apparently were unwilling to hazard their split ticket, with the chance that the Progressives would be thrown out of the ticket by a supreme court decision.

"I favor naming a complete Democratic ticket," said Moore, secretary of the party's national committee, when asked for his opinion of the fusion movement. "If the Democrats were to name a ticket, it would be a Progressive to put the same name on their ticket, and if the thing can be done, it would be a good thing."

Virtual unanimity on three candidates for both tickets in harmony with fusion plans had been reached as a result of the conference. Party leaders said, but the other was still in dispute. Perry W. Mitchell of Nez Perce is generally certain to be the candidate of the fusion forces in congress from the first district. Mr. Mitchell arrived from the north early Sunday and immediately contacted with delegates leaving.

Apparently the results were satisfactory to the Progressives, but the opinion of any other candidate from that district had not been reached.

The situation in the second district is also made more complicated, particularly those lukewarm toward the fusion plan, favored Asahel B. Wilson as the Democratic candidate, while the Progressives are in favor of including him if they see fit.

For the Judiciary John C. Rice of Caldwell, former chief justice, is virtually assured of the nomination, for in line with earlier discussions, J. B. Eldridge, Boise lawyer, also practices the usual tactics of the fusionists for the other supreme court justiceship. While Mr. Eldridge has the particular strength in third party ranks, he is also popular with the Democrats, and little difficulty was experienced in agreeing on him. Mr. Rice, while a Democrat, who has long been Progressive backing, leaving the second congressional district the only one where a contest between the two negotiating parties.

Candidate discussion during the two-day convention continued entirely to the four counties lacking the proposed amalgamation being that it would be better to concentrate on these places. If the fusionists are not accepted, leaving the remaining places more or less unaltered.

J. B. McDonald, Progressive committee man from Bannock county, announced Sunday night the party's convention will come to order Tuesday morning at 9 o'clock in the high school auditorium. # PRECEDENCE MOOT ISSUE IN MEETING

Main State Senator and Territorialities Come Before State Officers to Moot the Issue of Precedence. Merely Directorial Provision That May Be Altered.

When the democrats are called to order tomorrow at the high school auditorium by State Chairman James P. Popo, one of the questions that will be presented is whether the national congressional officers like senator and congressmen shall be seated at the state convention or the reverse. This the state provide for the nomination of the national officers first, but it is held by some members that the order is purely directory and not mandatory (although mandatory in form), and that either plan may be followed.

"What the Law Says"

The statute reads:

"In the nomination of candidates, the following order shall be followed: (1) presidential electors; (2) United States senators; (3) representative in congress; (4) governor; (5) lieutenant governor; (6) justice of the supreme court; (7) the remaining state officers in the order named in the constitution or the law creating them. Provided that in the nomination of representative in congress only the delegates representing the counties within the territorial limits of the respective congressional districts shall be entitled to vote for their representative nominated from their district."

The following taken from staff correspondence to the Times on August 23, 1912, indicates the order of precedence in the state convention: "The convention nominated the 'tickets' which consists of George Washington, W. P. Whitaker for second. The resolutions followed the congressional nominations. A desperate fight was made for the nomination of the platform which was progressive all the way through, but the provision was sustained by a vote of more than two to one. After the nomination of Governor Alexander in an eloquent speech by Frank Martin, etc. Here followed the description of the nomination of the rest of the state ticket. The convention adjourned after the next meeting."

# SHIPSTEAD TALKS TO LARGE CROWD IN CITY PARK

Minnesota Senator Criticizes Acts of Old Parties and Appeals to Voters to Support the Ticket Headed by La Follette and Wheeler.

A large crowd listened yesterday to the speech of Senator Frank Shipstead at Minnesota, at the city park, wherein he criticized the records of the republican and democratic parties for their conduct of government. The speaker was introduced by D. F. DeWolfe, who in explaining the holding of a political meeting on Sunday afternoon said that Christ had trouble with the Pharisees over the same subject. He said that he always noticed that folks who were sick sent for a doctor on Sunday. He said that the country was sick and like folks who found their remedy in a doctor's office, they should try a new one.

Senator Shipstead said he was on his way to Boise and had received word of an announcement that would be made at an entertainment on Saturday evening. He charged that after the war under the operation of the federal reserve act, credit was expanded to such an extent that the people borrowed lavishly, and then the currency was contracted, and the people lost what they had accumulated. He said that now in order to boost the party in power, the strikers were left out of the party, a period of labor money, after which the strikers were taken away the products as a bee owners take away the honey of the bees. He said that the strikers were being used as a tool to get them where he wants them.

Senator Shipstead denied that lack of sufficient exports caused the trouble. He said that in 1912 the exports in corn were three times as great as before the war, and that in wheat much greater exports in three ton trucks as great and exports of all farm products greatly increased.

He denounced the "Each-Cummings" record as a law for which he was named of both old parties. "He did not say, however, that a majority of democrats in both houses voted against the law.

He scored the Democratic plan as favoring international bankers and denounced militarism. He praised Senator Lorah and appealed to all to join in supporting La Follette and Wheeler.

# STONE MOUNTAIN DESCRIBED BY TWIN FALLS MAN

James Hall Spoke on the Origin of the Building and Loan Movement C. P. Howles Also Spoke to the Kwanza Club on His Trip.

The speakers at the Twin Falls Kwanza club luncheon today were James Hall, C. P. Howles and C. E. Lind. Mr. Hall was introduced as a new member and then spoke briefly on the building and loan industry in Scotland and then spread to Great Britain in 1781 and the first building and loan was started in 1801. The industry has grown from a membership of 1,500,000 25 years ago to seven million members at the present time. Twenty-five years ago there was \$600,000,000 invested in building and loan stock and now there is \$1,500,000,000.

Mr. Howles spoke of his vacation and the various places he visited while away from Twin Falls. He dwelt at length on the mountain which is the pride of the world which is commonly called Stone mountain in Georgia. Here they are carrying in solid granite a sculpture of the general and leaders of the Southern Confederacy.

The sculptor is Oulton Berghart, a Scotchman, and the mountain is five miles around and one mile to the top. This gigantic piece of sculpture is one of the greatest art works in the world, and it cost \$10,000,000 dollars. It is 16 miles from Atlanta. It will cover one and a half acres of land. Mr. Howles visited about 36 of the leading cities of the many eastern and southern states. He visited his parents in Kentucky, his sisters and brother in Atlanta.

C. E. Lind spoke of the need of care to take the delegates to the state democratic convention here tomorrow and the next day. In the various points of interest in the various parts of the state, he mentioned the city of Boise and J. E. White will look after the transportation problems of the convention.

# ATTACK RATE OF COMPANY

BOISE, Aug. 25—Attacking the Idaho Power company from several angles the Southern Idaho Light and Power Users' association late Saturday filed an application for intervention in the company's rate case now before the commission. Captain Everett M. Hall was named as attorney for the association. The commission was ordered July 14, 1914, by the commission to show cause why the minimum bill for water hauling should not be reduced and why a 10 per cent additional minimum discount should not be allowed on all metered service. The commission's answer filed Saturday is in answer to the company's application.

The commission's order on July 14 was issued by the association having filed a petition with the commission asking that summary relief be granted the users of Idaho Power company. It was explained in this petition that the users find themselves at a disadvantage in that the company was in the 1912-13 revenue was out of balance to the company's disadvantage. Now, the petition states, the revenue is out of balance to the users' disadvantage and summary relief is urged for.

The petition states that on which the power company is attacked, the association answers that in 1910 the company paid \$101,310 in taxes. In 1912 a total of \$12,064,175 was paid, making a reduction of more than 133-60%. Since 1910 the association points out that the company has received and been allowed several millions of dollars additional to its rate because of new property.
