EN ROUTE WITH SENATOR LA FOLLETTE TO SIOUX FALLS, S. D., Oct. 17.—Senator La Follette, independent candidate for president, today denied charges by T. V. O'Connor, chairman of the alpine board, that money is being sent from Russia through Mexico to help the La Follette-Wheeler ticket.

"So far as campaign contributions for purposes of the federal campaign law," he said, "I have absolute knowledge, and I emphatically deny O'Connor's statement, O'Connor declared. "I denounce it as a wild and malicious campaign lie. It is a piece of other loose and untruthful statements made by desperate Coolidge henchmen."

His alleged evidence of campaign contributions to the La Follette-Wheeler ticket. 2. His payment of expenses of the hired affidavits of fake labor leaders delivered to C. B. White House to listen to President Coolidge's Labor day address.

CALIFORNIA BANK TO GIVE BUSINESS TO ITS EMPLOYEES

SAN FRANCISCO, Oct. 17.—The bank of Italy, one of the largest financial institutions of "the Pacific coast," started the banking today with announcement of a plan whereby its ownership will pass to its employees. Today's announcement had three phases: First, it embraced a plan whereby 50 percent of the profits of the bank will be placed in a fund, each year, to be used to purchase shares of the bank to be given to the employees. Second, it provided a plan whereby employees will rotate in official positions providing constant promotion. Third, it was the announcement of the retirement of A. J. Starnes, president and founder of the bank, in accordance with the plan to give 50 percent of the bank to employees, every employee from 1895 to the present will contribute to the fund.

BOISE TOURIST PARK POPULAR

Total Registrations for Past Summer Reach Large Figure.

BOISE, Idaho, Oct. 17.—The total registrations in the Boise tourist park during the 1924 season, amounted to 5380, the board in charge announced. Due to the fact tourist travel is falling off it was decided to close the park this week. During the months of June, July and August, no number of cars averaged 70 daily, with from two to five persons to a car, so that the park was filled to capacity. Every state in the union was represented by tourists during the season. California cars headed the list in numbers. Some days almost a third of the total population of the park was composed of California people. Foremost among eastern representatives throughout the year were Ohio cars. New York followed second. There were cars from as far south as Rhode Island and as far north as the Carolinas. Countries outside of the United States were well represented. Canada being credited, however, with the greater number of foreign cars. China, Great Britain, Hawaii, the Philippines and other foreign countries were represented.

Fukien War Lord Assumes Charge; Occupies Shanghai

SHANGHAI, Oct. 17.—General Sun Chuan Fong, war lord of Fukien, assumed control of the military district, the largest foreign-held in Shanghai today. This caused a panic among the guests who fled into the street in night clothing and were unable to return to their belongings. **IRVING, Ill., Oct. 17.**—Some of that wild enthusiasm which made Washington temporarily unbalanced when the Senators were fighting for the baseball championship, drifted overland and dropped in on this midwestern college town where a major football championship may be decided tomorrow.

All the surrounding hamlets are as proud of the Illinois date as Washington was of her fighting nine, and the same confidence exists that Michigan will be defeated here tomorrow and the "big ten" championship will be won with a clean tilt.

Michigan may be a public favorite, Illinois had a championship eleven last year but she had to share the honor with Michigan as neither team lost a game and the rules would not permit them to fight it out.

The schedule this year brings together in this early season some of two outstanding powers of a great conference and makes possible one of the greatest football exhibitions in years.

## Old Cornish Tongue

**Soon to Be Memory**  
"Catharsis, Gerrard, Dm. Tho. Carmon" was the title of an address delivered to the members of the London Cornish Association by Terahway Roberts, one of the few men still able to speak the old language of Cornwall. Translated these mysterious syllables emerge as "A Few Words About Cornwall."

Cornish, Mr. Roberts pointed out, is not quite so dead as it usually is held to be and produced an exhibit of a postcard written by a little girl of eleven, who had learned the language from her father, says the Living Age.

Prince Janion Henegarty is responsible for the legend that Dorothy Wentworth, who died in 1787, was the last person who spoke Cornish. It is reported to have been lost.

The old lady used to swear at tourists in Cornish, usually ending with the words in direct Cornish: "Ugly black tool!" in exchange for the copper nails lavished upon her by the visitors. John Henry Henegarty, who died in 1891, could speak it fluently.

Ninety per cent of the place names in modern Cornwall show traces of the old language. In spite of the profuse cornishisms of Mistress Wentworth, Cornish is now few and far between. It is regarded as an alarming spectacle.

# TUBERCULOSIS AND OIL BEFORE THE DEMOCRATS

Representative Lloyd Gives Position on Hospital and State Platform

In his address before the Woman's Democratic club last night Representative T. Lloyd defined his position in regard to the tuberculosis hospital and the return of the fund for hospital construction to the general fund last winter. Mr. Lloyd stated that he was paired against the return of the fund to the general fund and that he was strongly opposed to diverting it from the purposes for which it is intended. The representative from Cassia was ill and on the verge of pneumonia, which he contracted immediately thereafter, and would at the risk of his health have remained to vote for the return of the fund. Mr. Lloyd stated, so he commented in a joke, which killed the case of the Cassia man and at the same time allowed him to take care of himself physically. Fatigue caused Mr. Lloyd to quit talking without a will in equivalent to saying without a will.

Mr. Lloyd read two letters, one of September 8 in reply to an inquiry from Mrs. W. Z. Airon and one of October 11, in reply to Mrs. Glen S. Whitney, president Ladies Pioneer of Kimberly, Cassia county, Idaho. His letter to Mrs. Whitney reads:

"Dear Mrs. Whitney: I consider the legislation by which the money raised for the tuberculosis hospital was diverted to the general fund of the state a most infamous piece of work, and my efforts for its revocation have not yet, as all the newspapers say, been successful. The question whether it should be one of two hospitals is debatable, and one upon which I do not in and out this time fully established."

In his letter to Mrs. Airon he had taken the same position, and had pointed to his work for the establishment of tuberculosis hospital facilities as proof of his active sympathy and co-operation.
