## KEEPING WELL

### OPEN THE WINDOWS

DR. FREDERICK H. GIBSON Editor of "HEALTH"

DURING the summer I spent a month in a village in northern Michigan. The old lady in whose house I stayed was the widow of the village postmaster and had lived in that town for forty years. Naturally, she knew every man, woman and child in the place and all the details of their lives. For a month I was entertained by a first-hand history of the town and its inhabitants.

People are much alike everywhere. The story of our lives is about the same, north and south, east and west, whether we live in town or country. A great city, as I, Henry, showed in his studies, is only the small town multiplied many times over. But as I listened to the old lady's stories of the people and things in this little village, I was surprised at the number of people she told me about who had died of "consumption."

Yet this little town is a health resort. It is surrounded by pine forests. It stands on sandy soil, where drainage is easy and effective. Its water supply is remarkably pure, coming from artesian wells of unusually good water. The houses are well-ventilated; there is abundance of pure air and sunshine; the winds off the great lake are fresh and slightly salty; there are no factories to pollute the air; the people are mostly farmers or village shopkeepers and are of good sound American stock. What is the reason for the large amount of this dread disease?

The reason, I think, is that while there is an abundance of pure air outside, the people keep their doors and windows tightly shut. The winds are long and severe in this part of the country, so the houses are tightly built. As soon as cold weather comes, the houses are filled up, storm doors and windows are put on, every crevice by which cold could enter is tightly sealed up and the people live all winter in stove and furnace heated rooms.

Even at night the windows of the bedrooms remain tightly closed; partly to save fuel and partly because many people still believe that night air is injurious. Yet air at night is far purer and better than the air during the day, so that while thousands of people travel hundreds of miles of pure air, which they could get by opening their windows and letting it in.

The idea may succeed and it may not. It will not accomplish its purpose if Dundee comes back from Europe with an argument that he is still the champion and demands that he be allowed to continue to fight. As Jim Jeffries did to his opponent fight.

Dundee has suggested he still do this. The elimination series will be the six contenders picked up by the commission to seek his crown will develop a good card for Dundee, and that of course, means a good prize.

Danny Kramer, Lew Jansen, today Garcia, Kid Kaplan, Jess Lambrino, and Mike Dundee were the contenders picked by the commission and Billy DeVoe and Mike Herman were named as alternates to fight in if any of the regulars should find it impossible to make the weight.

Kramer, a young southpaw, from Philadelphia, and Kaplan, who preferred Dundee into his surprising revelation of the title, are being picked by the smart ones as the favorites in the tournament with Lambrino as the dark horse.

When Dundee resigned as the champion with the announcement that he could make his weight no longer, the commission accepted his retirement with the warning that he never would be permitted to box as a featherweight in New York.

## LINCOLN FIELD PROTECTED FROM RAIN BY BLANKET OF STRAW; OFFICIALS CHOSEN

Lincoln field, where the Fifth-Twin Falla football game will be played tomorrow afternoon, has been heavily covered by a carpet of straw in an effort to prevent the rain, which has visited this section recently, from turning the field into a mire. The field was covered by a carpet of straw laid by Jack Viroon. Regardless of the condition, however, the game will be played and it was declared today at the high school that unless the gods send another wet downpour the field will be in a playable condition tomorrow. The straw will be raked off some time before three o'clock Friday.

These officials are thoroughly familiar with the fine points of football and will run the game smoothly and efficiently. A pep rally through the town streets and stadium, at the intersection of Main and Shoshone streets, will be held after school tonight. The band will be there and every effort will be made to stimulate all possible interest in Friday's great battle.

## IDAHO VANDALS MEET TROJANS

MOSCOW, Nov. 20.—To the sons of Idaho the "big" football game in the far west of this Saturday will not be the California-Stanford game at Berkeley, but the Trojan-Vandal clash at Los Angeles. Idaho's fate in the conference is now up entirely in the outcome of this game, and to her will record place if she wins that is if the Stanford-California game ends any way but a tie.

Idaho, defeated but once in her six years this season, is the favorite but it must be recognized that weather conditions will be the heaviest handicap in determining the result. At the present Idaho looks the better choice although an upset against the Trojans will split it all and revert the choice probably to either Stanford or Washington, the clubs next in line. # SMALL USERS SUBSCRIBE TO THE BIG DAM

Many Districts on the Upper River Will Take 200,000 Acres Feet; All Surplus Water on the Reservoir as Planned Will Be Taken Up by December 6, Removing Last Objection of Interior Department.

A number of small water districts on the upper Snake river met Saturday at Idaho Falls and decided to subscribe for water in the American Falls reservoir. The amount of 200,000 acre feet was signed for, and another meeting called for December 6, at which time it is understood that all the surplus water contemplated in the reservoir will be taken.

The reservoir as planned provided for the impounding of 600,000 acre feet more water than had been subscribed for. This created some objection on the part of the interior department, and it was feared that failure to get practically all of it subscribed would delay a considerable time the construction of the big dam. Gooding agreed to take approximately 200,000 acre feet. Then the movement was extended to a number of small water districts, and these are all coming in. It is said that in some cases farmers have small water rights under three such districts. It is believed that all these will subscribe, and that the whole amount will be taken up at the meeting of December 6, or two weeks before the bids for the construction of the dam will be opened under the new call.

# MRS. A. AVERY DENIES CHARGE

Defendant Says She Rode Alone on the Evening of Oct. 10, and Did Not See the Key in Evidence Until They Arrived at Police Station on Night of Arrest.

That she rode alone in her Buick car on the evening of October 10, that E. J. Murray was not in the car at any time that evening, until ordered to get in by Police Officer H. O. Durr, that she did not see the key required to contain manacles until they got to the police station, that several dozen bottles in boxes in the car were for the purpose of putting up catnip, and that she never saw a rubber tube said to have been found in the car until after her arrest, were leading points in the testimony of Mrs. A. Avery, proprietress of the Kellie rooming house, as the witness stood in her own behalf this afternoon.

She said she took a driver around town alone for about an hour and then returned. She saw two men, who later proved to be the policeman and Mr. Murray in a warm conversation at the foot of her stairs, but did not know who they were until she started up the stairs and was halted by the command of the officer. He then picked up something and put it in her car. At the police station this proved to be a key similar to one she had seen at the station previously, she said.

Prosecutor J. W. Taylor put the witness through a rigid cross-examination regarding the time for putting up catnip, and why she found it necessary to buy so many bottles.

The entire morning and early afternoon were taken up with the continuation of the cross-examination of Pottemann. But, when the defense began to introduce evidence to have been prejudicial against Mr. Murray on account of a previous alleged misjudgment.

STONE CROSSES WILL REPLACE WOODEN ONEN ON GRAVES OVERSEAS

WASHINGTON, D. C., Nov. 26.—The battle monuments commission headed by Pershing, has decided informally that the graves of American war dead in France shall be marked for all time with white stone crosses in patterns similar to the wooden markers that have stood on the graves since the war.

Not only will sentiment for the cross be perpetuated, General Pershing said today, but the arrangement will be unchanged, the stone crosses being fired with permanent markers, "run on row."

General Pershing explained that the decision had been approved by individual members of the battle monuments commission and, for all practical purposes, would be formally relayed at a meeting of the commission to be held here this week. The plans will then be presented to Secretary Weeks for approval before actual work of planting the stone crosses in the cemeteries overseas is begun in the cemetery division of the army quartermaster corps.
