WORRY OVER WELFARE LEADS TO WAGE REDUCTIONS

Head of American Federation of Labor Announces Policy to Be Adhered By Workers: What Hurts One Industry, Injures All According to Green:

WASHINGTON, D. C., Feb. 25.—Unions may be reduced. Workers will be asked to give up reductions. William Green, president of the American Federation of Labor, said today:

"One of the important industries which are engaged in an attempt to cut wages," Green, in an interview, warned, "against similar reductions in other industries, which would result in a general reduction in all industries."

"Workers must fight," Green said, "but we can't do it alone. The wages of carpenters, bricklayers, carvers, buy textiles, and the wages of textile workers are reduced," said Green. "Manus, who is a member of the executive committee, indicated that in his district they eat poorer food; they make the old shoes last longer, burn less coal or no coal at all. So wages in the long run, increase unemployment."

"Unemployment has steadily reduced since the advance of the depression, and we are faced with the problem of getting men back to work again," Green said. "The rates of pay, of food and of clothing must be increased, but we cannot increase the cost of machinery, and it is dangerous to do so."

**Rescuer's Body Found
Only 300 Yards from

DENVER, Colo., Feb. 26.— Three hundred yards from what would have meant life and safety, the frozen body of a rescuer who had risked his life on Long's Peak January 16 was accidentally found late yesterday.

Oscar Brown, care-taker at Long's Peak, recovered the body, 300 yards from the summit, about 10 o'clock from the main automobile road leading to the inn.

Brown died in a blizzard after he had been sent from a rescue party to the aid of Alice M. Williams, prominent society and business woman of Denver who succumbed to freezing weather after a successful mid-winter trip up the peak.

Three weeks searching through the drifts snow on lower Long's Peak while the thermometer ranged near zero, Brown had failed to reveal his body.




ROUNDHOUSE STORY STIRS UP THE CITY

Officials-The Steel Water Main Construction Starts It as Early as Possible Statement by Representatives of State Before Engineers Commission Meets in West, Sacramento.

Much interest is aroused in the city over the approaching construction of the water main and the extension of the water mains to the site made late yesterday to Superintendent of Roads. Total cost of the six-inch pipe would be about \$2200 feet long within the city limits and about \$8 each, longer outside, Mr. Rayburn said. The plans, which were quite urgent, will be laid before the council Monday night, and if the pipe can be started early next week, the work, including track and clearing ground, will not be delayed in the meantime.

Although the last blue prints submitted here nearly a year ago provided for a seven-foot roundhouse, it is now planned to have a total of six-inch pipe, which will be about 1520 feet long within the city limits and about \$8 each, longer outside, Mr. Rayburn said. The new plans, which are apparently well in hand, will be laid before the council Monday night, and if the pipe can be started early next week, the work, including track and clearing ground, will not be delayed in the meantime.

Subscriptions for stock in the new tourist park are not being received from the public at this time, it was learned. Three committees which did some work, cost about \$400 apiece or the average, at a dollar a share, \$4000. The state has not yet paid its workers that the city must move the tourist park and that unless there is co-operation it will be impossible to begin the work, it was estimated.

The number of proposals as a result of reported unidentified framers to extend the city's plan of the construction of the Columbia River bridge to Spokane, Veteran and extending the same to Priest River, was announced this morning by the city engineer. The highest bid was \$1,000,000, approximately two years from now. The lowest bid is known here, as they have been sent by a number of firms.

Another theory which is gaining ground is that the completion of the extension to Priest River will need the services of the Denver, Salt Lake, Spokane and Los Angeles will come through Twin Falls and on via My over the Union Pacific and thence to Priest River. R. R. Bill Withdrawn

The proposed bill to provide a fund of \$20,000 to pay the expense of a commission to investigate the feasibility of building a north and south railroad around the city, which bill of the state has been withdrawn by its author, Senator Crooks, the senate after an adverse report by committee, voted to add to its defeat.

The proposal is a plan of Colonel Judson Speer to survey a road from the end of the lumber railroad at Council Bluff to the Snake River at the mouth of Piney Creek, through the head of Johnson Creek through Yellville to the mouth of the North Fork of Salmon river to Project Gap to North Fork of Salmon River, thence down Salmon River to the mouth of Clearwater River, thence via Alahka to St. Maries and to Coeur d'Alene, where connection is made with the International railway.

The plan, which is quite urgent, if not the last, will be laid before the council Monday night, and if the pipe can be started early next week, the work, including track and clearing ground, will not be delayed in the meantime.

Show Lack of Adequate Legal Knowledge and Trifling Burden of Proof of Showing Innocence Is on Him Self, says Justice J. W. Gillett. He Does Not Enter Plea. Joe Jump Gets Still Remand.

Whether John W. Davis, worried over the result of the election in Colorado, "will be tried" is a question he has to prove his innocence, or whether he is, as he claims, a victim of circumstances, was not determined this morning when he was arraigned before Justice Chester G. A. Divelbas. Davis who has a family, said he was unfamiliar with legal procedure and intimated that he supposed he would have to plead guilty. When asked whether he was innocent or guilty, he said, "I am not used to this sort of thing," said Davis, "and I have no witness, but myself; I have no means of proving my innocence."

"You do not have to prove your innocence," said Judge Hulcock. "The state has to prove you guilty."

Davis, then, asked how soon he could be tried before a jury and was informed that he could in about two weeks. He was given until Saturday morning to decide what plea would be entered.
