

IDAHO OUTLOOK IS PROMISING FOR FARMERS

State Land Commissioner Nash Gives Views on Prospects for Year in Various Parts of Idaho; Business Men and Farmers Predict Prosperity.

SALT LAKE CITY, April 7.—Increased activity in mining, lumbering and agriculture, and a favorable outlook for agriculture were reported by I. H. Nash, of Boise, Idaho, state land commissioner, who is in Salt Lake City on a business trip.

Centralization of the northern Idaho lumbering industry at Lewiston will result from the acquisition of the Clearwater, Tarmar and other river, according to Mr. Nash. In mining he reported that considerable developments were being made in the Hilly district, the Dead Horse section and the south work of the Purcell and the Coeur d'Alene districts of the northern Idaho.

Work is progressing on the American Falls dam to provide storage water for use in irrigation and under cultivation. Mr. Nash said in speaking of the satisfactory agricultural outlook in Idaho.

The timber industry outlook is good, with every indication of a good year for the industry. The Clearwater plant at Lewiston and other timber plants are being developed.

All this development will have a tendency to concentrate the Idaho timber industry at Lewiston, the development will provide an outlet market for the state timber holdings in the Clearwater.

I had not gone a hundred yards before I deeply resented my narrow escape. I may have said something in this chronicle that I am too imaginative to be a really courageous man, but that I have an overpowering fear of seeming afraid. How often I stopped, with the intention of turning and yet every time my pride conquered my fear, and sent me on again until my object should be attained.

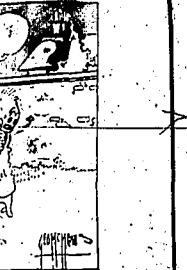
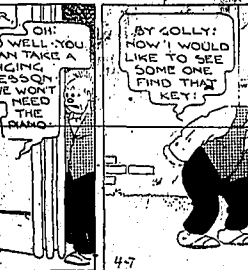

GOOD VOTE BUT LITTLE WORK TODAY

Large Registration in Files of Books Which Run Back for Many Years; Opinions Differ According to Viewpoints and Degree of Optimism Regarding Final Returns.

At 3 o'clock this afternoon, the total number of votes cast at the late voting booths was approximately 600 and the total number cast at the city hall about 400. A steady stream was pouring into the voting places but there was very little activity among voters. The polls close at 7 o'clock.

Considering the total number of nominal voters in this city, the vote of about 700 cast up to 7 o'clock this afternoon seems small. Registration here, the law of the States and Oregon, never expires, and the names that are on the list stay there unless the voter changes and goes in and re-registers. The result is that there are approximately 10,000 names on the list who are known to have moved from the city.

Up to one o'clock while a good stream of voters were rolling into the booths steadily, there had been no work done around the late voting booths. The city hall was only a little at the city hall precinct.

At 9 o'clock this afternoon, the city fathers had a brief session. The agenda was to approve of the Blue Lakes District and Receive Monthly Report of Police Chief.

The last complete meeting of the Twin Falls city council before the election was allowed, the specifications for the proposed improvement district on Blue Lakes boulevard were approved and the city attorney, A. J. Myers, was instructed to draft an intentional ordinance.

The monthly report of the chief of police, P. O. Herffman, was presented for violation of general ordinances, three for traffic violations, 15 for drunkenness and five for state misdemeanors. There were 72 meals furnished prisoners.

The council will clean up Monday night and allow bills, after which they will count the ballots officially and let the new officers be sworn in. Two years ago induction was deferred owing to the necessity of a unanimous runoff election for commissioners, as there were five in the race, none having a clear majority.
