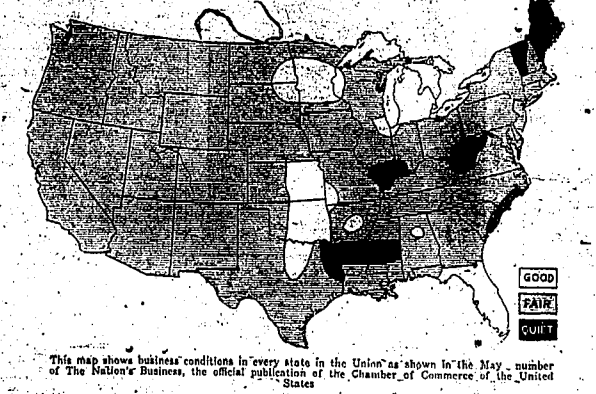

## TWIN FALLS COUNTY MAN GETS NEW TRIAL

**Harry J. Dunlap Convicted in District Court Here of Manslaughter Is Granted New Trial by Idaho Supreme Court's Action**

That where the securing of firearms is introduced as an incriminating circumstance in a criminal prosecution by the state, the defense has a right to introduce the testimony of the person who is the defendant to show the conversation took place in connection with the borrowing of the weapon, in order to prove innocent intent, is the substance of one of the opinions of the state against H. J. Dunlap, at Salt Lake City, on April 22, 1925, Russell, brother-in-law, as shown by the text of the opinion rendered today by Justice C. C. Chapman, who represented the defendant. Other points illustrating the principle of the law to which Dunlap appealed are also shown.

Dunlap borrowed a shot gun from his neighbor, Bell. He was allowed to explain that he borrowed the gun to shoot magpies, but he was not permitted to testify regarding a conversation to that effect in connection with the borrowing of the gun.

**DOISE.** Idaho—Harry J. Dunlap of Twin Falls county, was granted a new trial by the Idaho supreme court decision handed down Saturday in which the conviction of murder in the second degree was reversed.

Dunlap was convicted of murdering C. A. Russell, his neighbor, on the morning of April 30, 1922, following an altercation over damaged property "passed" from Dunlap's house and demanded the cows which Dunlap was holding. Words followed and Russell, reaching for an axe, threatened the lives of Dunlap and his wife. Dunlap was standing near a granary in which there was a shotgun. It reached for it and pointed it at Russell. It went off, the lead striking him in the back of the head and he died the next day.

The supreme court held that the lower court erred in the giving of several instructions to the jury. Two of these involved the law of self defense in one of these instructions used the words in referring to Dunlap's actions, under Russell's threat: "A man of ordinary firmness and courage."

The lower court also instructed the jury that: "Malice implies not only anger, hatred and revenge, but every unlawful and unjustifiable motive." In ruling against this instruction the court says: "The giving of an instruction containing the above language has been disapproved by this court as it tends to lead the jury to believe that they would be justified in finding that an act was done with malice."

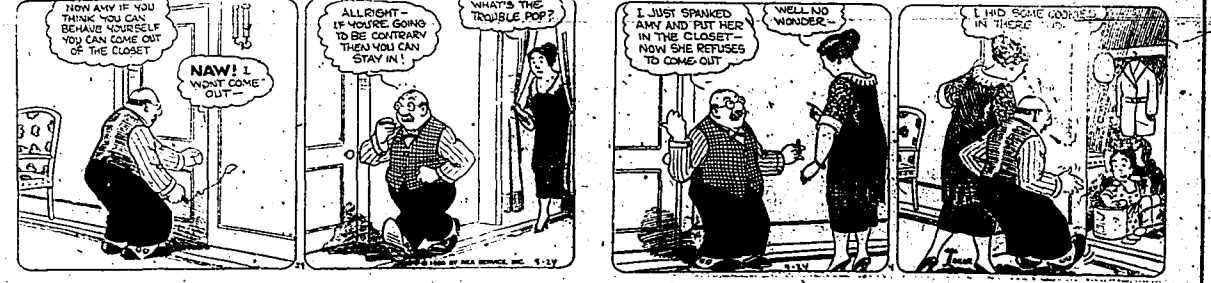

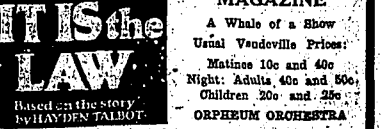
